Department: Transport

EXECUTIVE SUMMARY

- 1 There has been a request to use an area of Vogel Street for the purpose of film-making.
- This report recommends a Council resolution to temporarily close the road concerned using the provisions of the Local Government Act 1974, to enable the film-making as requested to proceed.

RECOMMENDATIONS

That the Council:

- a) **Decides** pursuant to Section 319, Section 342, and Schedule 10 of the Local Government Act 1974, to close the portions of Vogel Street as detailed below;
 - i) Friday 19 March from 3.45pm to 2.30am the following day, from 22 Vogel St to Jetty St.
 - ii) Saturday 20 March, from 3.45pm to 2.30am the following day, from 22 Vogel St to 115 Vogel St.
 - iii) Sunday 21 March, from 3.45pm to 2.30am the following day, from 22 Vogel St to 115 Vogel St.
 - iv) Tuesday 23 March, from 4pm to 2.45am the following day, from 22 Vogel St to Jetty St.
 - v) Wednesday 24 March, from 7:30pm to 6.15am the following day, from Queens Garden to Jetty St.

BACKGROUND

- There has been a request from a film productions company to use a portion of Vogel Street for the purpose of film-making.
- 4 A plan showing the area that the film company is wanting to use is attached.



DISCUSSION

- The area proposed to be used for film-making is legal road, and can therefore be temporarily stopped, if the statutory temporary road stopping procedures are followed.
- There is a clearly defined process for closing roads in the Local Government Act 1974 ("LGA 1974"). Where the proposed temporary road stopping relates to film-making the decision to close a road cannot be delegated to Council staff; a resolution of Council is required.
- Section 319 of the LGA 1974 gives Council the power to stop or close any road or part of a road in the manner and upon the conditions set out in section 342 and Schedule 10 of the LGA 1974.
- 8 Under clause 11(e) of Schedule 10 of the LGA 1974, Council can temporarily close a road for the purpose of film-making if certain conditions are met, as detailed in this report. A copy of Schedule 10 of the LGA 1974 is attached as Attachment C.
- There is a requirement for Council to assess effects on traffic. With the appropriate traffic management plan, traffic will not be impeded unreasonably as there is an adjacent detour available very near the closed portion of road. The temporary traffic management plan process will ensure that other issues are addressed.
- 10 Through the temporary traffic management plan process:
 - a) The film-makers are required to consult affected persons in order that access provisions will be managed.
 - b) A condition will be included specifying that the cost of repairing any damage caused by the film-makers will be met by the film-makers.
- 11 Council is required to give public notice of a proposed temporary road closure. This will be done as part of advertising an extraordinary Council meeting. Council is also required to give public notice of its decision. This notice will be given after Council's extraordinary Council meeting.
- The NZTA and the New Zealand Police have been consulted as required, and neither have any objection to the proposed temporary road closure.
- The road cannot be closed for more than an aggregate of 31 days in any one year. The Transport Team has advised that there have been few road closures around the Film-Making Area and, accordingly, the 31-day limit will not be exceeded through the approval of the proposed temporary road closure.
- 14 Council will need to be satisfied that the temporary road closure would be unlikely to impede traffic unreasonably. Given the limited duration of the temporary road closure, traffic is unlikely to be unreasonably affected.

OPTIONS

Option One – Recommended Option

- 15 That the Council closes the portions of Vogel Street as detailed below;
 - a) Friday 19 March from 3.45pm to 2.30am the following day, from 22 Vogel St to Jetty St.



- b) Saturday 20 March, from 3.45pm to 2.30am the following day, from 22 Vogel St to 115 Vogel St.
- c) Sunday 21 March, from 3.45pm to 2.30am the following day, from 22 Vogel St to 115 Vogel St.
- d) Tuesday 23 March, from 4pm to 2.45am the following day, from 22 Vogel St to Jetty St.
- e) Wednesday 24 March, from 7:30pm to 6.15am the following day, from Queens Garden to Jetty St.

Advantages

- The road will be able to be closed and the film making will be able to proceed.
- This will enable the benefits associated with film-making in Dunedin.

Disadvantages

There will be temporary loss of access through the closed area. However, there are
detours available nearby, and safety can be assured through the use of temporary traffic
management.

Option Two - Status Quo

That the Council decides not to close the portion of Vogel Street in question for the purpose of film making.

Advantages

• There would be no detour required for travelling public, and the road would be able to be used as normal.

Disadvantages

- The closure of the road for film-making would not be allowed.
- The benefits of film-making would be lost.

NEXT STEPS

17 Should the resolution be made to close the road, Council staff will proceed to accept the temporary traffic management plan, notify the public, the NZTA and Police.

Stopping of roads

- The council shall prepare a plan of the road proposed to be stopped, together with an explanation as to why the road is to be stopped and the purpose or purposes to which the stopped road will be put, and a survey made and a plan prepared of any new road proposed to be made in lieu thereof, showing the lands through which it is proposed to pass, and the owners and occupiers of those lands so far as known, and shall lodge the plan in the office of the Chief Surveyor of the land district in which the road is situated. The plan shall separately show any area of esplanade reserve which will become vested in the council under section 345(3).

- On receipt of the Chief Surveyor's notice of approval and plan number the council shall open the plan for public inspection at the office of the council, and the council shall at least twice, at intervals of not less than 7 days, give public notice of the proposals and of the place where the plan may be inspected, and shall in the notice call upon persons objecting to the proposals to lodge their objections in writing at the office of the council on or before a date to be specified in the notice, being not earlier than 40 days after the date of the first publication thereof. The council shall also forthwith after that first publication serve a notice in the same form on the occupiers of all land adjoining the road proposed to be stopped or any new road proposed to be made in lieu thereof, and, in the case of any such land of which the occupier is not also the owner, on the owner of the land also, so far as they can be ascertained.
- A notice of the proposed stoppage shall, during the period between the first publication of the notice and the expiration of the last day for lodging objections as aforesaid, be kept fixed in a conspicuous place at each end of the road proposed to be stopped:
 - provided that the council shall not be deemed to have failed to comply with the provisions of this clause in any case where any such notice is removed without the authority of the council, but in any such case the council shall, as soon as conveniently may be after being informed of the unauthorised removal of the notice, cause a new notice complying with the provisions of this clause to be affixed in place of the notice so removed and to be kept so affixed for the period aforesaid.
- If no objections are received within the time limited as aforesaid, the council may by public notice declare that the road is stopped; and the road shall, subject to the council's compliance with clause 9, thereafter cease to be a road,
- If objections are received as aforesaid, the council shall, after the expiration of the period within which an objection must be lodged, unless it decides to allow the objections, send the objections together with the plans aforesaid, and a full description of the proposed alterations to the Environment Court.

Temporary prohibition of traffic

- 11 The council may, subject to such conditions as it thinks fit (including the imposition of a reasonable bond), and after consultation with the Police and the New Zealand Transport Agency, close any road or part of a road to all traffic or any specified type of traffic (including pedestrian traffic)—
 - (a) while the road, or any drain, water race, pipe, or apparatus under, upon, or over the road is being constructed or repaired; or
 - (b) where, in order to resolve problems associated with traffic operations on a road network, experimental diversions
 of traffic are required; or
 - (c) during a period when public disorder exists or is anticipated; or
 - (d) when for any reason it is considered desirable that traffic should be temporarily diverted to other roads; or
 - (e) for a period or periods not exceeding in the aggregate 31 days in any year for any exhibition, fair, show, market, concert, film-making, race or other sporting event, or public function:

provided that no road may be closed for any purpose specified in paragraph (e) if that closure would, in the opinion of the council, be likely to impede traffic unreasonably.

- Where a road is closed under clause 13, an appropriate notice shall be posted at every entry to the road affected, and shall also be published in a newspaper circulating in the district.
- A copy of every resolution made under clause 13 shall, within 1 week after the making thereof, be sent to the Minister of Transport, who may at any time, by notice to the council, disallow the resolution, in whole or in part, and thereupon the resolution, to the extent that it has been disallowed, shall be deemed to have been revoked.
- No person shall-
 - (a) use a vehicle, or permit a vehicle to be used, on any road which is for the time being closed for such vehicles pursuant to clause 11: or
 - (aa) without the consent of the council or the promoter of any activity permitted by the council, enter or attempt to enter, or be present, on any road or part of a road that is for the time being closed to pedestrian traffic pursuant to clause 11; or
 - use a motor vehicle, or permit a motor vehicle to be used, on any road where its use has for the time being been prohibited by a resolution under clause 13.
