EXECUTIVE SUMMARY

- 1 This is a report for an application by the University of Otago for the renewal of an on-licence for the premises situated at 640 Cumberland Street, Dunedin, and known as the "Staff Club", "U Bar", "University Union", "St David Café" and "Gazebo Lounge". The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) apply to this application.
- 2 The applicant does not seek any changes to the licence. The trading hours are Monday to Sunday, 12.00 midday to 1.00 am the following day except for the "U Bar" which has a closing time of 3.00 am the following day. The "U Bar" is designated a supervised area while the rest of the premises is undesignated. The inspector considers that the sale and supply of alcohol under these conditions are consistent with the purpose of the Act and meets the criteria at section 131.
- 3 One public objection has been duly made. The reporting agencies have not opposed this application and the Licensing Inspector similarly does not oppose this application.

APPLICANT AND APPLICATION

Applicant

- 4 The applicant is the University of Otago which is an 'instrument of the Crown' and therefore can hold an alcohol licence.
- 5 The licence covers five distinct areas on the campus. The "Staff Club" is one of the original structures on the campus and caters mainly for staff. The "St David Café" is in the foyer of the St David Lecture complex on the northern side of the campus. The "University Union" is the main student area which has various food outlets for patrons. The "Gazebo Lounge" is on the first floor of the Union complex while the "U Bar" is in a basement area of this same complex. The "U Bar" is a late-night venue which also caters for live entertainment.
- 6 The University was first granted a licence in 1999 by the Liquor Licensing Authority. A new licence was issued in 2001 which covered both the Union Building and Staff Club. The current licence was issued in 2015 to cover the five areas listed above. This is the third renewal of this licence.
- 7 During the times the premises has been licensed it has been operated properly by the applicant.

PUBLIC NOTICE

8 Public notice of the application attracted one objection. The reporting agencies have not opposed the renewal of the licence.

Objections

- 9 Objection 1: Dated 16 December 2022 made by 'Students for Sensible Drug Policy Dunedin'. This group is affiliated with the Otago University Students' Association and facilitates representation of Dunedin's student population.
- 10 The grounds for this opposition are:
 - a) S.105(1)(a) Object of the Act: questions relating to the legal entity of the licence holder and who is responsible for ensuring the sale, supply and consumption of alcohol is undertaken safely and responsibly.
 - b) S.105(1)(a), (e) and (j) Object of the Act, Designated areas and whether there are sufficient staff, systems and processes to cover the areas covered by the licence. The objector does not believe the application covers this detail adequately for it to be assessed. They also question whether the areas can be included on the one licence.
 - c) Other matters include the lack of information regarding the 'high-risk' "U Bar" and in particular the specific Host Responsibility and Alcohol Management Policies for this area.
- 11 The objector would also like a condition included on the licence with relating to the "U Bar" regarding 'appropriate drug overdose and polysubstance/mixed substances overdose recognition and response training for all staff. The licensee should also 'create, hold and maintain up-to-date training procedures and manuals for training.

12 They would also like to see posters and pamphlets in the premises as well as the premises first aid supplies including Naloxone in the form of Nyxoid[®] and ensure all staff, including security, are trained in its use.

CONCLUSION

- 13 Th Committee will need to determine if the objector has an interest greater than the public generally and assess the matters raised against the matters to be considered in s.105(1) of the Act.
- 14 A lot of the matters raised have been determined previously at both the granting of the licence and subsequent renewals.
- 15 The reporting agencies are supportive of the licence renewal.

The University was established by The University of Otago Ordinance of the Provincial Council in 1869, the University of Otago Amendment Act 1961 and The Education Act 1989.

University of Otago, as the applicant is a body corporate who has held this licence since 2015. Under section 28 of the Act, a body corporate can hold an alcohol licence.

From The University of Otago's website:

The University Union is a commercial University owned operation comprising of 25 business units in 19 locations around campus.

The University Union is part of the University's Campus and Collegiate Life Services Division, with the General Manager reporting directly to the Director of Campus and Collegiate Life Services.

The Union's business units are divided into three major areas of operation, College Catering, Retail and Food & Beverage....

The Food and Beverage operation consists of the following food outlets:

It is my understanding that The University of Otago Union is a division of the University and is responsible for the running of the areas of campus covered by this licence: University of Otago Union, University of Otago Staff Club, Gazebo lounge, St David Café and U-Bar. The University of Otago Union is not the same entity as University Union Limited.

When this licence was last renewed on 29 May 2020, a caterer's endorsement was granted to 'The University of Otago Union'.

St David's lecture theatre is licenced in the café area and this (footprint) area includes the St David's lecture theatre for occasions when an external speaker/function is being held in the theatre, usually in the evenings (not supplying alcohol for day-to-day University lectures).

The University Union houses what was historically the food court on campus, which had a licensed outlet within it called the Union Grill. Between November 2022 – February 2023, this area is undergoing significant renovations with a new central bar being constructed within this area, which will also offer a substantive menu. In essence, several outlets are merging into one central outlet to cater for the whole seating area space.

The intention is for students to use this area as a common area, and the bar to operate from late afternoons into early evening. Night-time trade for this location is to be limited to functions such as organised quiz nights (or similar) from University groups, with the potential in the future to hire this space out for commercial functions potentially.

U-Bar opens early evenings Wednesday through to Sunday and can often trade up until 3am.



1. Legal basis of Objection

- 1. This Objection to renewal is made under S.128 of the Sale and Supply of Alcohol Act 2012.
- 2. S.128(1) states that 'a person may object to a renewal of a licence if he or she has a greater interest in the application than the public generally.' On that basis:
 - (1) Students for Sensible Drug Policy Dunedin (SSDP Dunedin) is affiliated with the Otago University Student Association (OUSA).
 - (2) The objective of SSDP Dunedin is 'to reduce drug related harm and advocate for drug policy change in Dunedin and Aotearoa.'
 - (3) In accordance with the Ministry of Health and the New Zealand Drug Foundation, SSDP Dunedin holds that Alcohol is the most commonly used drug in New Zealand.¹
 - (4) The core membership and primary focus of SSDP Dunedin's work is the University of Otago and Otago Polytechnic student population.
 - (5) SSDP Dunedin is an organisation that facilitates representation of Dunedin's student population, and greater participation in the democratic processes involved with the regulation and licensing under the Sale and Supply of Alcohol Act 2012.
 - (6) The section 1.3 of the Dunedin Local Alcohol Policy (LAP) specifically identifies and acknowledges that the youth/student population is 'particularly vulnerable to hazardous drinking and alcohol-related harm.'²
 - (7) The Applicant is the University of Otago, which is the largest education provider to the vulnerable youth/student population identified by the Dunedin LAP, and referenced above in in 1.2.(6) of this objection.
 - (8) We thereby hold that objections made by SSDP Dunedin are valid under S.128(1) of the Sale and Supply of Alcohol Act 2012.
 - (9) A comparable precedent for SSDP Dunedin's validity to object is set regarding the status of Waitemata Local Board in sections 76 to 81 of *Wilson v Durga Sai Holdings Limited* [2017] NZARLA 42 (9 February 2017).

- 3. S.128(3) states that no objection may be made except matters stated in S.131.
- S.131(1)(a) defines the permitted matters of objection as those of paragraphs (a) to (g), (j) and (k) of S.105(1), with these matters being:
 - (a) the object of this Act:
 - (b) the suitability of the applicant:
 - (c) any relevant local alcohol policy:
 - (d) the days on which and the hours during which the applicant proposes to sell alcohol:
 - (e) the design and layout of any proposed premises:
 - (f) whether the applicant is engaged in, or proposes on the premises to engage in, the sale of goods other than alcohol, lowalcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods:
 - (g) whether the applicant is engaged in, or proposes on the premises to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services:
 - ...
 - (j) whether the applicant has appropriate systems, staff, and training to comply with the law:
 - (k) any matters dealt with in any report from the Police, an inspector, or a Medical Officer of Health made under S.103.
- 5. There are no matters arising from S.105(2) given that Students for Sensible Drug Policy Dunedin are not a holder of any other license.





2. SSDP Dunedin's general position on licensed premises in Dunedin

Regarding alcohol generally

- 1. SSDP Dunedin supports the Dunedin Local Alcohol Policy (LAP)
- 2. We would bring attention to three critical points in the LAP:
 - (1) 'Student accommodation is clustered in the North Dunedin area which immediately surrounds the tertiary institutions, with student parties in the area acting as a magnet for non-students. This combination makes the city's young people particularly vulnerable to hazardous drinking and alcohol-related harm.' Section 1.3, fourth paragraph.
 - 'Analysis of police data indicates that: ... about 76% of alcohol (2) purchased is consumed in off-licence settings for drinking in situations where there is little or no control.' Section 1.3, last paragraph.
 - 'While it is a characteristic of on-licensed premises that they provide a (3) controlled environment in which people drink alcohol, some premises have more potential to cause harm than others." Section 5.1, third paragraph.
- 3. SSDP Dunedin fully agrees that responsible and well-managed on-licensed premises provide a controlled environment for the consumption of alcohol, and that these premises are essential to the safe and responsible consumption of alcohol, and the minimisation of alcohol related harm in Dunedin.
- 4. We further maintain that uncontrolled drinking situations primarily located in the student accommodation areas of North and Central Dunedin fundamentally increases the risk to, and vulnerability of, the student population to hazardous drinking and alcohol-related harm.
- 5. SSDP Dunedin holds that the recent closing of most on-licensed premises which primarily catered to the student population has caused an increase in uncontrolled drinking situations located in North and Central Dunedin, exacerbating and increasing instances of hazardous drinking and alcohol-related harm.

- 6. Hence, SSDP Dunedin believes that effective management of alcohol in Dunedin requires a consistent balance of the following factors:
 - That licensing decisions and regulatory interventions are firm and (1)thorough enough to achieve the object of the Sale and Supply of Alcohol Act 2012, with a focus on applicant suitability, best business practices, and proven-effective harm reduction approaches; and
 - (2) That applicants with venues that are proven to be responsible and wellmanaged are valued and supported to ensure their businesses are sustainable, resilient, and profitable. This is to ensure the ongoing operation of on-licensed premises that provide a supervised and controlled environment for the consumption of alcohol as an alternative to higher risk situations of drinking in North and Central Dunedin where there is little or no control; and
 - (3) That investment in proven and cost-effective interventions focused harm-reduction and grass-roots change in Dunedin's student/youth drinking culture are continued and expanded to ensure a steady progression to a more sociable and harm-aware student culture and environment.

Regarding alcohol and other substances

- 7. SSDP Dunedin believes that licensees of on-licensed premises have traditionally sought to side-step issues of substance use and intoxication on their premises.
- 8. S.12.(1) of the Misuse of Drugs Act 1975 makes it illegal to knowingly permit your premises to be used to supply, consume, procure or administer a 'controlled drug'.
- 9. Anecdotal arguments common within the Hospitality industry tend to make claims that an on-licensed premise which engaged with or promoted materials including posters related to 'controlled drug' harm-reduction was 'knowingly' acknowledging their premises was being used for the consumption of 'controlled drugs,' and thereby was in breach of the Misuse of Drugs Act 1975.
- 10. This is despite all on-licensed premises have an explicit responsibility to manage intoxication caused by 'other drugs,' derived from S.5.(1) of the Sale and Supply of Alcohol Act 2012 which defines 'intoxicated' as:

'intoxicated means observably affected by alcohol, other drugs, or other substances (or a combination of 2 or all of those things) to such a degree that 2 or more of the following are evident:

- appearance is affected: (a)
- (b) behaviour is impaired:
- co-ordination is impaired: (c)
- (d) speech is impaired

- 11. SSDP Dunedin agrees with the New Zealand Drug Foundation that the best way for on-licensed premises to manage intoxication as defined by, and to meet the object of, the Sale and Supply of Alcohol Act 2012, is for the management of on-licensed premises to engage with these matters in a direct and thorough manner alongside key relationships and networks.³
- 12. Furthermore, we believe that the following factors make it critical that licensing, regulatory and enforcement agencies actively promote, and even require, local on-licensed premises to develop and implement business practices and managerial processes, and correspondingly actively train staff in effective drug/polysubstance/mixed substance intoxication recognition, and overdose recognition and response training:
 - (1) The unique characteristics and demographics of the Dunedin population, including the student population; and
 - (2) The increasing risk of the international opioid epidemic reaching New Zealand, upon which the Dunedin population would be at critical risk of opioid overdose due to exacerbating factors in both alcohol and substance consumption behaviours present in the vulnerable Dunedin student/youth populations. Opioid overdose, particularly when combined with high alcohol consumption, leads to respiratory depression, and the lack of oxygen can cause brain damage within 5 minutes, followed shortly after by death.

3. Objection Framework

- 1. S.128 gives no other directions as to prescribed form or manner beyond that objections must be in writing.
- 2. For the ease of the District Licensing Committee in filing this objection, SSDP Dunedin has categorised the matter and grounds of objection into three categories:
 - Outright Objection for matters based on appropriate grounds where SSDP Dunedin objects to a license being issued or renewed outright; or
 - (2) Partial Objection for matters based on appropriate grounds where SSDP Dunedin objects to a license being issued or renewed without the District Licensing Committee undertaking further scrutiny of specified matters, which may require the applicant submitting further documentation for the District Licensing Committee's assessment or review; or
 - (3) Objection dependent on further or discretionary conditions for matters where SSDP Dunedin objects to the license being issued or renewed without the following conditions being imposed on said license by the District Licensing Committee.

Regarding the conditions of licenses on issue or renewal

3. S.132 of the Sale and Supply of Alcohol Act 2012 states:

'132 Imposition of conditions on renewal

- (1) When renewing a licence of any kind, the licensing authority or the licensing committee concerned—
- (a) may impose any conditions subject to which it may issue a licence of that kind;'
- 4. S.117 of the Sale and Supply of Alcohol Act 2012 states:

'117 Other discretionary conditions

- (1) The licensing authority or licensing committee concerned may issue any licence subject to any reasonable conditions not inconsistent with this Act.
- (2) The generality of subsection (1) is not limited or affected by any other provision of this Act.'



- 5. From these sections, a licensing authority or licensing committee has a wider power to *'issue any licence subject to any reasonable conditions not inconsistent with this Act,'* and may do so upon the renewal of a license.
- 6. Furthermore, the precedent set by *My Noodle Ltd v Queenstown Lakes District Council* [2008] NZAR 481 (HC)⁴ holds that:

'no licence holder has a legitimate expectation that a licence will automatically be renewed on identical terms, and the fact that the licensee has managed the premises properly or that there were no specific problems relating to the licensee's particular operation is not decisive.'

- 7. Thereby, in SSDP Dunedin making an objection dependent on further or discretionary conditions being imposed on the license, we would argue that the District Licensing Committee should assess such an objection based on whether:
 - (1) the matter of objection is permitted under S.131(1)(a) of the Sale and Supply of Alcohol Act 2012; and if so,
 - (2) are the condition(s) to be imposed on the license as remedy to the matter of objection connected and relevant to said matter of objection; and if so,
 - (3) are the conditions requested 'reasonable conditions not inconsistent with the Sale and Supply of Alcohol Act 2012.

4. Outright Objection

SSDP Dunedin objects to this license being issued or renewed by the District Licensing Committee at Dunedin on the following matters and grounds:

1. Identification of which legal entity is the Applicant and License holder

This objection is made on the grounds of S.131(1)(a) permitting S.105.(1)(a) as a matter of objection.

- The prescribed application form for renewal of an on-license, and the certificate of the existing on-license including caterer's endorsement, specifies the 'University of Otago' as the Licensee.
- (2) The 'University of Otago' is a legislatively established body corporate governed by the Education and Training Act 2020 and considered a Tertiary Education Institute (TEI) under the Crown Entities Act 2004.
- (3) The details of premises specified on page 4 of the prescribed application form, being listed as University of Otago Union, University of Otago Staff Club, Gazebo Lounge, St David Cafe and U-Bar, are publicly stated to be owned or operated by University Union Limited (Company# 1201585), a registered limited liability company. See attachment A
- (4) University Union Limited is 'a commercial University owned operation comprising of 25 business units in 19 locations around campus.'
- (5) University Union Limited is owned by:
 - (a) the Otago University Students Association, an Incorporated Society (Society# 226783), which holds half of the total shares.
 - (b) University of Otago Holdings Limited, a Limited Liability Company (Company# 245910), which holds half of the total shares.
- (6) University of Otago Holdings Limited is fully owned by the body corporate that is the University of Otago.
- (7) The contact person specified on page 3 of the prescribed application form is Adrian Lowrey, Hospitality Services Manager, and it would seem likely that he is an employee of University Union Limited. See attachment B



(8)

S.(4)(1)(a) of the Sale and Supply of Alcohol Act 2012 states the first

'the sale, supply, and consumption of alcohol should be undertaken safely and **responsibly**.'

element of the object of the Act is:

- (9) Clear and unambiguous identification of the holder of a License issued under the Act is critical to ensuring which person or entity is responsible under the act, and who is accountable for any offences or infringements under the Act.
- (10) This issue of identity goes beyond the application and enforcement of the Sale and Supply of Alcohol Act 2012, as good management of a license premise necessarily requires engagement with members of the public, key stakeholders, and wider community, all of whom benefit from a clear understanding of exactly who is responsible for any issues that may arise from the operation of the on-license and its premises.
- (11) Both the University of Otago and University Union Limited are eligible entities under S.28(b) and (ba) of the Act. The fundamental matter at hand is identifying which legal entity is the Applicant / Licensee.
- (12) Identification of the legal entity is also necessary to establish the basis of authority for an employee or officer of said entity to make an application for a license.
- (13) As previously mentioned, it seems that Mr Lowrey is an employee of University Union Limited, a sub-subsidiary/sub-associate company that is not ultimately owned outright by the body corporate of the University of Otago.
- (14) It is reasonable from the information on hand to assume that Mr Lowrey has the authority to apply or renew a license on behalf of University Union Limited, and thereby investing in University Limited the associated responsibilities and obligations of holding a License under the Act.
- (15) It is not however, based on the information at hand, fair to assume that Mr Lowrey has the authority to apply or renew a license on behalf of the body corporate of the University of Otago, as he is likely not a direct employee or officer of that entity.
- (16) There is likely considerable unintended operational and reputational risk and consequences that could arise for the body Corporate of the University of Otago if it is unwittingly considered to be, and held as, a Licensee under the Act.

- (17) Furthermore, clear identification of the legal entity has implications for the caterer's endorsement under S.16 and S.38 of the Act, included in the existing license.
- (18) S.16 of the of the Sale and Supply of Alcohol Act 2012, and S.38 reiterates:

In addition to doing the things stated in section 14, the holder of an onlicence endorsed under section 38 can deliver alcohol from the premises the licence is issued for and sell it on any other premises for consumption there by people attending a reception, function, or other social gathering promoted by a person or association of people other than the holder.

- (19) If the legal entity that holds the current on-license with a caterer's endorsement is the body corporate of the University of Otago, then it is reasonable to argue that any sale or supply of alcohol undertaken for any of its constituent divisions⁵ is a technical breach(s) of the Act as it has sold or supplied said alcohol promoted by itself as the holder of an endorsed on-license.
- (20) Whereas if the legal entity that holds the current on-license with a caterer's endorsement is University Union Limited, or even specifically the Food and Beverage Operational Division of University Union Limited (as separate to the College Catering and Retail Operational Divisions), then it is reasonable to argue that any sale or supply of alcohol undertaken by the holder of the on-license with caterer's endorsement for any constituent division of the body corporate of the University of Otago was done so by an entity other than the holder of said license, and thereby no technical breach(s) of the Act have occurred.
- (21) Finally, if University Union Limited, or the Food and Beverage Operational Division of said company is the effective legal entity that holds the License issued under the Act, then the information regarding the principal business of the Applicant on page 3 of the prescribed form needs to be changed from 'Education and Research,' as by its own description 'The University Union is a commercial University owned operation comprising of 25 business units in 19 locations around campus.'





- (22) Thereby, SSDP Dunedin objects outright to this license being issued or renewed, until such a time that the identity of the legal entity that is Applicant and holder of this license is clearly and unambiguously identified.
- (23) To ensure transparency and accountability as elements of the critical object of responsibility under the Act, SSDP Dunedin further objects outright to this license being issued or renewed, until such a time that:
 - (a) The employee and/or officer with the highest authority within that legal entity that is Applicant and holder of this license that is ultimately responsible for the operations and good management of the on-license overall is clearly identified; and,
 - (b) That the contact details of the person specified above in 23.(a), or a specified and named delegated point of contact, are provided in order for members of the public, key stakeholders, and wider community to be able to communicate regarding any matters arising from the operation of the License with said person.

4. Outright Objection: continued...

 Insufficient information provided in the renewal application, or generally accessible, regarding the boundaries, designations, and management of the overall Premises and six sub-premises.

This objection is made on the grounds of S.131(1)(a) permitting S.105.(1)(a), (e) and (j) as matters of objection.

- The Applicant provided no information or plans describing or illustrating the extent, lay-out or boundaries of the overall premises, or the six subpremises, on the prescribed application form for the renewal of this License.
- (2) The current on-license certificate references 'plans received by the Dunedin District Licensing Committee on 10 December 2015.'
- (3) SSDP Dunedin has attempted to obtain a copy of the application to the Dunedin District Licensing Committee containing these plans for the licence issued on the 26th day of February 2016 but had been unsuccessful in doing so at the time of filing this objection.
- (4) The only identifies the names of six sub-premises on page 4 of the prescribed application form, being listed as University of Otago Union, University of Otago Staff Club, Gazebo Lounge, St David Cafe and U-Bar, are publicly stated to be owned or operated by University Union Limited (Company# 1201585).
- (5) Of these sub-premises, it is publicly stated that University Union Limited 'operates' the University of Otago Staff Club and U-Bar, which may indicate that these businesses may have different ownership. See attachment A
- (6) Of these sub-premises, University of Otago Union, Gazebo Lounge and U-Bar are situated at the addresses associated DCC property numbers of:

(Legal descriptions were not used here due to their complexity)

- (a) 660 Cumberland Street Dunedin, DCC# 5069022
- (b) 640 Cumberland Street Dunedin, DCC# 5104552
- (c) 65 Albany Street Dunedin, DCC# 5010114
- (7) These sub-premises are 144.3m away from the sub-premise of the University of Otago Staff Club, and 326.4m away from the sub premise of the St David Café.



- (8) The University of Otago Staff Club has the given address of 90 Union Place West, North Dunedin,⁶ otherwise situated at the address associated with DCC property number:
 - (a) 362 Leith Street Dunedin, DCC# 5065776
- (9) The St David Café has the given address of 86 Saint David Street, Dunedin North, otherwise situated at the address associated with the DCC property number:
 - (a) 700 Cumberland Street Dunedin, DCC# 5065777
- (10) The distance between the University of Otago Staff Club and the St David Café is 151.6m
- (11) S.(5)(1) of the Sale and Supply of Alcohol Act 2012 defines:

'premises—

- (a) includes a conveyance; and
- (b) includes part of any premises; and
- (c) in relation to a licence, means the premises it was issued for'
- (12) S.118 of the Sale and Supply of Alcohol Act 2012 states:

'Different conditions may apply to different parts of premises Any condition subject to which a licence is issued may do either or both of the following:

- (a) *apply differently to different parts of the premises:*
- (b) apply differently to the same part of the premises at different times, on different days, or both.'
- (13) This definition of premises under the Act is seemingly self-referential, but it could be fairly argued referral to S.284(2) of the Sale of Liquor Act 1962 and the precedent of *Kingsgate Hotels Ltd v Inspector of Licensed Premises* — [1984] 1 NZLR 246 could provide guidance.
- (14) Kingsgate considered 'whether on an application for redefinition of licensed premises under s 284(2) of the Sale of Liquor Act 1962 a Licensing Committee has jurisdiction to include in the redefined licensed premises an area of land that is not contiguous with the remainder of the licensed premises (eg land that is separated by a street).'

- (15) In Kingsgate, the Court of Appeal found that 'when a Licensing Committee is redefining licensed premises under s 284(2) of the Sale of Liquor Act 1962 it has jurisdiction under that subsection to include in the redefined licensed premises land that is not contiguous with the licensed premises. The criterion for the inclusion of land in the definition of licensed premises is the purpose for which it is to be used. There is nothing in s 284(2) limiting the nature or locality of the land which may be added by way of redefinition (see p 247 line 24).
- (16) SSDP Dunedin accepts that under the S5.(1) interpretation of 'premises' the Dunedin Licensing Committee's non-contiguous definition of the overall premise in terms of the six sub-premises is valid.
- (17) Yet the issue remains that the Applicant in the prescribed application form describing the extent, lay-out or boundaries of the overall premises, or the six sub-premises, and thereby there is no clear understanding of where, or how far, the spaces or areas of the Applicant's entitlements and obligations under the Act extend, nor for members of the public, key stakeholders, and wider community to be able to know where they may unwittingly commit or be liable for an offence or infringement under the Act.
- (18) On page 4 of the prescribed application form the Applicant states the maximum occupancy of the premises as 950 people, without providing a breakdown for each of the six sub-premises.
- (19) Regarding the intended business use or purpose under the license detailed on page 5 of the prescribed application form, the Applicant has checked Tavern/Bar, Café/Restaurant, Nightclub, and Entertainment without specifying which of the six sub-premises this applies to.
- (20) Regarding the designations that apply to the overall premises and the six sub-premises, on page 5 of the prescribed application form the Applicant has checked all three categories of Undesignated, Supervised, and Restricted without providing further information of which designation applies at which times/days to the six sub-premises, whereas the certificate of the currently issued license specifies that U-Bar is designated as a supervised premise, whereas all other parts of the premises are undesignated.



Item 2

- (21) The Applicant further differentiates the operations of U-Bar from the other 5 sub-premises:
 - (a) On the cover sheet of the prescribed application form the Applicant states that U-Bar's license will continue until 3.00am the following day, as opposed to 1.00am the following day for the other 5 sub-premises.
 - (b) On page 5 of the prescribed application form the Applicant indicates that Alcohol is the principal purpose of the Business of U-Bar.
 - (c) If the risk rating on page 2 of the prescribed application for was calculated for U-Bar alone, it would be rated as High-Risk. If the same were done for the other 5 sub-premises, they would be rated as Medium-Risk.
- (22) SSDP Dunedin holds that the business of U-Bar in terms of its on-license is of a significantly different purpose to the operations of the other 5 sub-premises which share a consistency of purpose.
- (23) The purpose and operations of U-Bar pose a significantly greater risk to the vulnerable youth/student population identified in the Dunedin LAP.
- (24) Upon considering the Act, and historical interpretation and precedents, SSDP believes a fair and reasonable question arises as to whether, when regarding U-Bar, that the object of the Sale and Supply of Alcohol Act would be best achieved by considering U-Bar as a separate on-license conditions appropriate to the nature of its business.
- (25) Otherwise, the lack of any information or describing the extent, lay-out or boundaries of the overall premises provided by the Applicant in the prescribed application form for renewal means there is no way to meaningfully evaluate matters of S.105(1)(j) regarding the Applicant's whether the applicant has appropriate systems, staff, and training to comply with the law.
- (26) Furthermore, the Applicant has provided no written plans or documentation showing how the Applicant intends to maintain effective liquor control of each sub-premises, including how the Applicant:
 - (a) Intends to prevent liquor being brought onto each of the onlicensed sub-premises, whether this would include bag searches for individuals coming onto each on-licensed sub-premise, and who would be conducting any bag searches.



- (b) Intends to prevent liquor being taken off each of these onlicensed sub-premises, including management and supervision of any outdoor areas (for example the outdoor seating area attached to the St David Café) designated as part of any of the on-licensed sub-premises, and how they will prevent alcohol being purchased and then being taken into unlicensed spaces such as adjourning rooms, outdoor areas, or lecture theatres.
- (c) Intends to manage and supervise possible intoxication in individuals in the use of toilets and hygiene facilities that are not directly connected and may be out of direct line-of-sight from the service area for each of the on-licensed sub-premises (for example, the nearest toilets for the St David Café are in a corridor adjacent and out of line-of-sight from the service area of the St David Café.)
- (27) Given the overall state of the application, the information the Applicant has provided for this renewal, and a change in how the Applicant intends to operate its sale and supply of alcohol which has been reported by the Otago Daily Times,⁷ SSDP Dunedin has serious concerns about the lack of detail and specificity provided for the renewal of the existing on-license.
- (28) Such a lack of specificity and detail affords significant flexibility to the Applicant in how they conduct their business, but it does not ensure, and rather may actively work against, achieving the object of the Sale and Supply of Alcohol Act 2012.
- (29) The information reported in the Otago Daily Times regarding the sale of Alcohol is of particular concern to SSDP Dunedin:
 - (a) As stated in Section 2 of this Objection, SSDP Dunedin is generally in support of initiatives that would encourage the vulnerable youth/student population to move away from uncontrolled drinking situations that are primarily located in the student accommodation areas of North and Central Dunedin.
 - (b) SSDP Dunedin firmly supports responsible and well-managed operation of U-Bar in its current hours of operation, as an onlicensed premises, which provides a controlled environment for the consumption of alcohol, which is essential to the safe and responsible consumption of alcohol, and the minimisation of alcohol related harm in Dunedin.

- (c) Yet, the Applicant's intended plans to sell and supply alcohol from midday at locations in the very heart of the Otago University Campus, as reported in the media by the Otago Daily Times, raises a fair question of whether increasing the availability of alcohol from midday at an on-licensed subpremise would actually improve the youth/student drinking culture and minimise alcohol-related harm, or simply increase access to alcohol to the vulnerable youth/student population in a place and at a time where there was no previous access.
- (d) It would be problematic for a slot machine to be set up in the workplace of persons knowingly vulnerable to gambling, and thereby SSDP believes that it would be equally problematic for an Education Provider to increase access to alcohol in a place of study of persons knowingly vulnerable to alcohol harm.
- (e) Yet, it could be argued that actively encouraging students to socialise in supervised and controlled spaces for the consumption of alcohol on campus would reduce uncontrolled drinking situations that are primarily located in the student accommodation areas of North and Central Dunedin that may be occurring at the same time.
- (f) The conversation to be had on this matter cannot be simply categorised by these perspectives alone, which indicates that there is a much wider consultation and conversation on the substantive matter is urgently required before any meaningful agreement can be made on expanding access to alcohol on campus in terms of both time and availability.
- (g) It must be noted that under the currently issued on-license, the Applicant has had the capacity to, but has chosen not to sell and supply alcohol at certain sub-premises until this time. Given the lack of detail and specificity around the extent and management of the sub-premises, it may be fair to argue that said lack of detail and specificity has been to the Applicant's benefit in avoiding potential objections and barriers to their operational plans, as such a change would in most other cases require a variation of the conditions of a license subject to public objection.

- (h) There is a further complicating factor in that the Applicant has access to alternatives to typical measures of enforcement regarding their license, by the means of the Proctors Office. This may have the effect of obscuring events of intoxication and alcohol-related harms associated with the Applicant's onlicensed sub-premises, particularly in the case of U-Bar, that have been recorded as an incident by any of the on-licensed sub-premises within their own records, as well as any events that have been reported to the Proctors Office, the Police, or both.
- (30) Thereby, SSDP Dunedin objects outright to this license being issued or renewed, until such a time that the Applicant reapplies with appropriate information and plans describing or illustrating the extent, lay-out or boundaries of the overall premises, including all six of the sub premises sub-premises, on the prescribed application form for the renewal of this License.
- (31) Furthermore, SSDP Dunedin objects outright to this license being issued or renewed, until such a time that the Applicant reapplies with appropriate written plans, policies, and documentation to how the Applicant intends to maintain good management and effective liquor control of each sub-premises, including the prescribed detailed Host Responsibility Policy and Alcohol Management Policy documents of a suitably high standard for the high-risk sub-premise of U-Bar.
- (32) Furthermore, SSDP Dunedin objects outright to this license being issued or renewed, until such a time that the Applicant provides a detailed report outlining any and all incidents of intoxication and alcohol-related harms, in proximity of, or related to each of the six specified on-licensed sub-premises, accounting for a period of at least the last 18 months,⁸ that have been recorded as an incident by any of the on-licensed subpremises within their own records, as well as any events that have been reported to the Proctors Office, the Police, or both.

- (33) SSDP Dunedin believes that a reapplication process is essential as a matter of natural justice, so that members of the public, key stakeholders, and wider community to genuinely participate and engage with the licensing process, and have their voices legitimately heard, particularly given:
 - (a) The lack of information submitted as part of the prescribed application form for renewal of this license limiting meaningful engagement and understanding of the potential consequences of the renewal process; and,
 - (b) The barriers to accessing the original application, plans and materials provided to the Dunedin District Licensing Committee that may have provided more context to the renewal application; and,
 - (c) The duration of the license, as otherwise without a prohibitive amount of effort and access to significant resources, members of the public, key stakeholders, and wider community will not have another chance to genuinely participate and engage with the licensing process, and have their voices legitimately heard until the next time the time the license is up for renewal.
- (34) SSDP Dunedin strongly urges the Applicant to consider how applying for a separate license for the high-risk sub-premise of U-Bar may further assist in ensuring that the object of the Sale and Supply of Liquor Act is achieved.
- (35) Finally, SSDP Dunedin strongly urges both the Applicant and the Dunedin District Licensing Committee to keep in mind the precedent previously referenced in section 3.6 of this objection, set by My Noodle Ltd v Queenstown Lakes District Council [2008] NZAR 481 (HC), which holds that:

'No licence holder has a legitimate expectation that a licence will automatically be renewed on identical terms, and the fact that the licensee has managed the premises properly or that there were no specific problems relating to the licensee's particular operation is not decisive.'



5. Partial Objection

SSDP Dunedin objects to this license being issued or renewed without the District Licensing Committee undertaking further scrutiny of the matters specified below, with the applicant submitting further documentation for assessment or review, should the District Licensing Committee so request it:

 Specific to the high-risk premise of U-Bar, that the Applicant provide the prescribed Host Responsibility Policy and Alcohol Management Policy documents, and that these documents are held to a to a standard suitable of a high-risk premise.

(on the grounds of S.131(1)(a) permitting S.105(1)(a) & (j) as a matter of objection.)

2. That the Applicant provides a written breakdown of capacity for each of the six onlicensed sub-premises, and further provides written policies containing management and training processes detailing how they intend to safely manage capacity for each of the six on-licensed sub-premises, while enforcing the effective maximum capacity for each of the six on-licensed sub-premises.

(on the grounds of S.131(1)(a) permitting S.105(1)(a), (c – LAP, Maximum Occupancy), (e – design and layout of the premises) and (j) as a matter of objection.)

 Specific to the high-risk premise of U-Bar, that the Applicant reviews their application that designates U-Bar as supervised, and instead, given the nature of its operations, designate U-Bar as restricted

(on the grounds of S.131(1)(a) permitting S.105(1)(a) as a matter of objection.)

4. That the Applicant premise provides written policies containing management and training processes, either combined or for each of the six on-licensed sub-premises, detailing how they intend to ensure that all matters of security are compliant with the Private Security Personnel and Private Investigators Act 2010. This includes how the applicant intends to ensure that all security staff, whether contracted directly or through another business, are suitably qualified and possess current certificates of approval (COA) issued by the Private Security Personnel Licensing Authority, and furthermore, how the Applicant intends to ensure that all securite that all security staff are trained and remain up-to-date on all matters and training specific to the conditions of the whichever of the six on-licensed sub-premises is relevant.

Furthermore, that the Applicant provides sufficient information detailing how the relationship between Campus Watch and on-license related Security will interact, and what responsibilities each will have in regards to achieving the object of the Sale and Supply of Alcohol Act 2012, and to the good management of the six on-licensed sub-premises.

(on the grounds of S.131(1)(a) permitting S.105(1)(a) and (j) as a matter of objection.)



5. That the Applicant provides a detailed report outlining any and all incidents of intoxication and alcohol-related harms, in proximity of, or related to each of the six specified on-licensed sub-premises, accounting for a period of at least the last 18 months⁹

(on the grounds of S.131(1)(a) permitting S.105(1)(a) as a matter of objection.)

 That the Applicant provides documentation including staff training manuals and records, including those for security staff, as proof of effective training to comply with the law.

(on the grounds of S.131(1)(a) permitting S.105(1) (j) as a matter of objection.)

6. Objection dependent on further or discretionary conditions

On the basis of S.132 and S.117 of the Sale and Supply of Alcohol Act 2012, SSDP Dunedin objects to the license being issued or renewed without the following conditions being imposed on said license by the District Licensing Committee:

 Specific to the high-risk premise of U-Bar, but encouraged for the other subpremises, that the Licensee undertakes appropriate drug overdose and polysubstance/mixed substances overdose recognition and response training with all staff, including security staff.

(on the grounds of S.131(1)(a) permitting S.105(1) (a) and (j) as a matter of objection.)

SSDP Dunedin is able to recommend local training providers to the Applicant in order to assist them meet this condition.

 The Licensee creates, holds and maintains up-to-date and thorough alcohol and substance harm reduction training procedures and manuals for the purpose of training.

(on the grounds of S.131(1)(a) permitting S.105(1) (a) and (j) as a matter of objection.)

 The Licensee keeps detailed training records for all staff, including security staff, that records the date of training, the details of that training, the resources used in that training, and the details of who provided that training.

(on the grounds of S.131(1)(a) permitting S.105(1) (a) and (j) as a matter of objection.)

4. Specific to the high-risk premise of U-Bar, that the Licensee develops and maintains a thorough policy detailing a specified 'place of safety' on the licensed premise, and a corresponding procedure including conditions for handover to emergency services, for how staff, including security staff, should engage with any person who is intoxicated and at likely risk of overdose, where there is a reasonable risk of harm should that removed from the license premise.

(on the grounds of S.131(1)(a) permitting S.105(1) (a) and (j) as a matter of objection.)

This condition is permissible under S. 252(3) of the Sale and Supply of Alcohol Act 2012 which states:

'It is a defence to a charge under subsection (1) if the defendant satisfies the court that, as soon as the defendant or any employee of the licensee became aware of the situation, reasonable steps were taken in respect of the intoxicated person concerned, either—

- (a) to take the person to a place of safety on the licensed premises; or
- (b) to remove the person from the licensed premises."



5. That the Licensee holds for distribution and displays substance, polysubstance and mixed substance harm reduction posters and materials.

(on the grounds of S.131(1)(a) permitting S.105(1) (j) as a matter of objection.)

SSDP Dunedin is able to provide brochures and posters, or can recommend other Harm Reduction Services who can provide these materials, to the Applicant in order to assist them meet this condition.

 The Licensee holds Naloxone in the form of Nyxoid[®] as part of its first aid supplies, and ensures that all staff, including security, are trained in its use.

(on the grounds of S.131(1)(a) permitting S.105(1) (a) and (j) as a matter of objection, and furthermore, on the basis of S.2.12.ii of this letter of objection.)

Naloxone is an opioid antagonist that is used to counter opioid overdose that comes in multiple forms. Nyxoid[®] is an easy to administer nasal spray form of naloxone that is a general sale medicine in Aotearoa. The effects of opioid overdose are exacerbated by alcohol, increasing the risk of respiratory depression – which is the lack of oxygen that can cause brain damage within 5 minutes, and is followed shortly after by death.

In an emergency where opioid overdose is suspected, Nyxoid[®] can be used (in conjunction with CPR) while waiting for professional medical support. Nyxoid[®] can be safely administered to anyone, whether they have ingested an opioid or not. If naloxone is on site when an overdose occurs, it could mean the difference between life and death. When considering:

- i. The recent opioid drug overdose events in the Wairarapa during 2022;
- ii. The 333 deaths in New Zealand from opioid overdose over the last 5 years, at a rate that is increasing year-on-year;¹⁰
- iii. The factors unique to Dunedin that increase the potential vulnerability and harm for its youth/student population;
- The high demand and limited emergency resources available in Dunedin, particularly during the weekends, that can result in delayed response time by first responders;

SSDP Dunedin firmly believes that immediate access to Nyxoid[®] will save lives and is an essential inclusion to any on-licensed premises first aid supplies.
