EXECUTIVE SUMMARY

- 1 This is a report for an application for the renewal of an off-licence for the premises situated at 86 Hillside Road, Dunedin, and known as "Pak 'n' Save Dunedin". The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) apply to this application.
- 2 The applicant does not seek any changes to the licence. The inspector comments that there are no suitability concerns with the applicant and that the premises complies with the relevant legislation.
- 3 Public notice of the application did not attract any objections and the Medical Officer of Health has no matters in opposition. The Police do, however, oppose the renewal of the application.

APPLICANT AND APPLICATION

- 4 The applicant has been the licensee of the premises since August 1997. During that time there has been no compliance issues with the premises.
- 5 The premises used to be open 24 hours per day however, with the introduction of the Sale and Supply of Alcohol Act 2012 (the Act), and then Dunedin's Local Alcohol Policy (LAP), the trading hours are now 7.00 am to 10.00 pm. The applicant is not seeking any change to the current licence conditions.
- 6 While the supermarket is situated in South Dunedin, it is the only "Pak 'n' Save" in Dunedin therefore attracts shoppers from around the city.

PUBLIC NOTICE

- 7 Public notice of the renewal did not attract any public objection.
- 8 The Medical Officer of Health has not opposed the renewal.
- 9 The Police have opposed the renewal. The grounds for their opposition are:
 - a) Section 105(1)(a): Object of the Act the sale of single serve, high alcohol content alcohol at cheap prices is contrary to the Act's object. The premises is situated in a vulnerable community which is being exposed to higher levels of alcohol-related harm. The external advertising of alcohol further exposes the community to harm.
 - b) Section 105(1)(b): Suitability of the Applicant the sale of single serve, high strength alcohol at cheap prices raises questions regarding the applicant's suitability.
- 10 The Police also have concerns relating to the amenity and good order of the location. They highlight the locations of family harm and disorder incidents within a 1 km radius of the premises and, while they cannot link the harm to alcohol purchased from the premises, they say it is 'almost certain' alcohol purchased from this premises has contributed to some of the harm.
- 11 The Police have suggested the addition of two extra conditions to the licence:
 - i. No external advertising or promotion of alcohol; and,
 - ii. No single serve sales of RTDs, beer or cider in containers 500ml or less, excluding craft beer.
- 12 The Licensing Inspector has not opposed the renewal stating there are no issues in relation to the suitability of the applicant and the premises is compliant with all relevant legislation.

CONCLUSION AND CONDITIONS

- 13 While the Police have opposed the renewal of this licence, they would be satisfied with the addition of two extra conditions relating to single serve sales of RTDs, beer and cider and the external advertising and promotion of alcohol.
- 14 The Committee will need to consider the evidence presented by the parties at the hearing.



HOST RESPONSIBILITY POLICY

1. MINORS

- <u>All staff</u> are conversant with the requirements of the Sale and Supply of Alcohol Act 2012, which prohibits the sale of alcohol to persons under the age of 18 years.
- Signage is displayed on the premises stating minors will not be served.
- Staff may require any person appearing to be under the age of 25 years to produce proof of identification.
- The accepted forms of identification are: photo drivers licence, passport, 18 plus card. Identification will be requested where any doubt as to age exists.
- Where proof of age cannot be produced and doubt exists as to age sales will not be made to that person.
- PAK'nSAVE will not sell alcohol to anyone in school uniform even if that person shows valid identification proving they are aged 18 or over.

2. INTOXICATION

- All staff are aware that the Sale and Supply of Alcohol Act 2012 prohibits the sale of alcohol to intoxicated persons and the presence of intoxicated persons on licensed premises.
- Signage is displayed on the premises stating intoxicated persons will not be served.
- Staff have been trained in how to recognise the signs of intoxication.
- Alcohol will not be sold to any person displaying signs of intoxication.
- 3. NON-ALCOHOLIC AND LOW-ALCOHOL BEVERAGES
 - A range of non-alcoholic and low-alcohol beverages are available for purchase.
- 4. SAFE SND RESPONSIBLE CONSUMPTION OF ALCOHOL
 - PAK'nSAVE does not condone the excessive consumption of alcohol, and encourages you to drink responsibly.
 - No promotions encouraging the rapid consumption of alcohol or consumption of an excessive volume of alcohol will be either initiated or conducted on these premises.

Refusal of service should be viewed as an indication we are concerned for your welfare. It is pointed out that staff must comply with their legal obligations under the Sale and Supply of Alcohol Act 2012.

Set out below is details of the steps that PAK'nSAVE Dunedin takes to prevent the sale and supply of alcohol to prohibited people and to promote the responsible consumption of alcohol and ensure compliance with the Act.

DIN kaunihera

CIL | Ōtepoti

- 1. A non-negotiable policy that requires all customers under 25 that are buying age restricted items to produce the required form of identification.
- 2. Point of sale software that automatically prompts the checkout operators to ask the age of any customer purchasing age restricted items. Junior staff require supervisors to approve these sales.
- 3. In addition to this PAK'nSAVE Dunedin employs an outside agency to conduct mystery shopping exercises that check to ensure the checkout operators and supervisors are following PAK'nSAVE Dunedin's polices and legal requirements for the sale and supply of alcohol.
- PAK'nSAVE Dunedin is also saturated with CCTV both the inside and outside of the premises. This allows us to monitor customer behavior, protect staff and prevents any possibility of staff contemplating breaking the law by serving alcohol to underage or intoxicated people.
- 5. PAK'nSAVE Dunedin uses a web based training system Redseed that requires all of its authorized operators to undergo training and then an online test covering the sale and supply of alcohol.
- 6. As a member of Foodstuffs South Island Limited PAK'nSAVE has access to all training resources provided as well as dedicated managers that deal with alcohol and the responsibilities associated with the sale and supply.
- 7. PAK'nSAVE Dunedin's customer service team is trained to watch out for multiple purchases by at risk customers in addition to the usual attempts to purchase alcohol by intoxicated or underage customers.
- 8. PAK'nSAVE Dunedin holds regular meetings to ensure that all duty liquor duty managers and the authorized operators are fully aware of the obligations under the Sale and Supply of Alcohol Act and also any changes or any case law that is developing. All changes are communicated to the checkout operators and updated in our Redseed training software.
- 9. PAK'nSAVE Dunedin does not sell to minors or customers who are intoxicated.
- 10. PAK'nSAVE Dunedin takes its host responsibility practices seriously (a copy of the Host Responsibility Policy is attached).
- 11. Lastly, PAK'nSAVE Dunedin considers itself to be socially responsibly hosts and a good corporate citizen. It will always ensure that alcohol is sold within the law responsibly and in such a way that assists in the minimization of harm caused by excessive alcohol consumption.



On occasion, broken boxes/cartons of beer are individually priced and placed in a trolley to be sold singularly within the designated alcohol area. These products are 'mainstream' products, typically ranging from \$1.69 - \$2 (on average) per bottle/can, typically all 330ml volume and under 5% ABV strength. This activity only occurs when stock is damaged/cartons broken and is not advertised beyond the trolley physically being present within the designated alcohol area.

- Kingfisher Beer, 7.2% ABV, 500ml, \$3.69 (Special) Haagen Strong, 7.2& ABV, 500ml, \$3.79 8.6 Gold Beer, 6.5% ABV, 500ml, \$2.99 (Special)

- New Zealand Lager, 7.0% ABV, 500ml, \$3.59

High strength, low-cost products such as those listed above have the potential to cause harm within communities. For context, this position has been referred to in recent case law, namely:



ltem 2

Two Brothers wholesale Ltd [2021] NZARLA 32:

[124] In terms of the type of products being sold on the premises, the evidence is that Mr Singh considered that Kingfisher beer which has 7.2% alcohol by volume, is "just like everything else in the store, there's quite a few other products that are 7.2%" and he sells it, including as single cans because "there's a demand for it". The Authority considers that the DLC was right to be concerned about this especially given the vulnerability of Tokoroa. As this Authority said in Shady Lady Lighting Ltd v Lower Hutt Liquormart Ltd, the vulnerability of an area raises the threshold of suitability in terms of whether the grant of the licence will result in an increase in alcohol-related harm.

On appeal Churchman J found no error of law arising from the Authority's conclusion in this regard.

Nekita Enterprises Ltd [2021] NZARLA 139-145:

[300] Before the Authority, Mrs Singh also accepted that Nekita's Pages Road premises in Aranui is in one of the most deprived suburbs in Christchurch. Despite this, when questioned about why a fridge for single sales was located at the entry to the store and why there was a trolley of single sale ciders and beers on display with a sign saying "Seven for \$10.00" (which ACG said equated to a unit price of \$1.43 and said was "extremely cheap alcohol"), Mrs Singh replied that they only have a handful of customers who buy those and they are not promoted.

[301] Moreover, in response to whether Mrs Singh saw a problem with her Wainoni Road manager (also in deprived Aranui), saying that Woodstock (a 'ready-to-drink') and single cans were the most popular purchase at Wainoni Road, Mrs Singh replied that Woodstock was 'just a core product' and that 'they have not caused any harm by selling single beers'.

[302] The Authority finds these responses most underwhelming. These responses demonstrate that Mrs Singh either does not understand or is not bothered by the risks associated with single sales, and the promotion of very cheap alcohol in deprived localities. These matters are of considerable concern to the Authority in such localities and are matters that go to the object of the Act.

Whilst considering the above-mentioned case law I cannot however provide any direct evidence that such products sold from this store have contributed to such harm.

I support the Police's request for the DLC to consider a condition being put on this licence (and all off-licensed premises) moving forward of:

"No sales of single serve cans 500mls or below, of high alcohol, low-cost products (except craft beers)"

On 08/08/2022 Police received an application from McDonald Holdings Limited for the renewal of the Off-Licence for the premises known as Pak 'n' Save Dunedin.

This is a busy supermarket premises situated on Hillside Road, South Dunedin. Being a large and popular supermarket chain, the target market for this premises is not only the locality of South Dunedin in which it is situated, but also the wider Dunedin population.

Anecdotal and factual evidence regards this locality as a vulnerable community in regard to Alcohol Harm.

As such Police oppose the renewal of this licence under Section 105:

- (a) Object of the Act
- (b) Suitability of the applicant
- (h) amenity and good order
- (i) amenity and good order already badly effected

It also falls short of section 106(iii), in regard to number of current premises of the same kind in the area.

Object of the Act

(1) The object of this Act is that-

- (a) The sale, supply and consumption of alcohol should be undertaken safely and responsibly; and
- (b) The harm caused by the excessive or inappropriate consumption of alcohol should be minimized.

(2) for the purposes of subsection (1), the harm caused by the excessive or inappropriate consumption of alcohol includes-

(a) any crime, damage, death, disease, disorderly behavior, illness or injury, directly or indirectly caused or directly or indirectly contributed to, by the excessive or inappropriate consumption of alcohol; and

(b) any harm to society generally or the community, directly or indirectly caused or directly or indirectly contributed to, by any crime, damage, death, disease, disorderly behavior, illness or injury of a kind described in paragraph (a)

The sale of single serve, high octane alcohol at a cheap price does not align with the object of the act in that the vulnerable community in which this premises is situated are exposed to higher levels of harm. Furthermore, the advertising of alcohol on the external surrounds of the premises is exposing an already vulnerable community to further harm.

Suitability of the Applicant

Single sales of high strength alcohol at a cheap price adversely effects the suitability of the applicant.

Amenity and good order

Police records of alcohol related incidents in the area indicate that the 1km radius surrounding the premises is one of the worst areas for calls for Police service in Dunedin City. Frequent incidents of family harm and disorder are attended by Police within this area. Alcohol consumed at these incidents are all purchased at nearby off-licences, of which Pak 'n' Save Dunedin is the most prevalent and commonly frequented by the surrounding vulnerable community. Whilst Police have no statistics that directly correlate alcohol harm back to this premises, it is almost certain alcohol purchased at this premises results in nearby harm. The NZ Police Geospatial mapping application has provided the map below showing the location of the premises well within an area of the highest deprivation (red) and incidents where alcohol is a contributing factor.



Conditions Sought

To mitigate further risk, Police seek the following licence conditions:

- 1) No external Alcohol advertising or promotion on the external building premises
- 2) No single sales of RTD's, beer or cider 500ml or less (excluding craft beer)

NOTE: The agencies met with the applicant in early September and engaged in email communication regarding these conditions. The applicant emailed back commending the agencies joint efforts and requesting time to seek advice. This was agreed to by Police and interim opposition was entered. Police have since emailed the applicant back asking for an update but have received no response.
