UPDATE ON ANIMAL SERVICES EDUCATION SESSIONS

Department: Customer and Regulatory

EXECUTIVE SUMMARY

- 1 This report updates the Customer and Regulatory Committee (the Committee) on the Animal Services' free dog education sessions being provided to Dunedin primary schools this year.
- 2 This programme is underway and is proving to be popular. 73 sessions have been scheduled so far and 17 completed to date.

RECOMMENDATIONS

That the Committee:

a) **Notes** the update on Animal Services education sessions.

DISCUSSION

Proactive approach

- 3 This year, the Animal Services team took a proactive approach to promoting dog education, by emailing all Dunedin primary schools to offer them free education sessions for their children.
- 4 Animal Control officers provide these sessions, along with their dogs. Key messages are how to approach a dog, whether the dog is known or unknown, and what to do if they are attacked by a dog. The dogs are important parts of these sessions and allow the children to practise what they have learnt. Sessions take 30-45 minutes.

Response

- 5 Traditionally, schools have been able to request sessions via the Dunedin City Council (DCC) website with limited results. (In the 2022/2023 year, nine sessions were held.)
- 6 To date, the Animal Services proactive approach has yielded 73 bookings for dog education sessions. Requests range from 1-12 sessions per school depending on the school size. There is also interest from two pre-schools as well as a children's library book club.
- 7 Free dog education sessions are also provided for external organisations and internal teams who are out in the community in the course of their work, for example the DCC Resource Consent and Building Consent teams. Four of these sessions have been carried out this year.



OPTIONS

8 As this report provides an update only to the Committee, there are no options.

NEXT STEPS

9 The Animal Services team plans to continue this approach next year and to gradually extend it, at a manageable level, to organisations whose staff regularly enter people's properties, for example NZ Post.

REVIEW OF DOG CONTROL BYLAW AND DOG CONTROL POLICY

Department: Customer and Regulatory

EXECUTIVE SUMMARY

- 1 In August 2023, the Council resolved to commence review of the Dog Control Bylaw (the Bylaw) and Dog Control Policy (the Policy). This review must be carried out under requirements of the Dog Control Act 1996 (the Act) and the Local Government Act 2002 (LGA).
- 2 This report presents the results of early engagement on the review of the Bylaw and Policy, conducted in November 2023. This early engagement has informed the development of a draft Bylaw and Policy.
- 3 In order to meet requirements of the Act and the LGA, and for consultation purposes, this report asks the Committee to:
 - a) Approve a draft Dog Control Bylaw see Attachment A
 - b) Approve a draft Dog Control Policy see Attachment B
 - c) Adopt a statement of proposal (SOP) see Attachment C.
- 4 Proposed changes to the Bylaw and Policy seek to:
 - Improve opportunities for the recreational needs of dogs and their owners: for example, proposing that dogs are allowed on-leash in central business district areas (such as the Octagon) where they are currently prohibited.
 - Protect wildlife and minimise the potential for danger, distress or nuisance, by requiring:
 - i) dogs to be on-leash in all coastal dune areas, including access paths
 - ii) the number of dogs an owner may have on-leash in a public place is limited to six, and off-leash is limited to two at any one time.
 - Make the Bylaw and the Policy clearer and simpler, providing notes explaining the Bylaw and Policy and removing duplication, for example of maps.
- 5 Proposed changes, including reasons for the proposals and an analysis of options, are set out in the SOP.



RECOMMENDATIONS

That the Committee:

- a) **Notes** the review's early engagement results.
- b) **Approves** the draft Dog Control Bylaw and draft Dog Control Policy for consultation purposes, subject to any amendment.
- c) Adopts the Statement of Proposal, for consultation purposes, subject to any amendment.
- d) **Resolves** that the proposed draft Dog Control Bylaw meets the requirements of section 155 of the Local Government Act, in that:
 - i) the proposed Bylaw is the most appropriate form of Bylaw
 - ii) the proposed Bylaw does not give rise to any implications under the New Zealand Bill of Rights Act 1990.

BACKGROUND

Dog Control Act 1996

- 6 The Act states that any territorial authority may, in accordance with the LGA 2002, make dogcontrol bylaws for the following purposes:
 - a) prohibiting dogs, whether under control or not, from specified public places
 - b) requiring dogs, other than working dogs, to be controlled on a leash in specified public places, or in public places in specified areas or parts of the district
 - c) regulating and controlling dogs in any other public place
 - d) designating specified areas as dog exercise areas
 - e) prescribing minimum standards for the accommodation of dogs
 - f) limiting the number of dogs that may be kept on any land or premises
 - g) requiring dogs in its district to be tied up or otherwise confined during a specified period commencing not earlier than half an hour after sunset, and ending not later than half an hour before sunrise
 - h) requiring the owner of any dog that defecates in a public place or on land or premises other than that occupied by the owner to immediately remove the faeces
 - i) requiring any bitch to be confined but adequately exercised while in season
 - j) providing for the impounding of dogs, whether or not they are wearing a collar having the proper label or disc attached, that are found at large in breach of any bylaw made by the territorial authority under this or any other Act

- requiring the owner of any dog (being a dog that, on a number of occasions, has not been kept under control) to cause that dog to be neutered (whether or not the owner of the dog has been convicted of an offence against Section 53 of The Act)
- I) any other purpose that from time to time is, in the opinion of the territorial authority, necessary or desirable to further the control of dog.
- 7 The Act also requires that territorial authorities must have a policy on dogs which details:
 - the outline, nature and application of any dog control bylaw
 - the public places where dogs are to be controlled and how they are to be controlled
 - any designated dog exercise areas, and
 - whether menacing dogs are to be neutered.
- 8 In adopting the Policy, the Council must have regard to:
 - the need to minimise danger, distress, and nuisance to the community generally
 - the need to avoid danger from dogs having uncontrolled access to public places frequented by children
 - the importance of public use of public places without fear of attack or intimidation by dogs, and
 - the exercise and recreational needs of dogs and dog owners.
- 9 Dog control bylaws are required to give effect to the mandatory Dog Control Policy. Bylaws cannot be inconsistent with the Policy.

Review requirements

- 10 The Act requires that a dog control bylaw must be made and reviewed in accordance with the LGA and that dog control policies are to be reviewed whenever the bylaw is reviewed.
- 11 The DCC's Bylaw and the Policy were last reviewed in 2015/2016 with the current version taking effect from 1 July 2016. The LGA requires that bylaws are reviewed no later than ten years after their last review.
- 12 A review of this nature requires use of the Special Consultative Procedure (SCP).

DISCUSSION

Early community engagement

13 To inform any changes to the Bylaw or the Policy, early engagement with key stakeholders was carried out during November 2023. Methods included circulating a web survey to key stakeholders via email, publication in "FYI", media release, advertisements on Dunedin City Council's (DCC) social media page, and a People's Panel survey.

- 14 Questions focussed on rules about some specific locations, satisfaction with controls and more general questions. The survey also sought feedback on satisfaction with dog exercise parks, long-life metal registration tags and dog poo bag vouchers.
- 15 Key stakeholder engagement included SPCA, rūnaka, Community Boards, Department of Conservation (DoC), Blind Foundation, the Police, surf lifesaving clubs, Athletics Otago as well as dog owners and non-dog owners.

Web survey results

- 16 There were 383 responses to the web survey which ran from 1-30 November 2023. Of these the majority (70%) were dog owners and 29% were not dog owners.
- 17 See Attachment D for the full web survey results and key findings.

People's Panel survey results

- 18 The Dunedin People's Panel is an online panel of people who want the opportunity to give feedback on a range of DCC issues can opt in to. At the time of the survey, there were around 1,200 people on the panel.
- 19 There were 239 responses to the People's Panel survey. Of these, 58% did not own a dog and 42% did own a dog.
- 20 See Attachment E for the full People's Panel results and key findings.

Social media feedback

- 21 On 1 and 27 November 2023, the DCC Facebook page posted information about the Dog Control Bylaw and Policy review. These posts provided links to early engagement questions. 8,046 users saw the first post and 793 engaged with the content (i.e. liked, shared, reacted or commented). 12,711 users saw the second post and 1,237 engaged with the content.
- 22 The main topics discussed in the social media chat were enforcement, education, compliance, signage, cats, dog swim areas, wandering dogs, dogs in the CBD, dog poo bins and dog parks.

Other councils

22. Staff also researched other councils' approach to dog control best practice. The proposed updated Bylaw and Policy have been informed by the Christchurch City Council's 2016 Dog Control Bylaw and Policy model. This seeks to better inform and engage dog owners by providing clear information and explanations.

Proposals

- 23 Our early engagement suggests that while many current controls work well, there are some opportunities for improvement.
- 24 These include:
 - improving opportunities for the recreational needs of dogs and their owners



- minimising the potential for danger, distress or nuisance to people, other animals, protected wildlife, and
- making the Bylaw and Policy clearer and simpler to read.
- 25 Proposed changes are summarised in the tables below. For current rules, reasons for proposed changes and an analysis of options, as required by the LGA and the Act, see the SOP at Attachment C.

Making the Bylaw and Policy clearer and simpler

- 26 Some of the changes to make the Bylaw and Policy clearer and to avoid confusion are:
 - adding explanatory notes;
 - removing the current set of maps from the Bylaw, replacing these with schedules and
 - retaining an interactive map which can be used as a guide (but is not part of the Bylaw or Policy).
- 27 See Attachment F for the current Dog Control Bylaw 2016 and see Attachment G for the current Dog Control Policy 2016.

New Zealand Bill of Rights Act 1990 (NZBoRA) implications

- 28 The Council and its Committees must ensure that any bylaw doesn't unreasonably limit the right to certain freedoms under the NZBORA.
- 29 The intent of dog control bylaw is the prevention of harm (either to people, wildlife, other animals, or property). In this sense, limiting the movement of people (when accompanied by their dogs) in some public places and for specified reasons, is a proportionate response and is considered a justified limitation for the prevention of harm.

Consultation

30 The Act requires that the SCP is used for the review of the Bylaw and the Policy and consultation. It is proposed that this is conducted from Monday 10 June until Friday 19 July 2024. This meets the LGA requirement that consultation is open for at least one month.

- Engagement methods will include sending information to dog owners, advertising on the DCC website, social media pages, on the Otago Daily Times noticeboard and in The Star, a media release, and "FYI" article. Key stakeholders will be advised of the review and invited to comment. Stakeholders include the Society for the Prevention of Cruelty to Animals, Community Boards, Yellow-Eyed Penguin Trust, Wildlife Hospital, Department of Conservation, Blind Foundation,
- 32 There will be the opportunity for people to present their views at hearings after July.

OPTIONS

33 Given the statutory requirement for this review, the two main options are to approve the proposed Bylaw and proposed Policy for consultation with or without any amendments. The third option of not having a bylaw and policy would not meet legislative requirements.

This bylaw is made by the Dunedin City Council under the Local Government Act 2002 and authorised by section 20 of the Dog Control Act 1996.

1. SHORT TITLE

1.1 This bylaw is the Dunedin City Council Dog Control Bylaw 2025.

2. APPLICATION

2.1 This bylaw applies to Dunedin City.

3. PURPOSE

- 3.1 The purpose of this bylaw is to give effect to the Council's Dog Control Policy (date) by:
 - 3.1.1 regulating and controlling dogs in public places
 - 3.1.2 providing appropriate controls to minimise the potential for harm, distress or nuisance that may be caused by dogs
 - 3.1.3 providing enforcement options to regulate dog-related matters.

4. EXPLANATORY NOTE

4.1 Text in this bylaw that is in italics *(italics)* is not part of the bylaw, but is explanatory in nature.

5. DEFINITIONS

- 5.1 All definitions have the same meanings as in the Dog Control Act 1996 unless otherwise specified.
- 5.2 In this Bylaw, unless the context otherwise requires:

Act	Means the Dog Control Act 1996
Control	Means the owner or person in charge of a dog is aware of where the dog is and what it is doing, and that the dog is responsive to commands and is not creating a nuisance.

Dog Control Bylaw

	Explanatory note: Having a dog under control means you can see it or are aware of what it is doing and are close enough to prevent issues or quickly bring it to heel.	
Council	Means the Dunedin City Council and includes any person authorised by the Council to act on its behalf.	
Dog exercise area	Means an area that is designated by Dunedin City Council for use as a place for exercising dogs and includes a designated dog exercise area and small breed dog park.	
Leash	Means an adequate restraint and may include a lead attached to a collar or harness, that allows for the control of a dog when in a public place.	
Leashed area	Means any public place specified in this bylaw, or in the Dunedin City Council Dog Control Policy, where dogs must be on a leash.	
Marked playing surfaces	Is that area of land in use for sports activities (excluding golf courses).	
Nuisance	Means anything which interferes with or threatens the health or enjoyment of people, wildlife or other animals, and in this context may involve things such as barking, causing distress via intimidating behaviour (such as aggressive barking or rushing), or attacking people, wildlife or other animals.	
Owner	 Has the same meaning as in s2 of the Act, and means every person who: a) Owns a dog or b) Has possession of the dog, whether the dog is at large or in confinement, otherwise than for the sole purpose of returning a lost dog to its owner or c) Is the parent or guardian of and shares a household with a person under the age of 16 years who is the owner of the dog pursuant to paragraph a) or b) of this definition. It does not include any person who has seized or taken custody of the dog under the Dog Control Act 1996 or the Animal Protection Act 1960 or any regulation made under either of those Acts. 	
Playground	 Means any Council children's playground: a) Within any fenced playground area b) On any specially surfaced playground area c) Within one metre of any fenced or surfaced playground area or d) Within one metre of any playground equipment where there is no fence or special surface. Includes Council skateparks and Council outdoor basketball areas. 	
Prohibited area	Means any public place specified in this bylaw or in the Dunedin City Council Dog Control Policy where dogs are prohibited.	
Protected wildlife	 Means: a) Any animal that is absolutely protected or partially protected according to s3 and s5 of the Wildlife Act 1953, other than any animal that may be hunted or killed under s5(2) of that Act; and b) Any animal that is a marine mammal within the meaning of the Marine Mammals Protection Act 1978. 	
Public place	Has the same meaning as in s2 of the Act, and generally means a place that is open to the public whether or not it is private property.	
Residential zoned land	As identified in the operative Dunedin City District Plan (2GP).

6. DOGS UNDER CONTROL AND ON LEASH IN PUBLIC PLACES

- 6.1 The owner or person in charge of a dog must keep their dog under control in any public place.
- 6.2 The owner or person in charge of a dog must also keep their dog on a leash in any public places, except in designated dog exercise areas and off leash areas specified in the Dunedin Dog Control Policy, Schedule C.
- 6.3 Dogs must not be left tied up and unattended in the central business district zone, as specified in the Dunedin Dog Control Policy, Schedule B.

Explanatory note: Under control leashed areas specified in the Dunedin Dog Control Policy, Schedule B, include:

- All roads, footpaths and tracks
- All cemeteries
- All sports grounds that surround marked playing areas when games are being played (allowed off leash when games are not being played and always prohibited on all marked playing fields
- On Te Aka Ōtākou Dunedin's shared harbour/peninsula pathway
- Within 20 metres of protected wildlife
- On all beaches unless otherwise specified

Dog Control Bylaw

- On all coastal dune areas including access pathways (unless in a prohibited area)
- In commercial areas such as the central business district (dogs must not be left tied up unattended).

7. PROHIBITED AREAS

7.1 No owner or person in charge of a dog shall allow their dog to enter or remain in any public place that is specified as a Prohibited Area in the Dunedin Dog Control Policy.

Explanatory note: Prohibited areas include:

- All children's playgrounds
- All marked playing surfaces at Council owned sports grounds (excluding Council owned golf courses)
- Designated safe swimming beach areas marked by lifeguards with the placement of flags (unless otherwise specified)
- Other specific areas listed in Schedule A to the Dog Control Policy.

8. TEMPORARY PROHIBITED AREAS

- 8.1 The Council may make temporary prohibited areas where reasonable and where, in the opinion of the Council, there is or is likely to be harm caused to people or animals.
- 8.2 The Council will take reasonable steps to notify the public of any temporary prohibited area. A temporary prohibition will take effect from the time signage is placed at the points of entry to the affected area and will end when the signage is removed by the Council.

Explanatory note: Reasonable steps may include advertising on the DCC website, social media or newspaper.

9. EXEMPTIONS TO PROHIBITED AND LEASHED AREAS

- 9.1 Nothing in this bylaw restricting or prohibiting access to any public place applies to:
 - 9.1.1 a working dog that is under the control of its owner while that dog is being worked or while it is being taken to and from its work; or
 - 9.1.2 any dog where an exemption has been granted by the Council.

Explanatory note: Clause 9.1.2 allows for exemptions for dogs that are similar to but do not qualify as a working dog, for example a dog that may be in training to be a working dog or a dog owned by a volunteer and used for pest control purposes.

10. DESIGNATED DOG EXERCISE AREAS

10.1 Designated dog exercise areas and small breed dog exercise areas are specified in the Dunedin City Council Dog Control Policy 2025.

- 10.2 Dogs weighing more than eight kilograms are not allowed inside the boundaries of any small breed dog exercise area.
- 10.3 No owner or person in charge of a dog may leave any dog unattended in a designated dog exercise area.

11. FOULING IN PUBLIC PLACES

- 11.1 The owner or person in charge of a dog that is in a public place must carry and display a bag or other receptacle suitable for the removal of faeces.
- 11.2 The owner or person in charge of a dog that defecates in a public place or on land or premises other than that occupied by the owner must immediately remove the faeces.
- 11.3 Where a public litter bin or similar receptacle is used for the disposal of dog faeces, the owner or person in charge of a dog must ensure that the faeces are wrapped or otherwise contained to prevent fouling of the receptacle.

12. INFECTIOUS OR DISEASED DOGS

12.1 Other than when a dog is being taken directly to a veterinary clinic, no owner or person in charge of an infectious or diseased dog may take that dog into any public place.

13. FEMALE DOGS IN SEASON


- 13.1 The owner or person in charge of a female dog in season must keep the dog:
 - 13.1.1 confined to private property; and
 - 13.1.2 confined in such a way as to minimise the potential for contact with other dogs.
- 13.2 Any female dog in season must be adequately exercised only on private land occupied by the owner of the dog or other private land with the consent of the occupier.
- 13.3 Clauses 12.1 and 12.2 do not apply to any dog that is being taken to a veterinary clinic or for the purposes of breeding.

Explanatory note: The hormones released by a female dog in season can be detected by other dogs over long distances. This is why female dogs in season have to be securely confined on private property (ideally away from boundary fences). The potential impacts on other dogs need to be minimised by limiting the likely hormone trail that would be left if the dog were to be exercised as normal in public places or if it were transported unnecessarily. Transport should be limited to veterinary or breedingrelated travel.

14. NUISANCE

14.1 If, in the opinion of the Council, any dog on any premises has become or is likely to become a nuisance, the Council may, by notice in writing, require the owner or occupier of the premises within a time specified in such notice, to do all or any of the following:

- 14.1.2 order the permanent removal of a particular dog on a property
- 14.1.3 construct, alter, reconstruct or otherwise improve the kennels, places of confinement or other buildings used to house or contain the dog or dogs
- 14.1.4 require the dog or dogs to be tied up or otherwise confined during specific periods
- 14.1.5 take other action as the Council deems necessary to minimise or remove the likelihood of nuisance.
- 14.2 The owner or person in charge of any dog shall ensure that it does not create a nuisance by:
 - 14.2.1 obstructing the lawful passage of persons in a public place
 - 14.2.2 rushing and frightening persons in a public place or persons lawfully on private property
 - 14.2.3 destroying, tearing or otherwise interfering with any refuse container whether the container is on private property or in a public place.

15. PERMIT TO KEEP MORE THAN ONE DOG

- 15.1 Owners of more than one dog must obtain a permit to keep more than one dog over the age of three months on any premises, unless the premises are zoned rural or rural/residential in the operative Dunedin City District Plan.
- 15.2 The fee for such permits shall be payable in addition to the registration fees payable under the Act.

15.3 Application process, criteria and conditions

- 15.3.1 Applications for permits to keep more than one dog shall be made on the form supplied by the Council and shall provide such information in respect of the application as the Council may reasonably require and be accompanied by the application fee set by the Council.
- 15.3.2 A permit is not transferrable to another property or a new owner at the same property.
- 15.3.3 No permit will be granted to the owner or occupier of any premises under clause 15.1 if, in the Council's opinion, the premises would be inappropriate for the housing of more than one dog (including by reason of inadequate fencing, size, location, or detrimental effect on any other premises).
- 15.3.4 A permit issued under clause 15 is subject to any conditions set by the Council. Any breach of conditions or other terms or restrictions shall be a breach of this Bylaw.

Dog Control Bylaw

15.3.5 A permit under clause 15 does not expire but may be revoked by the Council for breach of conditions or, in the event that circumstances change relating to the premises, the owner or occupier, or the animals kept on the premises.

16. LIMITS ON DOGS IN PUBLIC PLACES

- 16.1 No owner or person in charge of a dog may have in their charge more than six (6) dogs at any one time in a public place.
- 16.2 No owner or person in charge of a dog may have in their charge more than two (2) dogs off leash in a public place at any one time.

Explanatory note: An owner or person in charge of dogs may have no more than six dogs in a public place at any time with no more than two of these dogs off leash at any one time. This control is introduced to address issues with multiple dogs in public places.

17. NEUTERING OF DOGS

17.1 The Council may require the owner of any dog (being a dog that, on a number of occasions, has not been kept under control) to have the dog castrated or spayed whether or not the owner of the dog has been convicted of an offence against section 53 of the Act.

18. OFFENCE AND PENALTY

- 18.1 Every person who fails to comply with this bylaw commits an offence.
- 18.2 Every person who commits an offence under this bylaw is liable to a penalty under section 242(4) of the Local Government Act 2002 or section 20(5) of the Dog Control Act 1996.

Explanatory note: Many matters not covered by this bylaw are already covered by the Act, and breaches of those matters can result in the issuing of infringement notices (otherwise known as instant fines). The amounts for these infringements range from \$100 to \$750 and are set out in the Act.

19. RIGHT OF REVIEW

19.1 Any owner affected by a decision made under this bylaw may apply in writing to the Chief Executive for a review of this decision within 14 days after receiving notification of the decision.

Section 1: Introduction

1.1 Context

There are around 19,000 registered dogs in Dunedin, with many dogs considered part of the family. It is important that Dunedin has a range of public places that are accessible for dogs and their owners for fun and recreation. We also acknowledge the reality that dogs can cause problems (such as barking), can cause injuries such as bites, and can even cause death (such as to protected wildlife or other animals).

Good dog ownership can prevent many problems, but we are also aware that dogs can be unpredictable, so we need to minimise risk with reasonable regulatory controls. This policy aims to balance the recreational needs of dogs and their owners with the importance of minimising the potential for any danger, distress or nuisance that may be caused by dogs.

In carrying out its legislative obligations under in the Dog Control Act 1996 (the Act), the Dunedin City Council's (the Council's) approach to dog control is to provide a cost effective, professional service through education, monitoring, compliance and enforcement.

NOTE that the Department of Conservation (DoC) has its own rules about dog access on public conservation land managed by their Department. For more information on these rules please contact DoC directly. On beaches where it may be confusing whether DoC or the Council has control, DoC agrees that the bylaw will apply. These beaches are specified in the Dunedin Dog Control Policy, Schedule A.

1.2 Reason for the policy

The Act requires every territorial authority to adopt a policy on dog control matters and to develop a bylaw to give effect to its policy. The Dunedin Dog Control Bylaw 2025 has been developed alongside this policy.

1.3 Purpose of the policy

The purpose of this policy is to:

- outline how the Council addresses requirements set out in the Act
- balance regulatory controls to allow for the recreational needs of dogs and their owners with appropriate controls to minimise the danger, distress or nuisance that may be caused by dogs to people, other animals or protected wildlife
- encourage and facilitate good dog behaviour and good dog ownership through education.

This policy should be read in conjunction with the Dog Control Bylaw 2025 and the Act. This policy summarises some provisions in the Act, but may not describe or set out a provision of the Act in full. If any summary does not cover every matter discussed in a section, or leads to an inconsistency between the policy and the requirement of the Act, the Act will prevail.

1.4 Review of policy

This policy must be reviewed at least every ten years, together with the Dog Control Bylaw.

Section 2: Dog Control Bylaw

Under the Act councils are required to develop a dog control policy and must develop a bylaw to give effect to the matters covered by the policy. The Act requires a dog control policy to set out the nature and application of its associated bylaw. A dog control bylaw must not be inconsistent with the policy.

2.1 Nature and application of the bylaw

The Dunedin Dog Control Bylaw 2025 applies to all dog owners in Dunedin, and:

- promotes responsible management of dogs in public places
- provides for the recreational needs of dogs and their owners
- minimises the potential for danger, distress or nuisance from dogs to the community, animals and wildlife.

The Dog Control Bylaw covers the following:

- control of dogs in public places
- prohibiting dogs from specified public places or categories of public places
- requiring dogs to be on a leash in specified public places or categories of public places
- exempting certain types of dogs in certain situations
- designating specified areas as dog exercise areas
- placing limitations on the number of dogs that may be kept on properties
- placing limitations on the number of dogs that may be on leash and off leash
- placing limitations on the housing, movement and transportation of female dogs in season while requiring them to be adequately exercised
- placing limitations on travel of infectious or diseased dogs
- requiring dog owners to remove and dispose of any fouling (dog faeces) that their dog produces
- addressing nuisance from dogs.

Section 3: Obligations of dog owners

3.1 Overview

The Act sets out expectations placed on dog owners that are consistent across New Zealand. The Dunedin Dog Control Policy and Bylaw set out matters that are specific to the Dunedin district, such as public places where you can or cannot take your dog or must have it on a leash. All dog owners are required to understand the dog owner requirements and obligations set out:

- in the Act
- in the Dog Control Bylaw and
- in this Policy.

Dog owners should also be aware of animal welfare matters that are covered by the Animal Welfare Act 1999, and, in particular, by the Animal Welfare (Dogs) Code of Welfare, which sets out the minimum standards and recommendations relating to all aspects of the care of dogs. Animal welfare matters relating to companion animals are largely enforced by the Society for the Prevention of Cruelty to Animals (SPCA).

3.2 Dog Control Bylaw obligations of dog owners

Dunedin's Dog Control Bylaw requires dog owners to:

a) Keep dogs under control

Dog owners are required to keep their dog(s) under control at all times when in public places. This means the owner or person in charge must:

- be aware of where the dog is and what it is doing
- ensure their dog is responsive to commands
- ensure their dog is not creating a nuisance.

Explanation

When a dog is under control it means the dog is not creating any sort of nuisance to people, domestic animals or any other wildlife. Nuisance in this sense means things such as barking, rushing at, intimidating, attacking or otherwise causing injury, damage or harm. Going for a walk with your dog unrestrained (not on a leash) is fine in areas where there are no dog restrictions. However, the dog must still be under control. This means you can see the dog or are aware of what it is doing and you are close enough to prevent issues or quickly bring it to heel. Having your dog under control is as much about the safety of your dog as it is about the safety of others.

The Act requires all dog owners to carry a leash when taking their dog into a public place, whether or not the public place is a leashed area (section 54A). This is because unexpected situations may arise that require a dog to be leashed to keep the dog under control or to keep it safe. Another requirement in the Act is that the legal owner of a dog must be over the age of 16 (section 2). The owner or person in charge of a dog should also be physically capable of controlling the dog.

b) Carry and display the means of removing dog faeces in public places and remove dog faeces from public places

The dog owner or person in charge must carry and display a bag or other receptacle for picking up and removing any fouling (dog faeces) when in a public place (for example recycled or compostable bags, pooper scooper).

The person in charge must immediately remove any fouling that their dog produces and dispose of it in a hygienic manner (e.g. in a red wheelie bin or Council rubbish bin).

Explanation

A bag or other receptacle for picking up and removing dog faeces must be carried and displayed at all times when in public places with a dog. Dog toileting habits can be unpredictable and this requirement will prevent owners from being caught short. It is not an excuse to say you do not have a bag or other receptacle with you. Dog faeces can harbour diseases and parasitic infection that can make other dogs or people unwell. It is also generally unpleasant and smelly. It is important that dog owners take responsibility for their dogs so that dogs can continue to enjoy access to a wide range of public places.

c) Other obligations

The dog owner or person in charge must also:

- ensure their dog does not enter into a prohibited area
- ensure their dog is not unattended in a designated dog exercise area
- ensure their dog, if infectious or diseased, does not enter into any public place (other than when being taken directly to a veterinarian clinic
- ensure their female dog, if in season, is confined to private property to minimise potential contact with other dogs
- ensure they have a permit to keep more than one dog over the age of three months, unless the premises are zoned rural or rural/residential
- ensure they have in their charge no more than six (6) dogs at any time in a public place and no more than two (2) dogs off leash in a public place at any time.

Section 4: Registration of dogs

All dogs must be registered in accordance with the Act. It is an offence not to register a dog that is over three months of age. It is an offence to knowingly provide false information on a dog registration application form. Registered dogs must always wear a registration tag. Please contact the Council if you need a replacement registration tag.

Explanation

Dogs are required to be registered for three reasons:

- to keep an up to date record of all dogs and their owners
- to allow for the return of lost dogs, and
- to generate revenue for providing dog control services across the city.

4.1 Dog registration classifications

The registration classifications are as follows:

- Standard dog registration
 - This is the default dog registration classification.
- Responsible dog owner registration

- This applies to dogs owned by people who have Responsible Dog Owner status (this is explained in the section below).
- Spayed/neutered dog registration
 - This can be applied for with a veterinary certificate which is held on file for subsequent registration years.
- Working dog registration

- The definition for working dog is set out in the Act and generally means any dog carrying out functions and duties:
 - relating to farming, such as the herding of stock
 - under the direction of a government department or state employee undertaking responsibilities such as those relating to policing, defence, corrections, customs, security, biosecurity, pest management, emergency management or conservation, or
 - o under the direction of a private security guard in the execution of their duties.
- Dogs classified as menacing
 - This applies to dogs classified as 'menacing' under the Act.
- Dogs classified as dangerous
 - This applies to dogs classified as 'dangerous' under the Act. The Act requires a higher registration fee to be paid for these dogs.
- Disability Assist Dogs
 - These dogs need to be registered but do not incur a dog registration fee
 - Disability Assist Dogs are generally dogs that are certified to assist someone with a visual, hearing, mobility or other disability.

4.2 Setting dog registration fees

Registration fees are set through the Council's Annual Plan process and are notified to all registered dog owners at registration time. The fees are listed on the Council website.

In considering dog registration fees, the Council will, in accordance with the Act:

- set a standard dog registration fee
- set a fee for Responsible Dog Owners that is less than the standard dog registration fee
- provide a discount for spayed/neutered dogs that is less than the standard dog registration fee
- set a fee for dangerous dogs that is 50% higher than the standard dog registration fee
- not set a fee for Disability Assist Dogs, and
- charge a penalty for the late registration of dogs i.e. an additional 50% of the registration fee.

Registration fees are set by councils to take into account the cost of providing dog control services and aim to strike a balance between dog owners bearing the costs of dog control and the benefits to ratepayers of having safe and well controlled dogs in their community.

The Act requires that all money collected under the Act can only be spent on dog control matters.

4.3 Responsible Dog Owner status

To obtain Responsible Dog Owner status, a dog owner must apply for that status and meet the following criteria (as applicable):

- have been the registered owner of a dog and have resided in the Dunedin City District for at least 24 months, or previously held Responsible Dog Owner status in another district
- have paid dog registration fees on time for the last two years
- have all dogs owned by them microchipped in accordance with the Act, including providing the microchip number to the Council
- have a permit to keep multiple dogs on their property (if applicable)
- inform the Council of any dog registration or residential address changes, including information on the death, sale or transfer of any dogs, and including the birth of any pups
- have a property at which their dog(s) resides that is suitably fenced and gated to contain the dog(s) and that allows dog-free access to a door of the dwelling for authorised callers
- have complied with requirements of the Dog Control Act and the current Dog Control Bylaw and must not, in the last two years, have
 - had a dog that has been found at large, been uncontrolled, or been chased, returned or impounded by the Council
 - o been issued with a warning notice or infringement notice for any dog-related offence
 - been prosecuted for any dog-related offence.

Owners of dogs classified as 'menacing' or 'dangerous' under the Act may be considered for Responsible Dog Owner status, provided all criteria are strictly met (where applicable). The granting and retention of the status is at the discretion of the Council.

Applications must be received and approved before 15 April in any year to enable the applicant to gain this status for the dog registration year commencing 1 July.

Any breach of the criteria of this policy will lead to the immediate withdrawal of Responsible Dog Owner status. Should status be withdrawn due to a breach, the owner may not apply for, or be considered for, the status again until two years after the date of withdrawal.

4.4 Registration and de-sexing (neutering) dogs

The Council encourages de-sexing by offering a discount on registration fees for castrated or spayed dogs. You must provide written proof of de-sexing along with your dog registration application form to apply for a reduced fee.

Your dog should be de-sexed unless it is intended for breeding. De-sexing is important to reduce unwanted pregnancies and to reduce aggression. Unwanted puppies need to be cared for, rehomed or destroyed and can become an unintended cost or cause animal welfare concerns. The Council may offer a subsidised dog de-sexing service where possible and where there is an identified need.

4.5 Changing dog ownership

Where the ownership of a dog changes, the registration continues, and both the old owner and the new owner must advise the Council.

4.6 Transferring dog registration between districts

When a registered dog moves to a different council district, the registration will go with it. Owners of dogs transferring must advise both councils of the dog's move in writing and within six months of the move. The owner should take the dog registration tag to their new local council office so it can be swapped for a registration tag for the new area at no charge. The dog does not have to be re-registered in the new area until the next registration year.

4.7 Refunding registration fee if dog dies

The Council will refund the applicable portion of a dog registration fee in the event of the death of a dog. The owner must apply for the refund and provide evidence of the dog's death with a veterinary certificate. Refunds apply from the date the application is received (not from the date your dog died).

Section 5: Microchipping your dog

Except for working dogs, all dogs in New Zealand first registered after 1 July 2006 must be implanted with a microchip.

Owners must supply the dog's microchip information to the Council so it can be recorded in the National Dog Database. You can do this be providing a vet's certificate which includes the number.

Explanation

Dog registration and microchipping are two separate processes. You must register your dog every year but only need to microchip your dog once. A microchip is about the size of a grain of rice and is implanted in a dog's back towards the neck, generally by a qualified person such as a veterinarian. Microchipping is a more permanent way of identifying a dog than collars and tags which can be lost or removed. It enables a dog to be linked to its owner. It can also identify a dog which has been aggressive and classified as dangerous or menacing.

The National Dog Database is administered by the Department of Internal Affairs and holds details of all microchipped dogs in New Zealand, their owners and any infringements that may have been issued against the owner.

Section 6: Prohibited and leashed areas

Dogs may be prohibited from public places or required to be on a leash in public places. If a public place is not listed in this policy, then dogs are allowed there on leash. Dogs on leash and under control is the default classification in Dunedin.

Dogs are prohibited in certain areas to minimise the potential for any danger, distress or nuisance that may be caused by dogs. For example, playgrounds are designed for the use and enjoyment of children and ensuring dogs are not in playground areas makes them safer for children to use.

6.1 Prohibited areas

Public places where dogs are prohibited are listed in Schedule A to this Policy. Some are general areas such as those listed below and some are more specific locations.

Dogs are prohibited in the following **general** areas:

- all Council children's playgrounds this means within any fenced playground area, on any specially surfaced playground area, within one metre of any fenced or surfaced playground area and within one metre of any playground equipment where there is no fence or special surface
- all Council skateparks this means all skatepark surfaces and within one metre of the perimeter of any skatepark
- all marked playing surfaces at Council owned sports grounds (excluding Council owned golf courses)
- designated safe swimming beach areas marked by lifeguards with the placement of flags (unless otherwise specified)

Dogs are also prohibited in other specific locations that are also listed in Schedule A to this Policy.

The Council may from time to time put in place a temporary dog prohibition where, in the opinion of the Council, there is or is likely to be harm to people or animals. The Council will take reasonable steps to notify the public of any temporary prohibited area and these may include advertising on the Council website, social media or newspaper.

Explanation

The Council works with the Department of Conservation when making temporary restrictions, for example at times and places animals are nesting.

6.2 Leashed areas

There are some places where dogs must be on a leash and under control. If a public place is not listed in this policy, then the default is that dogs are allowed there on leash and under control. On leash areas are listed in Schedule B to this Policy.

Unless specified elsewhere, dogs must be on a leash:

- on all roads and footpaths
- at all cemeteries
- on all sports grounds that surround marked playing areas when games are being played (allowed off leash when games are not being played and always prohibited on all marked playing fields)
- on Te Aka Ōtākou Dunedin's shared harbour/peninsula pathway
- within 20 metres of protected wildlife

- on all beaches unless otherwise specified
- on all coastal dune areas including access pathways (except in a prohibited area, where no dogs are allowed)
- on commercial areas such as the central business district (in addition, dogs in these areas must not be left tied up and unattended)
- at all public places not listed elsewhere in this policy or schedules to the policy.

Explanation

These places are shared spaces where there may be vehicles, bicycles, children and wildlife. On leash protects both the dog and other users of these areas.

6.3 Exemptions to prohibited and leashed areas

Dog controls for prohibited and leashed areas do not apply to:

- working dogs (where a working dog is under the control of its owner while that dog is being worked or while it is being taken to and from its work)
- any dog where an exemption has been granted by the Council (for example, an exemption
 may be given where a dog is similar to a working dog, but does not meet that definition, such
 as a dog in training to be a working dog or a dog owned by a volunteer and used for pest
 control purposes).

Section 7: Dog exercise areas

The Council recognises the importance of the recreational and exercise needs of dogs and their owners, and aims to provide opportunities for dogs and their owners to access many different public places across Dunedin. There are parks, reserves, sections of coastline and beaches that allow the opportunity to exercise dogs off leash. These are listed in Schedule C. The Council also has designated dog exercise areas that are safe places to exercise dogs. These are fenced with agility equipment. Dogs must be under control but can be off leash in these areas.

Designated dog exercise areas are also listed in Schedule C and are at:

- Cemetery Road East Taieri
- Cemetery Road East Taieri small breed dog exercise area
- Forrester Park Norwood Street
- Forrester Park Norwood Street small breed dog exercise area
- Kew Park corner of Easther Crescent and Forbury Road
- Rotary Park Highcliff Road
- Shand Park Brighton Road, Green Island
- Shand Park Brighton Road, Green Island small breed dog exercise area*
- Wakari Reserve.

*A small breed dog exercise area is for dogs weighing no more than eight kilograms.

Section 8: Permit for more than one dog

Owners of more than one dog over the age of three months must obtain a permit to keep the dogs on any property unless the premises are zoned Rural or Rural/Residential in the operative Dunedin City District Plan.

A permit may be granted, have conditions imposed, or be refused at the full discretion of the Council. Considerations include, but are not limited to adequate fencing, the size, location and nature of the premises, dog-free access to the house, and compliance with the Dog Control Bylaw. The process is set out in the Dog Control Bylaw.

The fee for a permit shall be payable in addition to the registration fees payable under the Act. The permit fee is set through the Annual Plan process.

Explanation

The purpose of the permit is to minimise the potential for issues associated with having too many dogs on small properties and where neighbours are close by. Considerations relate largely to the Dog Control Act and Animal Welfare Act obligations. If a permit is not granted, then the dog/s must be removed.

Section 9: Limit on dog numbers in public places

An owner or person may have no more than six dogs under their control in a public place at any time and no more than two of those dogs may be off leash at any time. All dogs must be under the control of the owner at all times.

Section 10: Other owner responsibilities

10.1 Barking dogs

When the Council receives a complaint about a barking dog it will investigate, and if necessary, work with the dog owner to understand the extent of the barking, and reasons for it, before encouraging solutions.

If the barking continues to be persistent and loud, a dog abatement notice may be issued under the Act. If this notice is not complied with, an infringement notice may be issued. Complaints about barking may also impact on the dog owner's ability to have Responsible Dog Ownership status or to hold a permit for more than one dog. Dogs are also able to be seized due to loud and persistent barking.

Explanation

Different things can cause a dog to bark and it often happens when the owner is absent. Common reasons are:

- Protective aggression where dogs bark at people or animals they think are invading their territory
- Stimulus barking where dogs bark at sound or movement
- Separation anxiety if dogs are feeling lonely
- Social situations where dogs bark to communicate.

10.2 Female dogs in season

Owners must keep female dogs in season confined to private property. This is to minimise the potential impact on other dogs. Female dogs in season must be adequately exercised on private land occupied by the owner or other private land with the consent of the occupier. Transport of female dogs in season should be limited to veterinary or breeding-related travel.

Explanation

The hormones released by a female dog in season can be detected by other dogs over long distances. This is why female dogs in season have to be securely confined on private property (ideally away from boundary fences). The potential impacts on other dogs need to be minimised by limiting the likely hormone trail that would be left if the dog were to be exercised as normal in public places or if it were transported unnecessarily. Transport should be limited to veterinary or breeding-related travel.

10.3 Dogs in vehicles over summer months

Dogs left in vehicles over the summer months can suffer heat exhaustion quickly. Council officers may release a dog in distress, with the help of the SPCA, or Police.

Explanation

The SPCA has the power to protect all animals from abuse, neglect and abandonment including prosecuting people under the Animal Welfare Act 1999. Dog owners who leave their dog in a hot car can face a charge of animal cruelty.

10.4 Exercising dogs at night

Owners are encouraged to use reflective or other lighting attached to dog collars to help dogs be seen when exercising at dusk or in the dark.

10.5 Welfare of dogs during an emergency

Owners are expected to plan and prepare for the care and welfare of their dog in anticipation of an emergency. During a state of emergency, this includes always keeping dogs under control.

Section 11: Education and training

The Council encourages owners to attend dog training courses, especially puppy training classes to help train and socialise dogs. The first year of a dog's life is very important in establishing good behaviours. All dogs need to be able to understand and appropriately respond to simple commands if they are to be off leash in any designated public place.

Some employment roles (for example tradespeople, couriers and healthcare workers) require people to enter private property, and this can be dangerous if the property has an aggressive dog or a dog that can act unpredictably. It is also important to always supervise young children around dogs. The Council offers free dog safety education sessions for organisations and for schools to increase safety around dogs.

Explanation

A key message for children is 'if a dog is on its own, leave it alone'. Children are also taught to ask a dog's owner if the dog is friendly before approaching it.

Section 12: Managing troublesome dogs and dog owners

Under the Act, dog owners can be classified as probationary and can be disqualified in some circumstances. A dog can be classified as dangerous or menacing in certain circumstances. If education, training or other support is insufficient in terms of controlling a dog, then more punitive measures may be applied. For example, the Council may require the owner of any dog (that has not been kept under control on a number of occasions) to have the dog de-sexed.

Certain classifications can restrict a person's right to own dogs for several years and may require education or training before they are able to own another dog. These classifications apply across the country. The Act sets out processes for objecting to or appealing against classifications.

12.1 Probationary dog owners (see sections 21-24 Act)

When a dog owner has committed a series of dog-related infringement offences or has been convicted of dog-related offences, under the Act the Council may classify that owner as a probationary owner.

A probationary owner cannot become the owner of any new dog(s) (but may keep any registered dogs they already have) and must dispose of any unregistered dog(s). Probationary owners may have to undertake dog owner education and/or dog obedience courses. Probationary dog owner status generally applies for up to two years but may end sooner.

12.2 Disqualified dog owners (see sections 25-28 Act)

Under the Act, a disqualified dog owner cannot be the registered owner of a dog (for a specified period) and must dispose of every dog that they may own. Disqualified dog owner status can apply for up to five years.

12.3 Dangerous dogs

Under the Act, the Council must classify a dog as dangerous based on the owner being convicted of certain offences, or based on sworn evidence that the dog is aggressive and is a threat to the safety of people, stock, poultry, domestic animals or protected wildlife.

The Act provides that dangerous dogs:

- must be kept within a securely fenced section of the owner's property (and dog-free access to the house must always be available)
- must be muzzled and on a leash in all public places and private ways
- must be de-sexed
- incur a registration fee that is 50% higher than a standard dog registration fee
- must <u>not</u> be sold or given away without the written consent of the Council
- maintain their status as a dangerous dog no matter where they live in New Zealand.

The owner of a dangerous dog must, if required by the Council, produce a veterinary certificate showing the dog has been de-sexed or that it is unfit to be de-sexed within one month of the dangerous dog classification.

The Act sets out the process for objecting to or appealing a dog's classification as a dangerous dog.

12.4 Menacing dogs

Under the Act, the Council can classify a dog as menacing if it constitutes a threat to the safety of people, stock, poultry, domestic animals or protected wildlife, based on the dog's behaviour or characteristics typically associated with the dog's breed or type.

The Council must classify a dog as menacing if it belongs wholly or in part to the breeds of dogs listed in the Act: Brazilian Fila, Dogo Argentino, Japanese Tosa, Perro de Presa Canario and American Pit Bull Terrier.

Menacing dogs must be muzzled and on a leash in all public places and private ways. The Council requires all dogs classified as menacing to be de-sexed (neutered), including those classified as menacing by another council. The owner must, if required by the Council, produce a veterinary certificate showing the dog has been de-sexed or that it is unfit to be de-sexed within one month of the menacing dog classification.

The Act sets out the process for objecting to or appealing a dog's classification as a menacing dog.

Section 13: Seizing and impounding dogs

The Act gives warranted dog control officers the power to seize and impound a dog in certain circumstances, including when the Act is breached for:

- a dog not being supplied with enough food, water or shelter
- a dog that is unregistered or not displaying evidence of registration that is more than three months old
- dogs not securely confined on private property
- failing to comply with requirements of a menacing dog classification
- failing to comply with requirement of a dangerous dog classification
- a dog not under control in a public place
- a barking dog where the dog continues to bark and cause a nuisance after a notice has been issued
- a dog attacks a person or animal
- a dog rushes at a person, animal or vehicle in a way that causes death, injury or endangerment, or damage to property
- a dog in the vicinity of protected wildlife
- a dog at large amongst stock or poultry.

The release of a dog back to its owner will depend on the circumstances under which it was seized. For example:

- all fines and fees must be paid
- the dog is registered and microchipped
- Dog Control Act requirements are met.

Costs of housing a dog in the dog shelter and sustenance will be recovered from the dog's owner before the dog is released. Costs could include veterinary fees.

The Act states that when a dog's owner cannot be established, the dog will be impounded and after seven days made available for adoption or destruction.

Where a dog is released from the dog shelter to a new owner, the new owner is not required to pay a standard release fee but is required to pay an adoption fee which includes the cost of registration. This fee aims to ensure responsible ownership while not deterring purchase. Dogs will not be released for rehoming unless they have been de-sexed, there is an agreement to de-sex, or there are exceptional reasons for not requiring de-sexing.

Dog shelter fees, including adoption fees, are set locally and are included in the Council's Annual Plan process. Infringement fees are set in the Act and are consistent across New Zealand.

Section 14: Infringement notices

The Council will issue warnings at its discretion and/or infringement notices (instant fines) for infringement offences as set out in Schedule 1 of the Act.

The Council aims to encourage people to comply with regulatory requirements through education and working with people, rather than by taking a strictly enforcement approach, but will consider each situation case by case.

Section 15: Conservation Act controlled or open dog areas

The Act requires that a dog control policy identifies any areas in the district where there are dog restrictions on Department of Conservation land. Dunedin City Council does not have any 'controlled' or 'open dog areas' on public conservation land within its area.

However, the Department of Conservation has its own rules about dog access on public conservation land managed by their Department. For more information on these rules please contact the Department of Conservation directly. On beaches where it may be confusing whether DoC or the Council has control, DoC agrees that the bylaw will apply. These beaches are specified in the Dunedin Dog Control Policy, Schedule A.

Dog Control Bylaw and Policy Review 2024 Statement of Proposal

This statement of proposal is prepared under sections 10 and 20 of the Dog Control Act and in accordance with sections 83, 86, 87, 155, 156, 159 and 160 of the Local Government Act 2002.



We are reviewing the Dog Control Bylaw (the bylaw) and Dog Control Policy (the policy) and would like to know what you think about proposed changes.

BACKGROUND

The bylaw and policy were introduced as required by the Dog Control Act 1996 (Act). The policy aims to balance the recreational needs of dogs and their owners with appropriate controls to minimise the potential for harm, distress or nuisance that may be caused by dogs to people, other animals and protected wildlife. The bylaw gives effect to the policy by regulating dogs in public places and providing controls to regulate dog-related matters.

PROPOSALS AND OPTIONS

We're proposing some changes to the bylaw and policy. These have been informed by general feedback over recent years as well as feedback from early community engagement during November 2023 (results of the early engagement can be found at <u>www.dunedin.govt.nz/dogs-bylaw</u>). Changes aim to:

- Improve opportunities for the recreational needs of dogs and their owners
- Minimise the potential for danger, distress or nuisance to people, other animals and protected wildlife
- Make the bylaw and policy clearer and simpler.

We have made the bylaw and policy clearer and simpler to understand by rewording some sections. Explanatory notes and additional information are provided so the reasons for the rules are clear.

To avoid confusion, we have also:

- removed the current set of maps, replacing these with schedules of places where dogs are:
 - prohibited
 - allowed on leash and
 - allowed off leash
- retained an interactive map which can be used as a guide (but which is not part of the bylaw or policy)
- retained rules relating to Department of Conservation (DoC) managed beaches but removed rules relating to other DoC managed land these can be found on the DoC website.

Dog Control Bylaw and Policy Review - web survey report, December 2023

This survey and associated information were advertised in FYI, The Star, via social media and a media release, and circulated to key stakeholders such as Community Boards, SPCA, dog clubs and the Department of Conservation.

There were 383 responses including nine from organisations. Organisations were Otago Peninsula Community Board, Royal Forest and Bird Society of NZ, Athletics Otago, Birds NZ, Aramoana Conservation Trust, SPCA, Predator Free Dunedin, Mosgiel Pony Club, and Pony Club.


Key findings

Some key findings from the survey are summarised here:

- There was strong support for current rules at:
 - Te Rauone reserve (87%)
 - Redwood tracks (79%)
 - Caledonian Grounds (69%)
 - Macandrew and Broad Bays (65%).
- The majority supported:
 - dogs being allowed on the Mosgiel Memorial Garden track (68%) and
 - in the Octagon and other CBD areas (64%).
- Views were more divided about coastal dune areas with 51% saying current rules are appropriate and 41% wanting dogs on leash in these areas.
- Satisfaction was highest for long-life metal registration tags (63% satisfied or very satisfied), dog exercise parks (56%), and areas where dogs are allowed on a leash (52%). Dissatisfaction was highest for areas where dogs are not allowed (40% dissatisfied or very dissatisfied), areas where dogs are allowed off leash (33%), and dog poo bags subsidised vouchers (27%).
- The most common topics were better compliance, enforcement and education on the rules, preferring free, posted or cheaper dog poo bags, demand for more dog parks (especially West Harbour and Otago Peninsula), better signage, dog tags, and issues with dogs and horses on beaches. Dog fouling was also a common topic as was demand for dog poo bag dispensers.

We asked 'Do you own a dog in Dunedin?




377 people responded to this question with 70% owning a dog in Dunedin and 29% not owning a dog in Dunedin.






Areas where dogs are allowed on a leash



Dog exercise park areas



PART 05: DOG CONTROL

5.1 TITLE AND COMMENCEMENT

- 5.1.1 The Dunedin City Council makes the Dunedin City Dog Control Bylaw 2016 pursuant to section 20 of the Dog Control Act 1996 and section 145 of the Local Government Act 2002.
- 5.1.2 This bylaw is administered by the Dunedin City Council.
- 5.1.3 This bylaw comes into force on 1 July 2016.

5.2 FORMER BYLAWS REVOKED

- 5.2.1 The Dunedin City Council Dog Control Bylaw 2004 is revoked on 1 July 2016.
- 5.2.2 All bylaws of the Dunedin City Council already in force must be read subject to this bylaw.
- 5.2.3 In the event of conflict between the provisions of any former bylaw and the provisions of this bylaw, the provisions of this bylaw shall prevail.

5.3 PURPOSE

- 5.3.1 The purpose of this bylaw is to give effect to the Dunedin City Dog Control Policy 2016 by:
 - (a) Protecting the well-being and safety of both animals and people;
 - (b) Regulating the public places where a dog may be taken by its owner, and the method of control of the dog; and
 - (c) Limiting the number of dogs that may be kept on any premises;
 - (d) Requiring the owner of any dog that defecates in any public place to immediately remove the faeces; and
 - (e) Requiring the owner to neuter a dog which has not been kept under control on more than one occasion.
 - (f) Provide for the enforcement of this bylaw by prescribing offences for contravening or permitting a contravention of this bylaw.

5.4 INTERPRETATION

5.4.1 In this Bylaw, unless the context requires otherwise:

Act – means the Dog Control Act 1996

Animal Control Officer – has the same meaning as 'Dog Control Officer' as appointed under section 11 of the Act.

Cemetery – means any land or premises for the burial and/or cremation of the dead and includes a closed cemetery and Urupa (Maori burial ground).

Commercial Areas - means:

(a) the Octagon, the Civic Centre, the Library Plaza and those areas of Princes Street

and George Street which lie between the Exchange and Knox Church or

(b) King Edward Street, South Dunedin between Hillside and Macandrew Roads.

Dangerous dog – means a dog classified in accordance with section 31 of the Act.

Disability assist dog – has the same meaning given to it in section 2 of the Act.

District – means that area within the Dunedin City Council territorial authority boundaries.

Dog control fee - means any fee prescribed under section 37 of the Act.

Dog control officer - means a dog control officer appointed under section 11 of the Act and includes a warranted officer exercising powers under section 17 of the Act.

Designated Dog exercise area - means an area that is designated by Dunedin City Council resolution for use as a place for exercising dogs and includes a designated dog exercise area and small dog park.

Dog ranger - means a dog ranger appointed under section 12 of the Act, and includes an honorary dog ranger.

Domestic animal – includes:

- (a) any animal (including a bird or reptile) kept as a domestic pet;
- (b) any working dog; or
- (c) any other animal kept by any person for recreational purposes or for the purposes of that person's occupation or employment.

Infringement offence - has the meaning given to it in section 65(1) of the Act.

Marked Playing Surfaces – is that area of land in use for sports activities (excluding golf courses)

Menacing dog - means a dog classified in accordance with section 33A or section 33C of the Act.

Neutered dog - means a dog that has been spayed or castrated and does not include a dog that has been vasectomised.

Owner - means every person who:

- (a) Owns a dog; or
- (b) Has possession of the dog, whether the dog is at large or in confinement, otherwise than for the sole purpose of restoring a lost dog to its owner; or
- (c) Is the parent or guardian of and shares a household with a person under the age of 16 years who is the owner of the dog pursuant to paragraph (a) or (b) of this definition; but does not include any person who has seized or taken custody of the dog under the Dog Control Act 1996 or the Animal Protection Act 1960 or any regulation made under either of those Acts.

Playground - means any children's playground equipment provided or maintained by the Council for public use and includes a skateboarding facility.

Private way - has the meaning given to it by section 315(1) of the Local

Government Act 1974.

Protected wildlife - means:

- (a) Any animal for the time being absolutely protected pursuant to section 3 of the Wildlife Act 1953; and
- (b) Any animal for the time being partially protected pursuant to section 5 of the Wildlife Act 1953, other than an animal in such circumstances that it may be hunted or killed under the authority of subsection (2) of that section; and
- (c) Any animal that is a marine mammal within the meaning of the Marine Mammals Protection Act 1978

Public Place – means a place that, at any material time, is open to or is being used by the public, whether free or on payment of a charge, and whether any owner or occupier of the place is lawfully entitled to exclude or eject any person from that place and includes any aircraft, hovercraft, ship or ferry or other vessel, train, or vehicle carrying or available to carry passengers for reward.

Registration year - has the same meaning as that given to the term "financial year" by section 5 of the Local Government Act 2002. Currently this is defined as from the 1^{st} day of July in any one year to the 30^{th} day of June the following year.

Residential zoned land - as identified in the operative District Plan.

Rural-residential zoned land - as identified in the operative District Plan.

Road – has the same meaning as in section 315 of the Local Government Act 1974.

Small breed dog park - means a designated dog exercise area in which only dogs weighing less than eight kilograms may be permitted.

Stock – means:

- (a) Any live horse, cattle, sheep, swine, alpaca, llama, bison, donkey, hinny, mule, or water buffalo that is not in a wild state:
- (b) Any deer, goat, tahr, rabbit, possum, or other animal that is kept within a fence or enclosure for domestic or farming purposes

Warranted officer - means any person who is for the time being a warranted officer within the meaning of the Conservation Act 1987.

Working Dog – has the same definition as in the Act and includes:

- (a) any disability assist dog
- (b) any dog:
 - i. kept by the Police or any constable, the Customs Department, the Ministry for Primary Industries or the Ministry of Defence, or any officer or employee of any such Department of State solely or principally for the purposes of carrying out the functions, powers, and duties of the Police or the Department of State or that constable, officer, or employee; or,
 - ii. kept solely or principally for the purposes of herding or driving stock; or,
 - iii. kept by the Department of Conservation or any officer or employee of that

department solely or principally for the purposes of carrying out the functions, duties, and powers of that department; or, kept solely or principally for the purposes of destroying pests or pest agents under any pest management strategy under the Biosecurity Act 1993; or

- iv. kept by the Department of Corrections or any officer or employee of that Department solely or principally for the purposes of carrying out the functions, duties, and powers of that Department; or
- v. kept by the Aviation Security Service established under section 72B(2)(ca) of the Civil Aviation Act 1990, or any officer or employee of that Service solely or principally for the purposes of carrying out the functions, duties, and powers of that Service; or
- vi. certified for use by the Director of Civil Defence Emergency Management for the purposes of carrying out the functions, duties, and powers conferred by the Civil Defence Emergency Management Act 2002; or
- vii. owned by a property guard as defined in section 9 of the Private Security Personnel and Private Investigators Act 2010 or a property guard employee as defined in section 17 of that Act, and kept solely or principally for the purpose of doing the things specified in section 9(1)(a) to (c) of that Act; or
- viii. declared by resolution of the territorial authority to be a working dog for the purposes of the Act, or any dog of a class so declared by the authority, being a dog owned by any class of persons specified in the resolution and kept solely or principally for the purposes specified in the resolution and does not include a dog kept for the purpose of recreational hunting.

5.5 SHELTER FOR DOGS

- 5.5.1 The owner of any dog must provide:
 - (a) a weatherproof kennel of adequate size and on well drained land, or other place of confinement (which may include any dwelling); and
 - (b) access to clean water and food; and
 - (c) clean and sanitary conditions.
- 5.5.2 Where a premise is unfenced, the owner of a dog must restrain the dog by a fixed chain or running wire which allows the dog free movement.
- 5.5.3 No owner of any dog shall keep it in any kennel or place of confinement within two metres to any boundary of neighbouring premises. This clause does not apply to dogs confined within a dwelling house.

5.6 CONTROL OF DOGS

- 5.6.1 The owner and any person for the time being having charge of any dog shall ensure that the dog does not enter or remain in any public place unless it is under continuous control on a leash except:
 - (a) in designated dog exercise areas described in Schedule A; and

- (b) areas described in Schedule B as permitting dogs to be off leash but only between half an hour before sunrise until half an hour after sunset; and
- (c) areas described in Schedule C; and
- (d) any other areas shown in the Schedule E maps as being permitted off leash but only between half an hour before sunrise until half an hour after sunset.
- 5.6.2 Owners must ensure that dogs off leash are under effective control at all times, and that any restrictions described in any schedule are complied with.
- 5.6.3 Clause 5.6.1 does not apply to a working dog carrying out the work in respect of which the dog has been registered.
- 5.6.4 Dog owners must carry a leash with them at all times.
- 5.6.5 Dog owners must place their dogs on a leash within 20 metres of protected wildlife.

5.7 DESIGNATED DOG EXERCISE AREAS

5.7.1 Dogs weighing more than eight kilograms may not be allowed inside the boundaries of any small dog park.

5.8 PUBLIC PLACES IN WHICH DOGS ARE PROHIBITED

- 5.8.1 Dogs are prohibited at all times in those places listed in Schedule D.
- 5.8.2 If, in the opinion of the Animal Control Officer, there is or is likely to be harm caused to people or animals in any area, temporary prohibitions of the entry of dogs may be made to specified places. The temporary prohibition will take effect from the time signage is placed at the points of entry to the affected area and will end when signage is removed by an Animal Control Officer.
- 5.8.3 The Council may, by resolution, make areas permanently prohibited to dogs.
- 5.8.4 Permanent prohibitions will be publicly notified.

5.9 FOULING IN PUBLIC PLACES

- 5.9.1 The owner of any dog that is in a public place must carry and display a bag or other receptacle suitable for the removal of faeces.
- 5.9.2 The owner of any dog that defecates in a public place or on land or premises other than that occupied by the owner must immediately remove the faeces.
- 5.9.3 Where a public litter bin or similar receptacle is used to dispose of the faeces, they must be suitably wrapped or contained to prevent fouling the receptacle.

5.10 INFECTIOUS OR DISEASED DOGS

5.10.1 No person being the owner or having control or charge of any infectious or diseased dog may take that dog into any public place except while being taken to a veterinary clinic.

5.11 FEMALE DOGS IN SEASON

5.11.1 Every person that is the owner of any female dog in season must at all times keep

that dog confined so that it does not enter or remain on any place except the premises occupied by the owner.

- 5.11.2 Any female dog in season must be adequately exercised only on private land occupied by the owner of the dog or other private land with the consent of the occupier.
- 5.11.3 Clause 5.8.1 does not apply when that dog is being taken to a veterinary clinic.

5.12 DOGS ADOPTED FROM THE POUND

5.12.1 The owner of any dog adopted from the Council pound must present a certificate to an Animal Control Officer stating the dog is a neutered dog within one month of the adoption date.

5.13 NUISANCES

- 5.13.1 If, in the opinion of the Council, any dog or dogs on any premises has become or is likely to become a nuisance, the Council may, by notice in writing, require the owner or occupier of the premises within a time specified in such notice, to do all or any of the following:
 - (a) Reduce the number of dogs kept on the premises;
 - (b) Order the permanent removal of a particular dog on a property;
 - (c) Construct, alter, reconstruct or otherwise improve the kennels, places of confinement or other buildings used to house or contain such dog or dogs;
 - (d) Require such dog or dogs to be tied up or otherwise confined during specific periods;
 - (e) Take such other action as the Council deems necessary to minimise or remove the likelihood of nuisance.
- 5.13.2 The owner of every dog shall ensure it does not create a nuisance by:
 - (a) Obstructing the lawful passage of persons in public places;
 - (b) Rushing and frightening persons in a public place or lawfully on private property;
 - (c) Destroying, tear or otherwise interfere with any refuse container whether the container is on private property or in a public place.

5.14 PERMIT TO KEEP MORE THAN ONE DOG

- 5.14.1 No more than one dog of register-able age (whether or not such a dog is registered) may be kept on any premises unless:
 - (a) The owner or occupier is the holder of a permit to keep two or more dogs; or,
 - (b) The premises are zoned rural or rural/residential in the operative Dunedin City District Plan.
- 5.14.2 No permit shall be granted to the owner or occupier of any premises if the premises by reason of inadequate fencing, size, location or detrimental effect on any other premises would be inappropriate for the housing of two or more dogs.

- 5.14.3 If the property in which the dog owner resides is leased/rented, the written consent of the property owner is required to keep two or more dogs on that property. A copy of this consent must be provided to the Council with the application for the permit.
- 5.14.4 A permit issued under this Clause is subject to the conditions set by the Council. Any breach of such conditions or other terms or restrictions shall be a breach of this Bylaw.
- 5.14.5 Any permit may be revoked by the Council for breach of conditions or, in the event of change of circumstances relating to the premises, the owner or occupier or the animals kept on the premises.
- 5.14.6 Applications for permits to keep more than one dog shall be made on the form supplied by the Council and shall provide such information in respect of the application as the Council may reasonably require.
- 5.14.7 There shall be paid to the Council for every such permit an inspection fee which the Council may from time to time by resolution publicly notified prescribe, and on each 1st day of July following the date of issue, an annual fee may be charged for the following 12 months.
- 5.14.8 The fee for such permits shall be payable in addition to the registration fees payable under the Dog Control Act 1996.

5.15 NEUTERING OF DOGS

5.15.1 The Council may require the owner of any dog (being a dog that, on a number of occasions, has not been kept under control) to have the dog neutered or spayed whether or not the owner of the dog has been convicted of an offence against section 53 of the Act.

5.16 OFFENCES

- 5.16.1 Every person who contravenes or permits a contravention of this bylaw commits an offence.
- 5.16.2 Every person who commits an offence under this bylaw is liable to a penalty under section 242(4) of the Local Government Act 2002 or section 20(5) of the Dog Control Act 1996.

5.17 SAVINGS

5.17.1 Every licence issued under the Dunedin City Council Dog Control Bylaw 2004 to keep more than one dog shall continue in effect unless revoked under clause 5.10.

Areas that from time to time the Council will notify by way of signage and advertising that there is a temporary dog prohibition in place because of the presence of wildlife or stock.

1 INTRODUCTION

- 1.1 The Dunedin City Council recognises the positive impact that dogs can bring to health and wellbeing in their role as human companions. Responsible dog ownership ensures that the benefits of companionship are highlighted. Owning a dog also carries the responsibility of being considerate of others who share our public places who aren't dog owners and ensuring your dog is not a nuisance or menace to your neighbours and the wider community.
- 1.2 The Dunedin City Council is responsible for dog control across the district. This policy serves to meet the Council's obligations under the Dog Control Act 1996, and provides the framework on which the Dog Control Bylaw and associated fees regarding dog registration and offences are based.

2 OBJECTIVES

- 2.1 The Council's principal objectives are to:
 - (a) have all dogs registered and micro-chipped;
 - (b) minimise danger, distress and nuisance caused by dogs;
 - (c) minimise the risk of dog attacks;
 - (d) minimise the fear of dogs attacking or intimidating people;
 - (e) avoid danger from uncontrolled dogs entering children's play areas;
 - (f) ensure the protection of public health and safety in areas used by the general public;
 - (g) provide for exercise and recreational needs of dogs;
 - (h) provide for service users to meet the costs of services;
 - (i) ensure the protection of native wildlife in reserves and beaches (e.g. fur seals, sea lions, penguins and wading birds) by minimising the risk of dog attacks.

3 RESPONSIBLE DOG OWNERSHIP

3.1 Proactively promote the responsible ownership of dogs, including care and control around people, protected wildlife, other animals, property and natural habitats.

3.2 What Does It Mean To Be A Responsible Dog Owner?

- ✓ Choose the right dogs and treat them well.
- ✓ Ensure your dog has adequate exercise.
- \checkmark Consider the health benefits for your dog of neutering at an early age.
- ✓ Register and microchip your dog.
- ✓ Teach your dog basic obedience (keep your dog under control at all times).
- ✓ Know the best locations where you are allowed to take (exercise) your dog.
- ✓ Be particularly vigilant near children and closely supervise interaction at all times.
- Know when you dog will ignore commands: put dog on-leash, shorten leash, or avoid the area altogether (even if in an off-leash or designated dog exercise area).
- ✓ Respect other people's personal space. Public places are for everyone's enjoyment and not everyone is fond of dogs.
- ✓ Ensure your dog cannot leave your property by itself.
- ✓ Know when your dog must be on a leash, and always carry a leash.
- ✓ Always carry and display a bag or other receptacle suitable for the removal of faeces and pick-up after your dog.

4 LEGISLATION

4.1 The legislation that relates to the control of dogs and specifies the obligations imposed on Dunedin City Council and dog owners are:

4.2 **Dog Control Act 1996**

- 4.2.1 The purpose of the Dog Control Act¹ is to make better provision for the care and control of dogs:
 - (a) by requiring the registration of dogs; and
 - (b) by making special provision in relation to dangerous dogs and menacing dogs; and
 - (c) by imposing on the owners of dogs, obligations designed to ensure that dogs do not cause a nuisance to any person and do not injure, endanger, or cause distress to any person; and
 - (d) by imposing on owners of dogs obligations designed to ensure that dogs do not injure, endanger, or cause distress to any stock, poultry, domestic animal, or protected wildlife; and
 - (e) to make provision in relation to damage caused by dogs.

4.3 Dog Control Policy

- 4.3.1 All Territorial Authorities must adopt a Dog Policy under the Dog Control Act², which must have regard to the following:
 - (a) the need to minimise danger, distress, and nuisance to the community generally; and

- (b) the need to avoid the inherent danger in allowing dogs to have uncontrolled access to public places that are frequented by children, whether or not the children are accompanied by adults; and
- (c) the importance of enabling, to the extent that is practicable, the public (including families) to use streets and public amenities without fear of attack or intimidation by dogs; and
- (d) the exercise and recreational needs of dogs and their owners.

4.4 Dog Control Bylaw

- 4.4.1 Section 20 of the Dog Control Act permits any territorial authority to make bylaws regarding the control of dogs in accordance with the process in the Local Government Act 2002. The Dog Control Bylaw includes the following provisions;
 - (a) prohibiting dogs, whether under control or not, from specified public places;
 - requiring dogs, other than working dogs, to be controlled on a leash in specified public places, or in public places in specified areas or parts of the district;
 - (c) regulating and controlling dogs in any other public place;
 - (d) designating specified areas as dog exercise areas;
 - (e) prescribing minimum standards for the accommodation of dogs;
 - (f) limiting the number of dogs that may be kept on any land or premises;
 - (g) requiring the owner of any dog that defecates in a public place or on land or premises other than that occupied by the owner to immediately remove the faeces;
 - (h) requiring any female dog to be confined but adequately exercised while in season;
 - providing for the impounding of dogs, whether or not they are wearing a collar having the proper label or disc attached, that are found at large in breach of any bylaw made by the territorial authority under this or any other Act;
 - (j) requiring the owner of any dog (being a dog that, on a number of occasions, has not been kept under control) to cause that dog to be neutered (whether or not the owner of the dog has been convicted of an offence against section 53).

5 FEES AND REGISTRATION

5.1 The Council's policy is to apply a graduated fee scale to target fees to high demand users and to deter non-compliance. For example, fees for repeat impounding of a dog increase with each subsequent impounding.

5.2 Registration Fees

- 5.2.1 All dogs are required to be registered in accordance with the Dog Control Act 1996 which provides:
 - Dog registration fees are set by Council resolution;
 - Dog registration fees, fines and impound fees are used to fund the dog control service;
 - Registration fees paid after 31 July will have a late payment penalty applied. The penalty is an additional 50% of the registration fee; and
 - Infringement notices for not registering a dog may also be issued.

5.3

 Dogs that are kept within an effectively fenced area on the property they are registered at, to prevent escape from the property (Selected Owners);

- Neutered dogs.

5.4 The Council will provide a pro-rata refund for registration fees paid where a registered dog dies in the period of registration³.

5.6 Other Fees

- 5.6.1 These fees are set by Council resolution and include but are not limited to:
 - Impounding,⁴
 - Sustenance and board (during period of impounding)⁵
 - Micro-chipping⁶
 - Multiple dog permit⁷

6 MULTIPLE DOG PERMIT

- 6.1 No more than one dog of register-able age, i.e. three months old and over (whether or not such dogs are registered), may be kept on any premises unless the owner or occupier of the property has a permit from the Council.
- 6.2 No permit will be required to keep one or more dogs (working dogs) within the Rural zone as defined in the Dunedin City Council District Plan.
- 6.3 No permit may be granted to the owner or occupier of any property for more than one dog if the owner or occupier cannot demonstrate compliance with the Dog Control Bylaw, or if the criteria below are not met to the satisfaction of the Council:
 - 1 If the property in which the dog owner/owners resides is leased/rented, the written consent of the property owner is required to keep more than two dogs on that property before any consideration for a permit will be given. A copy of such consent must be forwarded to the Council with the permit application.
 - 2 The property must be adequately fenced to confine the dogs on the section, or in the absence of full boundary fencing, a portion of the section must be fenced sufficiently to confine the dogs yet allow them to have an adequate exercise area for their size.

- 3 Where necessary and having regard to the numbers and size of the dogs kept, the area of confinement must be paved, graded and drained to any standard set by the Council and in any event, must be on well drained ground.
- 4 Adequate housing of sufficient size suitable to meet the needs of the dogs, with access to clean water, must be provided on well drained ground.
- 5 The Council may consider the owner's dwelling to be sufficient to meet this condition, depending on the particular circumstances.
- 6 All dogs must be currently registered and must be kept at all times in accordance with the provisions of the Dog Control Act.
- 7 Such screening of the area of confinement as is necessary to protect the visual amenities of the neighbourhood must be provided.
- 8 All dog owners must abide, at all times, with the Dog Control Bylaw and its subsequent amendments. Failure to meet this requirement may result in a notice to remove one or more dogs permanently from the property.
- 9 The property must be made available for inspection by an authorised council officer at any reasonable time.
- 10 The number of dogs that may be kept on a property must not exceed that number for which the permit may be issued.
- 11 Any alterations to the property must meet the Council's criteria prior to the Animal Control Officer issuing a permit.
- 12 Any permit must be obtained prior to an additional dog being obtained.
- 13 The Council may:
 - (a) Refuse the granting of a permit for the keeping of two or more dogs, or
 - (b) Revoke a permit issued, if the conditions set out above are at any time breached and not rectified following written notice by the Council and within a period of time allowed by the Council and to give notice in writing that all dogs except one be removed from the property within such time as Council consider necessary in the particular case.
- 14 No permit will be granted relating to a property used for breeding, boarding or fostering unless a resource consent has been obtained where appropriate.
- 15 Council must be notified of any change of address, so that a permit may be obtained for the new address. Permits may not be transferred to a new property.
- 16 If your dog numbers reduce to one or no dogs for a period of two or more years your permit is deemed to have lapsed and you will need to reapply if you once again have two or more dogs on your property.
- 17 A fee as prescribed in the Animal Services annual fees and charges in the Council's Annual Plan must be paid to the Council by 31 July.

7 EDUCATION AND DOG OBEDIENCE

7.1 The Council encourages dog owners to attend dog obedience courses, particularly puppy training classes, to assist in the training and socialisation of dogs.

7.2 Where a dog has been classified as Menacing or Dangerous, the Council may require a dog owner to attend specified courses.

8 MENACING AND DANGEROUS DOGS

8.1 Dogs can be classified as Menacing in accordance with sections 33A and 33C of the Dog Control Act or Dangerous in accordance with section 31 of the Act.

9 PROBATIONARY AND DISQUALIFIED OWNERS

9.1 Dog owners can be classified as a Probationary owner in accordance with sections 21 of the Dog Control Act or can be disqualified in accordance with section 25. The maximum period of probation or disqualification may apply, unless the owner can demonstrate that the maximum period is unnecessary for the purpose of achieving the objectives of the Council's Dog Control Policy.

10 NEUTERING OF DOGS

- 10.1 Any dog classified as Dangerous by the Council or by any other Territorial Authority in accordance with section 32 of the Dog Control Act must be neutered. A dog categorised as Menacing under section 33E of the Dog Control Act may be required to be neutered.
- 10.2 In all cases the classification documents served on the owner of a Menacing or Dangerous dog will advise the owner of the requirement to neuter the classified dog within one month.
- 10.3 The owner of a dog which is required to be neutered by the Council; must produce a veterinary certificate showing either that the dog has been neutered or that the dog is unfit to be neutered before a certain date.
- 10.4 The Council may require the owner of any dog (being a dog that, on a number of occasions, has not been kept under control) to have the dog neutered or spayed whether or not the owner of the dog has been convicted of an offence against section 53 of the Act.

11 DOG FOULING

11.1 Dog fouling is not tolerated in any form within the Dunedin City Council boundary. Dog owners must ensure that they carry and display a bag or other receptacle suitable for the removal of faeces and remove it immediately.

12 INFRINGEMENTS

12.1 The following infringement offences are set by the Dog Control Act. The Council has no discretion to alter these fees.

13 DOG EXERCISE AREAS

- 13.1 The Council will review the need for specified dog exercise areas and suitable locations as necessary.
- 13.2 Dogs weighing more than eight kilograms may not be allowed inside the boundaries of any designated small dog park.

14 DOGS ON LEASH

14.1 Every owner of a dog shall keep that dog on a leash in public areas at all times except in a dog exercise area (specified either by signage or listed in a schedule Dog Control Bylaw) or by exceptions specified in the bylaw. Dogs must be leashed near any playground.

15 DOG RESTRICTIONS

- 15.1 Areas where dogs are restricted or prohibited within the Dunedin City Council district (except when in a vehicle) are specified in Schedule D of the Dog Control Bylaw.
- 15.2 The Department of Conservation ("**DOC**") manages dog restrictions by the use of onsite access signage and brochures. Dog owners are expected to adhere to restrictions displayed on signage and in brochures as to where dogs are permitted or prohibited.
- 15.3 Further information on dog restrictions on DOC-managed land can be obtained from the Dunedin DOC Office and i-Site Visitors Centre.
- 15.4 Dog owners must place their dogs on a leash within 20 metres of protected wildlife.
- 15.5 In addition to the specific restrictions set out above, dogs must be kept under control at all times as required by the Dog Control Act. This is expected to be sufficient to ensure that dogs do not injure, endanger, or cause distress to any protected wildlife.

16 WELFARE OF DOGS DURING AN EMERGENCY

- 16.1 All dog owners are expected to plan and prepare for the care and welfare of their dog(s) in anticipation of an emergency. While a state of emergency is in place dog owners must:
 - (a) Keep their dogs under effective control at all times;
 - (b) Ensure their dog does not injure, endanger or cause distress to any person.

TRADING IN PUBLIC PLACES BYLAW REVIEW

Department: Customer and Regulatory

EXECUTIVE SUMMARY

- 1 The Trading in Public Places Bylaw (The Bylaw) was made on 27 October 2020 and came into effect on 1 January 2021. The Local Government Act 2002 (The Act) requires that a bylaw must be reviewed within five years after being made.
- 2 This report recommends that the Customer and Regulatory Committee (the Committee) determines that a bylaw continues to be the most appropriate way to address public trading issues in Dunedin.
- 3 It seeks approval to commence review of the Trading in Public Places Bylaw 2020 (the Bylaw).
- 4 The Act requires these decisions to be made before commencing the bylaw review.
- 5 See Attachment A for the Bylaw.

RECOMMENDATIONS

That the Committee:

- a) **Determines** that a bylaw is the most appropriate way to address public trading issues in Dunedin.
- b) **Approves** commencement of the review of the Trading in Public Places Bylaw.

BACKGROUND

Purpose of bylaws

- 6 Under the Act, bylaws can be made for one or more of the following general purposes: protecting the public from nuisance; protecting, promoting, and maintaining public health and safety; and minimising the potential for offensive behaviour in public places (section 145).
- 7 The Act also allows bylaws to be made specifically to regulate trading in public places (section 146(1)(a)(vi).

Dunedin Bylaw history and purpose

8 The Bylaw was made on 27 October 2020 with the date of effect 1 January 2021. It replaced the Mobile Trading and Temporary Stall Bylaw which had been in place for more than 30 years regulating mobile trading and temporary stalls only.

- 9 As substantial changes were intended, the Mobile Trading and Temporary Stall Bylaw was revoked, and a new bylaw was made.
- 10 From 2021, the Bylaw required permits for a wider range of public trading activities than were addressed in the previous Mobile Trading and Temporary Stall Bylaw, including rental scheme operators (e.g. e-scooter companies), street fundraising, street performing, touting, and commercial use of footpaths. Requirements within the Bylaw include operators complying with conditions of their permit and that safe pedestrian access in public places is maintained. Under the Bylaw, the Council may charge a fee for permits.
- 11 The Act requires that a new bylaw is initially reviewed within five years of being made. Thereafter the review period is ten years.
- 12 While the purpose of the Bylaw is to *"provide reasonable controls to protect health and safety, to protect the public from nuisance and to regulate trading in public places"* it is also important to acknowledge the benefits that public trading can contribute to the city, including vibrancy, liveliness and attractive lifestyle options.

DISCUSSION

Bylaw is appropriate

- 13 Before commencing the bylaw review process, Council is required to determine whether a bylaw is the most appropriate way to address the perceived issue.
- 14 A bylaw is still proposed to be the most appropriate way to address issues with public trading in Dunedin. Initial evidence indicates that the Bylaw works well. Operators generally comply with the Bylaw and the relevant trading conditions. Along with a balance of education, the Bylaw ensures appropriate standards of health and safety, and pedestrian access are maintained for all people using our public places including people with disabilities. For example, the introduction of rental scheme operations (such as e-scooter companies) as a trading activity in 2021 means that these companies now require a permit to operate. They are required to pay a fee and comply with conditions (including always maintaining safe pedestrian access).
- 15 Without a bylaw, there is a risk that operators trade in public places without any health and safety or pedestrian access controls. The Council would have limited mechanisms to manage issues should they arise. Education alone is considered insufficient to manage public place trading in Dunedin.
- 16 The review will consider how well the Bylaw is working for each of the trading activities, and if there are opportunities for improvement.

Review of trading conditions

- 17 While the Bylaw requires trading operators to comply with conditions for their trading activity, the conditions themselves sit outside and are separate to the Bylaw. These conditions are monitored and can be reviewed by staff and amended as needed with appropriate levels of community engagement. This allows flexibility to respond to changing needs without the requirement to amend the Bylaw itself, which can only be done by use of the special consultative procedure process and Council resolution.
- 18 As an example, the code of practice conditions for rental e-scooter operators were updated recently, to meet evolving best practice, and in preparation for the tender process for permit



renewal. Mobile trading sites and street performing conditions are also able to be updated to align with city upgrades.

19 Particular attention is planned for the conditions and sites for mobile trading and for street performing. While separate to the Bylaw review, this work will be carried out around the same time.

Special consultative procedure

20 The Act requires the use of the special consultative procedure as part of the review.

OPTIONS

21 Options are whether a bylaw is the most appropriate way to address trading in public places issues in Dunedin and whether to permit the bylaw review process to commence.

Option One – The Bylaw is the most appropriate way to address related issues in Dunedin (recommended)

Advantages

• Bylaw ensures management of appropriate standards of health and safety, and pedestrian access across all public trading operators.

• Bylaw provides the means to address issues arising from public trading in Dunedin. *Disadvantages*

• There are some administrative costs of managing the Bylaw.

Option Two – A Bylaw is NOT the most appropriate way to address trading in public places issues in Dunedin

Advantages

• Administrative overheads could potentially be reduced.

Disadvantages

• Appropriate standards of health and safety, and pedestrian access may not be maintained with education and information alone.

The DCC would have limited mechanisms to protect public health and safety and minimise offensive behaviour and public nuisance in the event that issues arise from public trading. **NEXT STEPS**

- 22 Once the review commences, next steps are to carry out early engagement before reporting back to the Committee with a draft Statement of Proposal and draft Bylaw.
- 23 The draft Bylaw will incorporate any proposed changes. The recommendation will then be to approve a draft Bylaw and draft Statement of Proposal for consultation using the special consultative procedure, as required by the Act.

Trading	Has a corresponding meaning to trading activity.

4.2 Any undefined words, phrases or expressions used in this bylaw have the same meaning as in the Act, unless the context plainly requires a different meaning.

5 EXPLANATORY NOTES

- 5.1 Explanatory notes are not part of this bylaw and the Council may add, amend or delete explanatory notes at any time without amending the bylaw.
- 5.2 Explanatory note: Explanatory notes are used for a number of reasons, including to explain the intent of a clause in less formal language, to include additional helpful information, or because the information may be subject to change and need to be updated before the bylaw itself has to be updated.

6 TRADING ACTIVITIES IN PUBLIC PLACES

- 6.1 No person may undertake a trading activity in a public place without written permission obtained under this bylaw.
- 6.2 A permit issued under this clause is subject to terms and conditions that the Council thinks fit in respect of the proposed trading activity.
- 6.3 Permit holders must comply with the conditions of the permit and any applicable code of practice.
- 6.4 Terms and conditions specified in a permit may include without limitation, such matters as:
- 6.4.1 The name of the permit holder
- 6.4.2 The duration of the permit holder
- 6.4.3 The location to which the permit applies
- 6.4.4 The type of trading activity allowed by the permit
- 6.4.5 The hours of trade allowed by the permit.





7 APPLICATION FOR PERMISSION

- 7.1 An application for a permit must be made in writing and on the appropriate form provided by the Council (if any).
- 7.2 Every applicant must provide all the information requested.
- 7.3 A permit must be obtained in respect of each trading activity to be carried out by the applicant.

Explanatory note: A person carrying out multiple trading activities must obtain an individual permit for each trading activity.

7.4 The Council may set application and other fees for permissions under this bylaw.

8 PERMIT MAY BE ALTERED, SUSPENDED, CANCELLED

- 8.1 The Council may, in its discretion, on giving notice of not less than 24 hours to the permit holder, review, withdraw or alter any permission given under section 6 of this bylaw.
- 8.2 The Council may immediately without notice, alter, suspend or cancel any permit given under section 6 of this bylaw if:
- 8.2.1 Permit conditions are being breached
- 8.2.2 Urgent works are required in the public place where the permit applies
- 8.2.3 Urgent action is required to protect the public in the public place where the permit applies.
- 8.3 Where a permit has been suspended or cancelled the permit holder must immediately remove any vehicle, stall, goods and materials used in the permitted trading activity from the public place.

9 PERMIT NOT TRANSFERABLE

- 9.1 A permit granted under this bylaw is not transferable to any other person.
- 9.2 A person granted with a permit for one trading activity cannot transfer the permit to any other trading activity to be carried out by the person.

10 PEDESTRIAN ACCESS IN PUBLIC PLACES

10.1 All permit holders must ensure that pedestrian access is maintained in public places at all times and that they, and their audience, do not block footpaths, doorways, bus stops, fire escapes or roads.





11 PROHIBITED MOBILE SHOP TRADING AREAS

- 11.1 Unless specific permission has been granted, holders of mobile shop trading permits are prohibited from trading in the following areas:
- 11.1.1 George Street from the Octagon to Albany Street
- 11.1.2 Princes Street from the Octagon to Jetty Street
- 11.1.3 Lower Stuart Street from the Octagon to Moray Place
- 11.1.4 Moray Place
- 11.1.5 The Octagon except for specified spaces in the central carriageway
- 11.1.6 Wickliffe Square except for specified spaces.

12 THE COUNCIL MAY FROM TIME TO TIME RESOLVE

- 12.1 The Council may from time to time resolve to:
- 12.1.1 Declare any public place or part of a public place to be an area where a trading activity is prohibited
- 12.1.2 Declare any public place or part of a public place to be an area where a trading activity is restricted and only permitted in a specific location
- 12.1.3 Declare an activity to be a trading activity
- 12.1.4 Declare a trading activity to be prohibited for any period.

13 BREACH OF BYLAW

- 13.1 A person breaches this bylaw when they:
- 13.1.1 Breach any provision in this bylaw
- 13.1.2 Breach any conditions of a permit granted under clause 6 of this bylaw.
- 13.1.3 Fail to carry out any action reasonably required by an Authorised Officer under this bylaw.
- 13.2 A breach of this bylaw may result in the permit being suspended or cancelled.
- 13.3 Every person that has had a permit suspended or cancelled must immediately cease trading until such time that the Council may permit them to resume.

14 PENALTIES

14.1 Every person who breaches this bylaw commits an offence and is liable on conviction to a fine not exceeding \$20,000 as set out in the Local Government Act 2002.





14.2 Any property involved in the commission of an offence against the Local Government Act 2002 which includes a breach of this bylaw, may be seized and impounded by the Council in accordance with that Act.

15 RIGHT OF REVIEW

15.1 Any applicant affected by a decision made under this bylaw may apply in writing to the Chief Executive for a review of this decision within 14 days after receiving notification of the decision.

16 ADDITIONAL INFORMATION TO THE TRADING IN PUBLIC PLACES BYLAW 2020

This additional information does not form part of the bylaw. It contains information to help users understand, use and maintain the bylaw. This information may be updated at any time.







Key Trends and Issues:


- The Building Consent Authority's (BCA) biennial accreditation audit was undertaken by external auditors (IANZ) in September 2023. Only one general non-compliance was outstanding at the end of the audit. This was cleared before Christmas, and we retained our accreditation. The report noted the BCA as low risk and the Programme Manager – Building at IANZ noted it as an 'excellent performance'.
- In the six months ending 31 March 2024, Building Services staff provided 13 training sessions on various topics to 137 attendees from multiple organisations including Independently Qualified Persons (IQP's), Facilities Managers (FMANZ), architectural practices and designers.
- The Minister for Building and Construction has requested all BCAs to submit quarterly data on their processing timeframes to MBIE. The first dataset to 31 March 2024 confirms Dunedin's median days for Building Consents (BC) was 10 days and for Code Compliance Certificates (CCC) it was 11 days. The respective percentages were 97.0% for BCs, and 98.7% for CCCs. The full data dataset can be found at Building Consent System Performance Monitoring
- The number of building consent applications continues to reduce although there is an increase in the complexity with a higher proportion of commercial work and higher dollar values.
- Reporting for Building Warrant of Fitness (BWoF) auditing and Earthquake Prone Buildings will be provided at the next Committee meeting.
- The coalition Government recently announced proposed changes to 'drive down costs and make it easier to build'. Two of these changes are:
 - Remove barriers for the use of overseas building products and require councils to accept products that meet international standards which are the same as or higher than those in New Zealand.
 - Bring forward a review of the earthquake prone building legislation and extend remediation deadlines by four years while the review is underway.









Key Trends and Issues:

•Review of the Dog Control Bylaw and Policy is underway with formal consultation scheduled in June.

• The number of dog attacks has decreased slightly over the last quarter compared to the previous six months. Dog attacks on people has seen a slight upward trend.

 Education sessions to community and school groups have increased with 73 sessions scheduled for the 2024 year (compared with nine carried out during the 2022/2023 year).

•There is a downward trend in the number of wandering dogs, wandering stock, and barking requests for service received by Animal Services.









