EXECUTIVE SUMMARY

- This is a report for an application for a new on-licence for the premises situated at 354 Great King Street, Dunedin, and to be known as "DropKicks". The criteria found at section 105 of the Sale and Supply of Alcohol Act 2012 (the Act) apply to this application.
- This is a new licence for the upstairs area of the former Captain Cook Hotel. The focus for the new premises will be as a live entertainment venue. The inspector considers that the sale and supply of alcohol under these conditions are consistent with the purpose of the Act and meets the criteria at section 105.
- Public notice of the application attracted two objections. The first is from the Students for Sensible Drug Policy Ōtepoti Dunedin, and the other from Mr B Crestani and Ms E lbs.
- 4 The reporting agencies have not opposed the application.

APPLICANT AND APPLICATION

The Applicant in this matter has a sole director, Ms Miliana Lobo Linwood, and shared shareholding between Ms Linwood and Mr Baden Oxley.



- The purpose of this venue is to provide a safe space for all to enjoy great, quality entertainment. The Applicant's website states that they are "founded in response to the overwhelming need for an affordable bar and accessible live music & entertainment venue in North Dunedin."
- 7 The Applicant is seeking licence hours of Monday to Sunday, 11.00 am to 3.00 am the following day. They have asked for the premises to be designated a 'restricted' area.

AGENCY COMMENT

- 8 Neither the Medical Officer of Health nor the Licensing Inspector have opposed the application. The Police did not report.
- 9 The Licensing Inspector has commented on a promotion at another venue operated by the Applicant. This was dealt with after a meeting with the three agencies.
- During the meeting regarding the abovementioned matter, the Applicant was asked about the social media advertising a gig at the venue for the end of August. The Applicant was adamant they did not know about this gig until they read about it on the social media themselves.
- The Inspector stated that the concept of a student bar is well supported so long as it is run in a manner that ensures the safe and responsible sale and supply of alcohol.

PUBLIC NOTICE

Public notice of the application attracted two objections: the Students for Sensible Drug Policy Ōtepoti Dunedin (SSDP) and Mr B Crestani and Ms E Ibs via Dr L Gordon.

Mr Crestani and Ms McMillan

- 13 The objection relates to:
 - a) Sections 3 and 4 the purpose and object of the Act
 - b) Section 105(1)(b) suitability of the Applicant
 - c) Section 105(1)(h) amenity and good order of the locality
 - d) Section 105(1)(j) whether the Applicant has appropriate systems, staff and training to comply with the law.
- The concerns stated is that the location of the premises, media coverage of the proposed venue before the expiry of the objection period and purpose of the venue to provide a safe place for low-cost entertainment indicates it will be a student bar. No other detail relating to the grounds for objection is provided.

Students for Sensible Drug Policy Ōtepoti Dunedin

SSDP state they became aware of extensive social media campaigns by the Applicant announcing the date of the opening of the venue which was well before the close of the public objection period. They believe the actions of the Applicant were a 'complete disregard to the fair and due process required' in the Act.



- SSDP said they are committed to bringing back safer and well-managed student bars but cannot support and potential student bar when there is a clear identifiable risk that the prospective licensee will make things worse for students.
- 17 The grounds for objection stated by SSDP are:
 - a) Section 105(1)(a) object of the Act
 - b) Section 105(1)(b) suitability of the Applicant
 - c) Section 105(1)(h) amenity and good order of the locality
 - d) Section 105(1)(j) whether the Applicant has appropriate systems, staff and processes to comply with the law.
- 18 No other detail regarding the grounds for objection is provided.

CONCLUSION AND CONDITIONS

- 19 The Applicant in this matter is establishing the premises so there is another live entertainment venue in Dunedin that is safe for all.
- Advertising an opening before a licence is issued can be considered presumptuous on the part of the Applicant but it is for the Committee to determine if this places doubt on the Applicant's suitability to hold an alcohol licence.
- 21 The hearing will allow the parties to speak to their submissions before the Committee determines the outcome of the application.

With suitable number of experienced staff, both newly employed for the new premises and those currently working at Ombrellos & Errick's, we will have at least 4 or 5 of our current Duty Managers available for work across different shifts.

We will also employ professional security staff, through the security company we always use to help look after our events - at both sites, including at this property and off site.

How will the applicant train staff to ensure they comply with the Act?




Sensitive Areas surrounding 354 Great King Street

However, the distance between the two buildings makes it likely that our premises would have little to no effect on the hospital.



Evacuation Procedure:

Building Warden Duties:

On the activation of the fire alarm system alerting devices, the Building Warden shall put on their fire warden identification and proceed directly to the Fire Alarm Panel mimic in Albany Street and be prepared to receive information from each area/floor warden that their areas have been evacuated. On the arrival of the Fire/Rescue Service this information will be relayed to the senior officer who will take control of the scene.

Area/Floor Warden Duties:

On the activation of the fire alarm system alerting devices, the area/floor wardens shall put on their fire warden identification and check each room for occupants and ensure they are clear as they themselves evacuate the building. All occupants will be directed to the Assembly Area, on the footpath outside the car park at the South of the building in Great King Street, Dunedin.

The area/floor wardens shall assemble any person with a disability, who is unable to use the evacuation route, if located on the Ground Floor level, they will gather at the bar, near the Albany Street egress. If located on Level





1 they will gather at the top of the stairwell nearest Albany Street.

The area/floor wardens are to report to the Building Warden who will be located at the fire alarm panel mimic in Albany Street informing them of the state of the evacuation and the location of any person(s) with disabilities.

The area/floor wardens shall then proceed to the assembly area and ensure that occupants do not reenter the building until the "all-clear" has been given by the Fire/Rescue Service.

Trial Evacuations:

These shall be carried out on a 6-monthly basis and a copy of the evacuation report is to be sent to the NZ Fire Service on completion.

Errick's - New Business

Risk Mitigation to Community

The new business by Errick's at 354 Great King Street will be a Music/Event Venue and Bar serving beverages and food several times per week.

The surrounding areas are mainly occupied by hospitality and retail activities with no known accommodation in the immediate vicinity of the premises. We will ensure that noise activity taking place on site at any time will not exceed the performance standard set out in the district plan, with regular monitoring of this taking place.

The ownership team of Errick's takes their responsibilities as a licensed premise very seriously, as DCC will be well aware of in it's dealing with us on numerous occasions. We have several years of experience with our other premises, Ombrellos Kitchen & Bar in Clarendon Street and most recently at Errick's Venue.

While it is likely we will attract a younger clientele, given the location, our business ethos is all about providing safe, well managed space to patrons to enjoy entertainment. Providing a safe and well managed space comes with us closely managing the consumption of alcohol, the behaviour of our patrons and crowd control, in order to limit any negative impact on our community, create a positive work environment for our staff and avoid damage to our own property.

The building, outside areas and security

The new business of Errick's includes a small outside area, which is enclosed by fencing on. The courtyard will be intended to act as a smokers area only, to ensure this does not take place inside the premises and will be monitored by security.

During functions/ events, for which we would normally impose a 3am finish time, we employ a security firm, TN Security, who we have now worked with for many years, both at Ombrellos, Errick's and for our offsite events. They help manage the front door, corwd control, implement our safety procedures and conduct regular inspections of both the inside and outside areas in order to monitor behaviour, check IDs and mitigate any noise issues. We will endeavour to keep any issues with queues in public spaces at Errick's during functions at a minimum, employing the use of crowd barriers when necessary, and there will be no concerns at any other trading time.

Sale, consumption and supply of alcohol

Functions:

The new business of Errick's will make its spaces regularly available to people for hosting functions.



Errick's supplies a full set of terms and conditions to patrons holding functions on site, which hosts must sign. These include the following statement:

Any patron, including the birthday person or members of their family, arriving intoxicated, attempting to bring alcohol onto the premises or discovered with alcohol purchased elsewhere on the premises will be denied entry for the entire evening without exception. Any patron, including the birthday person or members of their family, who becomes intoxicated or otherwise antisocial on Errick's property will be required to leave the premises.

Pre-function meetings with function hosts include an additional briefing on alcohol consumption policies.

TN Security and our staff are trained to recognise the signs of intoxications amongst guests attending functions as they arrive. Anyone deemed to be intoxicated will be refused entry. We have taxi information for safe transport to hand.

During the function we have water and non-alcoholic drinks always available, along with lower alcohol options and we insist upon a minimum per-head spend on food to ensure adequate amounts are served to guests.

We discourage open bars and the service of spirits at our 21st functions. Where alcohol is provided either free of charge or at a subsidised rates by the host to their guests, non-alcoholic drinks must also be provided free of charge (to the guests).

General Service

We have a licensed duty manager on staff all the time and can have up to three working at any one time during busy functions, although only one will be the official duty manager on shift. Additionally, we actively encourage and support our staff to undertake the LCQ training and support them to obtain their Manager's Certificate if they want to and are likely to gain enough experience with us to take on a Duty Manager's role during their time with us. We want to ensure that any junior staff on duty, all of whom are briefed on induction on our sale of liquor policies and are able to access guidance if they have concerns about guests becoming intoxicated.

Promotions

Errick's may wish to run a select number of specials and promotions during the week but will be mindful to include food and low/ non-alcohol options during these times. The aim of Errick's new business will be 'low cost' to target a different demographic to our other businesses. For this reason, discounts on alcoholic beverages will not occur often and when they do, will be minimal.

BYO

Errick's does not generally permit BYO alcohol on the premises. Exceptions may be made for certain special events (such as a food matching degustation/ wine tasting event/family special occasions), when agreed in advance. Corkage charges are imposed.

Further, any person found bringing in and consuming alcohol on the premises will be required to leave immediately.

Provision of food

The new business of Errick's will have a bar menu (including 3 substantial food items) available operating at all times alcohol is being served/ available. We will also employ a partnership with the surrounding hospitality businesses (in the same building – reburger and Sals) to provide food for larger events, ensuring we have adequate food availability for the number of patrons.



Litter

The same as at our other premises, our staff will be instructed each night, to complete a litter pick out outside the venue. Our staff complete this in a buddy system to stay safe, and often complete this while security is still present on site. We always ensure the bulk of the pick up is completed on the night of an event, to ensure no disturbance to others the next day. We also employ a maintenance company, to help with keeping the outside of the premises and grounds tidy at all times.

Dispersal of Patrons

Much like a controlled entry, we use tactics to slow down the rate of dispersal of patrons too. Usually, we begin the exit process an hour prior to licence finish time (in this instance 2am at the latest). This usually comprises of factors such as, the headline act has finished, the sound gets turned down, the lights slowly get brighter, the bar services slows and eventually stops, the spaces are cleared one by one by security. This strategy ensures that patrons leave in small groups at a time, rather than all at once. This keeps the impact on the surrounding community and transport services to a minimum. The exit way is also monitored by security, with security keeping exit flow controlled via single file, employing the use of crowd barriers where necessary.

Host Responsibility Policy

The team from Errick's is committed to providing you with a comforting, welcoming environment where alcohol is served responsibly. We have developed the following host responsibility policy and provide ongoing training to our staff to ensure they remain up to date with current legislation and understand how to implement our policy.

Minors

If you look under 25 years old, we will ask you for identification when purchasing alcohol. We accept a driver's licence, passport or HANZ/ KiwiAccess Card as proof of age. Don't be offended – we could lose our liquor license for serving alcohol to people under 18 years of age.

Intoxication

Under the Sale and Supply of Alcohol Act 2012 people who are visibly intoxicated cannot be sold alcohol and must not be on our premises. The Errick's team are trained to recognise the signs of intoxication and supported to carry out their job responsibly.

Food and Non-Alcoholic or Low Alcohol beverages

A range of food is available at all times alcohol is served, along with a full selection of non-alcoholic and low alcohol beverages. Water is free at all times.

Transport

We encourage those consuming alcohol to make use of taxis or designated drivers when leaving Errick's. We have a full selection of interesting non-alcoholic beverages for designated drivers. Or you can ask our staff to phone you a taxi – we have a great relationship with a number of taxi operators.

Signage

There is signage throughout the venue promoting our host responsibility policy and the services we provide as responsible hosts. Please ask any of our staff at any time if you are unsure of our policy.

To whom it may concern,

In light of recent conversations and leaked information to the media and subsequent actions since, questions that have been raised with me from Sgt Jones (police), Tanya Morrison (DLA) and the media, I would like this document to be formally submitted in support of my liquor license application ON-10-2024 for Loboski Venues Ltd TA Dropkicks.

I feel this is necessary as communications around events to do with both our new business and current businesses, that have taken place thus far, seem to have been misconstrued by those involved with comments and decisions around our licence/s.

I believe having my comments in writing and laid out without interruption of other questions being brought into the picture such as my age, that I am a female and a young mother, will be far more productive, than conversations taking place in environments that bring back some of the worst memories for me, such as a police station.

To begin, I am more than happy and willing to listen to and take on board the concerns of the objections of our licence that have been made. I do agree that some points in both objections are completely valid and are points I also feel strongly about. You will note one of the same studies an objector has made reference to, is actually on our own website. I wish to take these concerns seriously and I am happy to be present and available for meetings as needed throughout this process with my legal representative.

I would also like for the record, prior to explaining things further to confirm that yes, I am a young female, yes, I am an active mother, and this does not make me any less of a suitable licensee holder or dedicated, proper and passionate business owner.

About DropKicks Media Leak

On the morning of Tuesday 13th August, I woke up to the news that The Critic, had written a story on our proposed business of DropKicks. After speaking with writers of the article, they advised that after seeing our license notice displayed and doing some research online to find a website created by our contracted marketer, they were able to piece two and two together for a story.

By the time I had woken up, I had requests from news outlets and media outlets, being pressured to make a comment.

I have messages to Tim Scott from ODT, who wrote the article, of me asking for the article to be delayed, given we did not have a decision on our liquor license.

I also have multiple messages to my marketing staff, advising for no advertising with a location or website to be released.

I have messages with my own father, asking how the news got leaked and the implications this could have for my license.

Following external pressures and public comments, I decided while it was not the ideal situation, it was necessary and crucial, for me to take control of the narrative in the media around my new business, that being bringing more live music to our city and creating safe spaces for all to enjoy, to ensure that the wrong light was not portrayed on what we were trying to do, given the timeframe for objections was still open – so this is what we did.

Inspector's comment

This report is prepared for the District Licensing Committee's consideration.

This applicant is the same applicant that is currently trading on a Temporary Authority licence at Erricks, 218 Crawford Street, Dunedin.

On 1 August 2024, Police became aware of a promotion at Erricks for a 'free \$100 bar tab' promotion and informed the other agencies. A meeting to discuss this was held with the applicant on 19 August 2024, with a Graduate Response Model (GRM) warning issued to the applicant by the NZ Police, due to a breach of section 237 (promotion of alcohol provisions) being apparent. Though this matter has now effectively been addressed with the applicant, the committee may wish to consider this incident in terms of overall applicant suitability.

Social media posts have advertised for an 'opening night' on 14 September 2024, as well as another gig (initially at a secret unknown location, recently revealed to be at DropKicks) on 31 August 2024. When questioned about this event at a meeting with the applicant on 19 August 2024, the applicant claimed no prior knowledge of this (31 August) gig until they themselves read about it online.

Whilst it is understandable that the applicant is looking to start their business, book artists/performers and bring in revenue by already selling tickets to planned events, it could be seen as presumptive that an alcohol-licence will be granted to enable these events to occur. These concerns appear to have been mentioned in the public objections received for this application as well.

The concept of a student bar in general I believe is well supported, provided it is run in a way that ensures the safe and responsible sale and supply of alcohol, which is the object of the Act.

I do not raise any matters for opposition. If the committee were of a mind to grant the licence, the premises would be included within routine monitoring throughout the licensing period.

We are sending you this letter on behalf of the members of Students for Sensible Drug Policy Ōtepoti-Dunedin (SSDP) to lodge an objection to the application for the renewal of license ON-10-2024 by Loboski Venues Limited trading as Errick's / 'Dropkicks'.

SSDP is affiliated with the Otago University Student Association (OUSA). The objective of SSDP is 'to reduce drug related harm and advocate for drug policy change in Dunedin and Aotearoa.' As has been recently reported on in the media, alcohol is the drug that is most used, and which causes the most harm in Aotearoa-New Zealand.

The core membership and primary focus of SSDP's work is the University of Otago and Otago Polytechnic student population, which are explicitly acknowledged in section 1.3 of the Dunedin Local Alcohol Policy (LAP) which states:

"As a tertiary education hub, the city is home to proportionately more 15 – 24 year olds than other New Zealand centres. These young people arrive in Dunedin just as they reach the age that they are legally able to purchase alcohol (18 years), and at a time when they are seeking opportunities to meet and socialise with other young people. Student accommodation is clustered in the North Dunedin area which immediately surrounds the tertiary institutions, with student parties in the area acting as a magnet for non-students. This combination makes the city's young people particularly vulnerable to hazardous drinking and alcoholrelated harm."





SSDP became aware of extensive social media campaigns by the Applicant, as well as the Applicant announcing the opening of their venue, around the 10^{th} of August 2024. This was well before the close of the objection period for their application for an On-license being 5:00 PM Wednesday 21st of August 2024.

SSDP found the fact that the Applicant had announced their venue extremely concerning, as the Applicant's actions seem to be in complete disregard to the fair and due process required by the Sale and Supply of Alcohol Act 2012 (hereafter 'the Act') which exists to ensure the safe and responsible supply of alcohol; and demands the minimisation of alcohol-related harm, as per the section 4

More recently, Section 3 of the Act has played only a limited role in case law since 2012, but in 2023 it was reaffirmed by the Supreme Court which emphasised several aspects. The "new system of control" is to be seen "for the benefit of the community as a whole". In particular, that "it is a feature of the 2012 Act that the system of control should facilitate local preferences about alcohol supply."3

In 2021, the Court of Appeal also notes at [17] that the Act "envisages that harm relating from supply of alcohol may occur after sale, where the alcohol is consumed or the consequences of its misuse felt. And it recognises that society and communities experience harm and have an interest in minimising it." (emphasis added).

SSDP believes it highly appropriate to refer to the observation of Clark J, in Medical Officer of Health (Wellington Region) v. Lion Liquor Retail Limited ("Lion Liquor"): "There is no presumption that an application for a licence will be granted ... $^{\prime\prime4}$

Also, we would cite the Hon. Simon Power, who stated that the changes implemented in the 2012 Act were intended to create a robust regime under which "licences will be hard to get and easier to lose."⁵

Furthermore, as ARLA has stated: "[W]hile there is no onus of proof on an Applicant, it does have an evidential burden and that it is for an Applicant to put its best foot forward if it expects a DLC to favour the application over opposition which is itself supported by evidence."

SSDP believes that the Applicant has been alarmingly presumptuous in announcing their new venue before their On-license has been granted, and in so has shown an utter disregard to the Purpose and Object of the Act, has brought alcohol control and regulation in Dunedin into disrepute, and has definitely not 'put its best foot forward' for their application to be granted.

In fact, the Applicant's actions have created tremendous discord among Dunedin's vulnerable student and youth community.

Based on the Applicant's actions reflecting a fundamental indifference and disrespect to the Act, to due process, and their apparent attempt to silence community voices by polarizing the student community, SSDP's researchers undertook extensive due diligence on the Applicant, including on their other operations. What SSDP has found has been extremely disappointing.

SSDP firmly and fully believes that on-licensed premises, including Student Bars, and Dunedin's live music scene, are essential elements to address the crisis of alcohol harm in Dunedin. This is more than just words for SSDP, and we have proven our commitment to this through providing Letters of Evidence in support regarding Extended Suitability for five well-managed, experienced, and responsible on-licensees in 2024. At every possible opportunity, we have amplified the voices of Save Live Music Dunedin, and spoken firmly to the City of Sydney research which identifies live music as one of the most effective alcohol-harm minimisation interventions we have available to us. SSDP is also actively supporting and engaging with Dunedin's on-licensed premises to ensure the upcoming LAP review is practical and supports our responsible and well-managed on-licensed venues as much as can be achieved.

SSDP is completely committed to bringing back safer and well-managed student bars. However, SSDP will not tolerate another 'Eleven Bar,' and simply cannot support any potential new student

bar when there is a clearly identifiable risk that the prospective licensee will make things worse for students.

Thereby, this objection is lodged on all the available grounds permitted on renewal under s105. of the Sale and Supply of Alcohol Act 2012 – but initially with (but not limited by) specific regard to:

- 1. The object of the Act sections 3 and 4 and 105(1)(a).
- 2. The suitability of the applicant, including the criterion of extended suitability s 105(1)(b).
- 3. Whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence – s 105(1)(h).
- 4. Whether the applicant has appropriate systems, staff, and training to comply with the law s 105(1)(j).

We will provide detail for the grounds of objection referenced above, along with information about any further grounds of objection, in opening submissions. Furthermore, SSDP will be calling on witnesses who will provide direct evidence to the grounds on which this objection has been filed.

 The activity is permitted in the zone and complies with the relevant rules in the Operative Dunedin City District Plan and the Proposed Second Generation Dunedin City District Plan.

Explanation

Operative Dunedin City District Plan

In terms of the Operative Dunedin City District Plan, the subject site is located within the Central Activity Area — Commercial Zone subject to requiring a verandah and adjoins Designation D454 being SH 1 - North Bound One-Way System. Great King Street is classified as a National Road within the District Plan's Roading Hierarchy.

Within this zone, licensed premises (defined as "...any land or buildings licensed under the licensed under the Sale of Liquor Act 1989") are a permitted activity pursuant to Rule 9.5.1(vi).

There have been no appeals on the relevant provisions of the 2GP in respect of this proposal, and so the 2GP is deemed operative for the assessment of this application.

Proposed Second Generation Dunedin City District Plan (2GP)

In terms of the Proposed Second Generation Dunedin City District Plan, the subject site is located in a Suburban Centre — Commercial and Mixed Use Zone. The subject site is also located within an Archaeological Alert Layer, a Hazard 3 (flood) Overlay Zone and the site adjoins a Primary Pedestrian Street Frontage Mapped Area on Albany Street. The site also adjoins Designation D454 being SH 1 - North Bound. Great King Street is classified as a Commercial Centre Road within the District Plan's Roading Hierarchy.

Within this zone, restaurants and ancillary licensed premises are a permitted activity pursuant to Rule 18.3.3.(10) and 18.3.3.(2).

Advice Notes

- This activity must comply with the performance standards for noise, glare and electrical interference outlined in the Operative Dunedin City District Plan and the Proposed Second Generation Dunedin City District Plan.
- New signage must comply with the rules set out in the Operative Dunedin City District Plan and the Proposed Second Generation Dunedin City District Plan, or else obtain resource consent. The alteration to any existing sign or the erection of a new sign may require resource consent.
- 3. This consent has been assessed under the Resource Management Act 1991, the Dunedin City District Plan and the Proposed Second Generation Dunedin City District Plan. It does not remove the need to comply with other legislation and Dunedin City Council regulations. These include the Dunedin City Council Local Alcohol Policy.
