#### **BACKGROUND**

- The Civic Affairs Committee provides oversight of the effective administration of Council governance, its activities and elected member procedures and protocols.

### **DISCUSSION**

**Council and Committee meetings** 


From July 2023 to the end of April 2024 Council held 15 meetings considering more than 142 reports. During the period, 11 committees and subcommittees held a total of 32 meetings. During these meetings 50 individuals and groups in public forum spoke on a variety of topics including zero carbon, cycleways, and support for the arts. Community boards and the Youth Council also briefed the Civic Affairs Committee.



#### **Engagement and Hearings**

- Council is required to consult with the public in a variety of ways, formally and informally. Since July 2023, Council received more than 1600 submissions on the Annual Plan, the Aurora Proposal, the Future Development Strategy, as well as the Gambling Bylaw and changes to parking restrictions.
- The following graph tracks the number of submissions received on the recent 10 Year Plan and Annual Plans.

- 7 Council and various hearings panels also provide a mechanism for people to present their views in public. Eight hearings (over 20 meetings, including the Future Development Strategy) in addition to those for the Annual Plan and Aurora, have been held since July.
- 8 Council also conducts hearings and decision-making meetings for several regulatory functions such as the District Licensing and Resource Management. The District Licensing committee held 22 separate meetings, some over multiple days and there were seven hearings held under the Resource Management Act.

#### Council Workshops

9 Over 50 workshops have been held on a variety of topics. Since mid-November Council has been giving notice of workshop topics to be held. Information is provided on the Council's website.

#### Community Boards

As part of the governance structure of Council, the community boards provide both an advocacy and decision-making function. The boards have connections with a variety of community groups in each of their board's area. Since July the community boards heard from over 50 groups or




individuals. Each community board is invited to brief the Civic Affairs Committee on matters of note in each Board's area.

Requests under the Local Government and Official Information Meetings Act (LGOIMAs)

- Since 2020 staff have reviewed processes for responding to LGOIMAs and provided training and guidance across the organisation to assist in improving the response time. This has also included a checklist which is completed for each LGOIMA. We continue to review our processes.
- The activity report to be presented in November 2024 will also include annual statistics on the number of complaints to the Ombudsman.
