5 BEAUTY THERAPISTS, TATTOOISTS AND SKIN-PIERCERS BYLAW REVIEW - RESULTS OF CONSULTATION

Cazna Savell (Compliance Solutions Manager – Acting), Tanya Morrison (Team Leader Environmental Health and Alcohol Licensing) and Anne Gray (Policy Analyst) spoke to the report and responded to questions.

In a report from Customer and Regulatory it was advised that on 17 September 2024, the Customer and Regulatory Committee resolved to commence a review of the Beauty Therapists, Tattooists and Skin Piercers Bylaw and on 11 March the Committee approved a draft Bylaw and statement of proposal for consultation.

38 submissions were received during the consultation period, and there were no submitters who wished to be heard.

Tanya Morrison provided an overview of the review and responded to questions.

Following discussion it was agreed that the proposed changes be accepted.
