EXECUTIVE SUMMARY

- 1 This is a report for an application by Samgan Limited for the renewal of an off-licence for "Leith Liquorland", situated at 233 Leith Street, Dunedin. The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) apply to this application.
- 2 The applicant does not seek any changes to the licence.
- 3 Public notice of the application attracted one public objection.
- 4 The Medical Officer of Health Delegate has opposed the licence renewal. The Police submitted an interim opposition but has not followed this up with a formal opposition report. The Licensing Inspector has not opposed the application.

APPLICANT AND APPLICATION

- 5 The Applicant company, Samgan Limited, has a single director and shareholder, Mr John Hart. The premises has been operated by the Applicant since 2012. There has been no opposition to licence renewals in the past.
- 6 The premises is situated in the North Dunedin student flatting area and has licence hours of Monday to Sunday, 9.00 am to 10.00 pm. The premises is designated a supervised area.

7 No suitability issues have been raised regarding the Applicant.

PUBLIC NOTICE

- 8 Public notice of the application attracted one public objection.
- 9 The Medical Officer of Health Delegate has opposed the application. The Police submitted an interim opposition but this has not been followed up by formal opposition.
- 10 The Licensing Inspector has not opposed the application but does suggest that an earlier closing time would be a proactive step in achieving the object of the Act.

OBJECTIONs

Public Objection

- 11 The public objection received was from Mr Bede Crestani. Mr Crestani does not reside in Dunedin but he supports a safer environment in Dunedin through the Sophia Charter for Community Responsibility and Wellbeing.
- 12 Mr Crestani would like to see:
- 13 The premises shutting at 9.00 pm daily. He refers to data supplied by the Medical officer of Health relating to the emerging data showing the effects of excessive alcohol consumption through admissions to the Dunedin Public Hospital Emergency Department and the peaks during specific university related events. Mr Crestani said he would like to see all off-licence premises in North Dunedin close at 9.00 pm as they come up for renewal so there was a level field.
- 14 A ban on the sale of alcohol in glass. He states that broken glass in the North Dunedin streets was unacceptable and would not be tolerated in other cities. He acknowledges some customers value alcohol in glass and use it responsibly which would 'complicate' the simplistic removal of products in glass.
- 15 Mr Crestani acknowledged the Applicant was a responsible operator and that they actively promote cans over glass bottles.

Medical Officer of Health Delegate

- 16 The Medical Officer of Health Delegate has opposed the renewal and makes the following points:
- 17 There is increased alcohol-related harm with extended trading hours. Studies have found that reducing the availability of late night off-licence sales is associated with lower consumption levels, reductions in hospital admissions for alcohol intoxication, especially for young people, and a reduction in road crashes.
- 18 North Dunedin has amongst the highest rates of alcohol-related Emergency Department admissions in Dunedin.
- 19 Suitability of the Applicant and premises is questioned with their request to retain their current trading hours. Trading until 9.00 pm would be more suitable for this community. The Applicant



has a responsibility to operate in a way that minimises harm and supports responsible alcohol consumption.

CONCLUSION

- 20 This application is for the rollover of the current conditions.
- 21 The public objector acknowledges the Applicant is a responsible operator but would like to see a reduction in trading hours to make the North Dunedin environment safer. The Inspector also stated there were no suitability issues.
- 22 The Police did not follow-up their interim opposition, but the Inspector noted that they were intending to oppose the application.
- 23 The Medical Officer of Health Delegate has opposed the application to get the closing time brought back to 9.00 pm.
- 24 The Dunedin Local Alcohol Policy is still current and will remain so until the review is completed.



HOST AND SOCIAL RESPONSIBILITY POLICY

Our objective is to meet all host responsibility requirements and legal prerequisites of the Sales and Supply of Alcohol Act 2012 (the Act) and its subsequent amendments along with local council social responsibility through correct practise and enforcement of systems in our environment.

Systems and Practise

We will adhere to all conditions and requirements as detailed in our Off-Licence

Our Off-Licence has a supervised designation. Minors are not admitted on to the premises unless accompanied by a parent or guardian.

We will not sell alcohol including remote sales or delivery to any intoxicated person. Should a person be seen to exhibiting signs of intoxication a Duty Manager will be called to carry out an assessment using the Speech, Co-ordination, Appearance and Behaviour criteria and if deemed to be intoxicated then the person will not be served.

We will not sell or supply alcohol including remote sales or delivery to any person under the age of 18 years old.

If any doubt whatsoever arises over a customer's age, an evidence of age document as prescribed by the Act must be provided ie NZ Passport or Overseas Passport, a Driver's Licence issued under the Land Transport Act 1998 (photo drivers licence) a Hospitality 18+ Card (valid 10 years from date of issue) or Kiwi Access Card document. If a customer looks under 30 years of age, ID will be requested and signage will be displayed advertising this. If staff identify a minor trying to purchase alcohol they will be refused and a duty manager will be called to assist if required.

Appropriate training by holders of Managers Certificates for the responsible sale of alcohol and all requirements of the Act will be undertaken all staff. Staff will receive refresher training on a regular basis and records will be kept on the premises of these details.

A holder of a Manager's Certificate or a correctly appointed temporary/acting manager will always be on duty when alcohol is available for sale.

We will display clear signage throughout the premises relating to the non-serving of minors and intoxicated persons. Promote the safe and healthy use of alcohol. Comply with all advertising and promotional restrictions under the Act.

Always provide non alcoholic beverages and regularly promote low alcohol beverages.

Be aware at all times of the activities of our customers within our premises.

No delivery or remote sales between 11pm and 6am.

Comply with local council external signage requirements.

Maintain a safe and tidy environment by regularly checking on noise, litter, or any anti-social behaviour around the exterior of the store.

Always provide management support & training for staff to carry out this policy effectively.

On busy trading days / periods we operate a FREE Sausage Sizzle that is available regardless of purchase in our establishment. We have also sub-leased a section of our floor area to a fresh fruit & produce retailer & actively encourage our patrons to pop next door to get their fresh fruit & vegetable fix.

- 4. Steps we take to prevent the sale & supply of alcohol to prohibited people are:
 - a. At SAMGAN Liquorland we have an Under 30 I.D policy. We are vigilant in the enforcement of this & it is an expected part of our selling process. This is a voluntary minimum age for entry condition. All other Liquorlands are U25.
 - b. Intoxication is also not tolerated and anyone we suspect to be under the influence will either be refused entry or closely observed. If we believe them to be intoxicated we will refuse service if we have not asked them to leave the premises prior to this point being reached.
 - c. In terms of other prohibited persons, we routinely trespass nuisance persons & uphold the conditions of those trespass notices.
 - d. All members of groups are asked for ID, if not present with all in the group service will be refused to all.
 - e. If one person in a group is deemed to be Intoxicated service is also refused to all.
 - f. If noticed, persons sitting in cars in our carpark will also be asked for ID or proof of age to allow those in the store to purchase.

5. The other steps we take to promote responsible consumption of alcohol:

- a. As purchase of alcohol occurs at our establishment to be consumed off site, we have a small window of opportunity to encourage purchase of food items. However, our staff are trained in up-selling chips, nuts, jerky & other food items. We also encourage patrons to pop next door to Vege Boys & down the road to The Flying Squid.
- b. b. A large number of sku's that we stock & sell are can or plastic products as requested by the DLC & The Police.
- c. c. Our large range of non & low alcoholic products available is also aimed at giving people the choice not to make their night a big one. We also actively encourage our customers to add a mixer to their spirit choice.
- d. Our staff our also encouraged to converse with customers as a means of ascertaining intoxication levels & then take the appropriate steps of refusal of service or removal from our store.
- e. Liquorland has also actively engaged in "Free" piazza promotions on a number of occasions. Liquorland Leith specifically gave away 2732 'Free' Pizzas during one 2 week period last year.
- f. We have also increased our range of can & plastic products available for sale at the request of the DLC & The OUSA, The Police & Health South.
- g. We do not sell single shots or cans, (craft beer & cider being the exception) in working with the DCC upon requested.
- h. We currently supply to Toitu (DCC Owned Venue) in supplying to local & international events & we upheld the same standards in terms of Intoxication.

- Prior to key events in the city we also increase the presence of all of our Can & PET lines to ensure we are abiding by the act.
- j. ALL 3 of our sites actively respond to Dunedin police requests for CCTV footage when asked (at our own cost of USB sticks) for the purpose of eradicating crime.

Other Matters:

- 1. Ensuring compliance with the Act:
 - a. We display all alcohol responsibility signs prominently as required to by law!
 - b. We also have a strict no open vessel policy in the area immediately outside our venue.
 - c. Our intent is to 'Responsibly provide our customers with the means to a good or great night, not a dangerous or crazy one. We insist our customers consume alcohol responsibly.
 - d. Our staff do a daily rubbish run (all gutters & street rubbish relating to alcohol & food is collected up & disposed of appropriately).
- 2. Training we provide to staff to ensure compliance with the Act is:
 - a. We have an internal Liquorland training program called 'Red Seed' that covers, amongst other things, all elements of the SOLA 2012, and this training is compulsory for all staff members working in our establishment.
 - b. Foodstuffs 'Redseed' is also a certified provider of LCQ Training & all staff are offered it at our expense after 2 solid years of employment.
 - c. We have frequent staff meetings and lines of communication where all staff are encouraged to ask questions in particular regarding the SOLA 2012 & our role as a liquor retailer.
 - d. We also run all staff through Age Compliance Training and have an age compliance Induction guide that is presented to all employees upon joining our staff. (See Attached)
- 3. Other Systems we have in place to ensure compliance with the act:
 - a. We operate an incident book where all events are recorded for customer & staff benefit.
 - b. We adhere to our National Banner advertising that is vetted by LAP's & do not 'undercut' any promotional price point.
 - c. A holder of a Managers certificate or Acting/Temporary manager will be on Duty whenever alcohol is available for sale.
 - d. We have systematically increased the range of can & PET products available for sale. This was a direct response to a request by the Dunedin Alcohol Partnership, Dated 24 December 2013.
 - e. We also DO NOT sell single cans or shots in conjunction with the DCC & The Police.
 - f. We removed all Nitro 1.5L from our premises a number of years ago due to health concerns.
 - g. No ID NO Service (regardless of item chosen to be purchased). We are now an U30 ID Site at our own doing.



Risk Mitigation Report in support of Samgan LTD (Trading as Leith Liquorland) application for renewal of Premise Liquor Licence.

The Steps we take to mitigate ANY risk to the local community are:

- 1. We do not promote alcohol that exceeds 25% discount off our usual RRP.
- 2. Our premises do not operate any later than 11pm
- 3. We are NOT at risk of ever being a nuisance in terms of noise.

If staff identify a minor trying to purchase alcohol they will be refused and a duty manager will be called to assist if required.

Inspector's comment

This report is prepared for the District Licensing Committee's consideration. The operator is very active in engagement, and communication with the agencies.

During the onsite interview, when it was raised that provided procedures (within the application) were somewhat generic across the applicant's tri-businesses, and out of date details wise in places, the applicant actioned this by updating and re-submitting this information.



This premises is located adjacent to the University of Otago campus, therefore is known to be highly frequented by students. This premises is also located within an area of high rubbish, however the applicant has good systems in place for addressing, and proactively removing any rubbish surrounding their premises.

The licensing hours sought were discussed at length with the applicant and the agencies. The applicant currently has licensing hours until 10pm, which all agencies would like to see pulled back to at least 9pm. Reducing hours is seen as one mechanism to directly reduce alcohol related harm – availability leads to consumption; consumption leads to harm.

The applicant has appeared wiling to consider reduced hours, however, is concerned about consistency amongst all Off-Licensed premises, and not wanting to be penalised essentially with shorter hours, compared to other Off-licensed premises.

With the current review of Dunedin's Local Alcohol Policy (LAP), it is unknown currently where this policy will land in the future in terms of guiding the committee to a blanket end licensing time for all off-licences premises that will see reduced hours for all premises.

Communication received on 7 April 2025 from external lawyers suggests the previous LAP continues to be in effect, therefore this still acts as a guiding document for the committee to consider.

I raise no matters towards the applicant's suitability for the committee but believe reduced licensing hours until 9pm would be a proactive step, to further uphold the object of the Act in the safe and responsible sale and supply of alcohol, with regards to further minimising alcohol related harm is a known high-risk, high-alcohol related harm area.

I do not oppose this application.

Opposition to the Renewal of an Off-Licence for Leith Liquorland

Introduction:

This submission is presented in **opposition** to the renewal application submitted by Leith Liquorland, which seeks to maintain its current trading hours, closing at 10pm. The Medical Officer of Health requests a reduction in trading hours from 10pm to 9pm. We support this request for a reduction, as we believe it aligns with the objectives of the *Sale and Supply of Alcohol Act 2012* (the Act) and is necessary to reduce alcohol-related harm in the community.

Relevant Provisions of the Sale and Supply of Alcohol Act 2012 (NZ):

The Sale and Supply of Alcohol Act 2012 provides a legal framework that aims to reduce alcohol-related harm, ensure the responsible sale and consumption of alcohol, and promote public health and safety. The following provisions of the Act are particularly relevant:

- 1. Section 4 Purpose of the Act: The purpose of the Act is to:
 - Ensure that the sale, supply, and consumption of alcohol are undertaken safely and responsibly.
 - Prevent the harm caused by the excessive or inappropriate consumption of alcohol.
- Section 5 Objectives: When determining alcohol licence conditions, the

Act requires that the licensing authority consider:

- $_{\odot}$ The harm caused by alcohol consumption, including crime, injury, and health problems.
- Ensuring that alcohol is sold and consumed in a manner that minimizes the risk of harm to the community.

3. Section 105 – Licensing Objectives: The licensing authority is required to determine whether a licence should be granted, renewed, or amended, taking into account factors such as:

- The object of the Act to minimize alcohol-related harm.
- The suitability of the applicant and the premises.
- The level of alcohol-related harm in the locality and the potential for further harm.

Grounds for Opposition:

1. **Increased Alcohol-Related Harm with Extended Trading Hours:** The extension of trading hours until 10pm increases the potential for excessive alcohol consumption, particularly later in the evening. Studies have found that reducing the availability of alcohol late at night for off-licences is associated with lower consumption levels, reductions in hospital admissions for alcohol intoxication, especially for young people, and reductions in road crashes and alcohol-related injuries.¹ A reduction in trading hours, as requested by the Medical Officer of Health, from 10pm to 9pm, would reduce the availability of alcohol late at night and is consistent with the Act's objectives to minimize alcohol-related harm.

By closing earlier, Leith Liquorland would limit opportunities for alcohol consumption that contribute to higher risks of harm, thereby promoting a safer environment for the community.

2. Evidence of Alcohol-Related Harm in the Locality: North Dunedin has amongst the highest rates of alcohol-related Emergency Department presentations in Dunedin. The Sale and Supply of Alcohol Act 2012 allows licensing authorities to consider existing levels of alcohol-related harm in the locality. Evidence shows that late-night alcohol sales are linked to higher rates of binge drinking, public disturbances, and accidents, particularly in communities that are already experiencing alcohol-related harm. Extending trading hours beyond 9pm in these areas can exacerbate existing problems.

The Medical Officer of Health's request to reduce trading hours aligns with the harm-reduction principles outlined in the Act. By restricting the availability of alcohol, the risk of harm-such as alcohol-fuelled violence and emergency department admissions-would be reduced.

3. Suitability of the Premises and Applicant: Under Section 105 of the Sale and Supply of Alcohol Act 2012, licensing authorities must consider the suitability of the applicant and the premises, as well as the level of alcohol-related harm in the locality. The applicant's request to maintain trading hours until 10pm is inconsistent with the goals of the Act, particularly when the community is already experiencing significant harm related to alcohol consumption.

Reducing the trading hours to 9pm would be more suitable for the community, especially considering the negative impact of late-night alcohol availability on public health and safety. The applicant has a responsibility to ensure the premises operate in a way that minimizes harm and supports responsible alcohol consumption.

Conclusion:

Granting Leith Liguorland's request to maintain trading hours until 10pm would be inconsistent with the Sale and Supply of Alcohol Act 2012, particularly in relation to the Act's focus on minimizing alcohol-related harm. We respectfully request that the licensing authority impose a reduction of trading hours to 9pm, as this would better align with the harm-reduction principles of the Act and contribute to ensuring the responsible sale and consumption of alcohol in our community.

Reason for Objection

Closing hours

Data shows that longer opening hours creates more unsafe drinking and harm as a result. We propose that the store closes at 9pm.

Refer to research from Dr Michael Butchard, Medical Officer of Health, National Public Health Service, Southern.

Data is emerging showing the effects of excessive alcohol consumption, through admissions to the hospital emergency departments, and the peaks during university term time. It also shows peaks during specific university related events and days of the week.

Reducing access to alcohol will contribute to a safer environment, and reducing closing time to 9pm is likely to be a worthwhile change. We would welcome data collection which proves, disproves or provides an alternative view.

Glass

There is a significant problem with broken glass in North Dunedin and it is an issue we have wanted to end for 5.5 years. Broken glass in the street would not be tolerated in any other suburb of NZ and it should not be tolerated in Dunedin either. It is both an indicator of a bigger problem and a problem in its own right. It is an issue that DCC, the University, Police and others in the community have tried to address, however the first step should be to remove the problem at source, along with holding those who break glass responsible.

We appreciate that there are other customers who value alcohol in glass and use it responsibly, which complicates the simplistic removal of glass.

Operator comment

The key issue is for all suppliers, retailers and national representative organisations to be responsible for the harm created by their products and take charge of usage, so that it is used responsibly. We ask that they engage in ways to reduce alcohol related hospital admissions and eliminate broken glass in North Dunedin.

We understand that Leith Liquor is a responsible operator and is reasonable in the way it operates. We recommend that the opening hours are reduced to 9pm and that the same conditions are placed on other liquor outlets as they come up in North Dunedin, to provide level conditions for all operators.

We appreciate that Leith Liquor take proactive steps to sell cans over bottles.
