

#### **EXECUTIVE SUMMARY**

1 This report covers activities of Toitū Otago Settlers Museum (Toitū) from 1 April to 30 June 2025.

#### **BACKGROUND**

This report is prepared for the Toitū Otago Settlers Museum Board meeting and details the latest activities and KPI performance at Toitū.


#### **DISCUSSION**

#### Visitation

Toitū recorded 58,629 visitors this quarter, representing a 23% decrease compared with the same period in FY 23/24. The overall visitation for the financial year was 301,140, representing a slight 3.5% decrease on the previous financial year. The annual visitation total exceeded the level of service target of 250,00 visitors.

#### **COLLECTIONS AND EXHIBITIONS**

#### **Exhibitions**

#### New displays

In the next quarter the team will be installing an extensive changeout in the Creative Dunedin space featuring the story of Shona Dunlop MacTavish MBE (1920-2019) dancer, teacher, choreographer and pioneer of liturgical dance, often referred to as 'the mother of modern dance in New Zealand'.

#### Maintenance of permanent exhibits

- The Exhibitions and collections team continuously maintain the quality of the permanent exhibits at Toitū, this work includes the following:
- Audio Visual (AV) touchscreens: All of the digital label rail screens across Toitū have now been replaced.
- Lighting renewals: This reporting period we took delivery of a range of new light fittings as part of a project to renew the exhibition lighting. The technical team have begun a gradual roll out of new light fittings in the permanent displays.

#### Permanent exhibition updates

- Portraits: A project is underway to create a single, authoritative catalogue for the entire portrait collection at Toitū. The outcome will be a new, searchable online database, along with updated content in the Smith Gallery, including full biographies for all portraits on display.
- 9 First Great City and Gold: The team is undertaking a refresh of the object displays in these galleries. This includes the installation of a revolver that was acquired several years ago, now able to be displayed following compliance with updated firearms licensing regulations.



- 1925 New Zealand and South Seas International Exhibition: Planning is underway for a changeover of objects in this small exhibition area. A replica of the original exhibition's entry arch will be installed as part of the refresh. The team has partnered with the Audience Engagement Team to develop a programme of public talks, aligned with this year's Heritage Week theme.
- 11 Foyer Immersive Project: In July we held a very successful two-day wanaka with the content producers and mana whenua. The concept draft has been established and production is now underway. We anticipate opening the new ticketed attraction in the summer.

#### Short temporary displays

"The Craft": an exhibition about Freemasonry in Dunedin, is currently under development, and will be installed in the temporary display in the Transport and Technology from September 2025.

# **Collections**

#### Acquisitions

17 This reporting period 10 donations were accessioned into the collection. Highlights include Cadbury Cookie Bear ephemera transferred from the Hocken library as a complement to our existing Cadbury collection; and the wedding outfit of Deidrichs-Fox from The Big Day exhibition of wedding outfits on display 2022-2025.

# Collections support of exhibitions

The Collections team continue to support exhibitions: arranging loans, organising quarantine processes and condition reporting and carrying out conservation preservation processes on objects for display.

#### Collections projects

- Asbestos Remediation: The team continues to test and remediate objects when they are required for retrieval for access or display. We continue to work with the DCC Property team on the offsite store at Parry Street, as time and current resource levels allow, to remediate the building itself which is asbestos contaminated and then move into object testing.
- 20 Collection Development: A specific focus recently has been on the costume holding, with the rehousing of the shoe collection following the completion of a significance report by Dr Jane Malthus. The team has created special card containers for our shoes and are currently working through rehousing these into the new drawers recently purchased with a grant from



Environment Lotteries and Heritage. A preliminary assessment of the significance of the dress collection has also been completed.

#### Conservations projects

- The Conservator condition reported three loan renewals. 32 objects selected by the curatorial team for "The Craft" have now been conserved and prepared for display.
- 22 Microdot fading research project: We are currently waiting for a report from colleagues at University of Otago for the microdot fading test carried out on the Thomas Burns book. This will enable us to better understand how display lighting may affect the ink pigment, and therefor make accurate assessments about caring for this object whilst on display.

#### **Archives**

Collections and Exhibitions staff processed 50 public enquiries, 49 by email/correspondence and one through physical visiting. The majority of these were collection based, followed by photograph orders through the research centre. This demonstrates that genealogy enquiries are being well-handled through the Research Centre and the OASES database.

#### **AUDIENCE DEVELOPMENT**

# **Enriching Local Curriculum (ELC) – Education**

24 Education themes explored through the Enriching Local Curriculum (ELC) programme across this reporting period for early childhood, primary and secondary ākonga included immigration, colonisation, general museum exploration, the growth of Dunedin, communication, kai tahu and early Dunedin life, Anzac Day, navigation, Otago gold mining, school life and games during the 1950's and 60's, food production, the Toitū Stream trail, and Te Tiriti o Waitangi.

## **Visitor Programmes**

- During this reporting period, our program of public talks featured a variety of speakers. These included Toitū Registrar Beth Rees on her work with textiles in the Toitū Collections, a presentation on the kaitiaki of the Eden Hore fashion collection in support of the Costumes and Textiles Association NZ annual symposium, Anna Campbell, the newly appointed general manager of the Yellow Eyed Penguin Trust, and Malcolm Deverson, speaking about his recently published book on the life of Les Lockerbie.
- The April School holiday offerings had a gold, rocks and minerals theme and included gold panning workshops, an interactive theatre performance about life on the goldfields, a gallery trail, and for the adult audience, a talk on Otago's Golden Heritage with Sean Brosnahan and Hamish Blakemore, Manager Geology and Exploration at OceanaGold.
- Toitū hosted just under 500 people for tea, coffee, and Anzac biscuits on Anzac Day, followed by a well-attended performance by the Red Cross Choir at 10am. Alongside that, close to 200 remembrance crosses were completed by visitors in the lead up to Anzac Day, who also engaged with the recently upgraded Roll of Honour interactive display.
- In celebration of International Dance Day, Toitū hosted a full day of community dance sessions with Dance Ōtepoti, and in support of NZ Music Month, developed a programme of popular music sessions each Sunday. Offerings featured weekly 'open piano' opportunities, led by pianist Jeff Cheshire, and performances by local musicians and choirs.



In recognition of International Museum Day, the team hosted a variety of activities throughout the building targeted at the family audience, including a photo booth, workshops, trails, and music.

#### **COMMERCIAL ACTIVITY**

#### Retail

- 30 The retail shop at Toitū had buoyant sales over the reporting period.
  - April 2025 \$38,900 (inc. GST) increase of \$21,076 on April 2024
  - May 2025 \$22,000 (inc. GST) increase of \$9,131 on May 2024
  - June 2025 \$15,859 (inc. GST) increase of \$4,363 on June 2024
- 31 A particular highlight of the quarter is sales of the Eden Hore publication *Central Otago Couture* which supports the *Eden in Dunedin* Exhibition. 85 copies were sold at the opening of Eden Hore/ID opening/Book Launch event on 1 April. Over the three month reporting period 232 copies have moved. This is one of the shops best-selling books since reopening in 2012.
- Additional lines were also purchased from Central Otago District Council that relate to the Eden Hore exhibition notebooks, postcards and small books featuring different areas of Central Otago.
- June 30 marked the end of the financial year and the team are very pleased with revenue through the shop for 2024/2025 year. Total sales have been \$330,300 (inc. GST) or \$287,479 (exc. GST) against a target of \$200,000 (exc. GST). Revenue has also increased by \$15k on last year. Total item quantity sold: 24,700. Spend on stock has increased to match the increased sell through.
- 34 End of financial year processes have been completed smoothly which involves three shop stocktakes and other financial administration tasks.
- The focus for the months ahead will be product development, restocking and purchasing for the next six months. The commercial manager will attend the gift fair in Auckland in late August to ensure we stock the best products and keep abreast of current trends.

#### **Functions and Commercial Events**

- 36 15 private venue bookings were held at Toitū 1 April 30 June 2025.
- 37 Toitū hosted the opening of *Eden in Dunedin* exhibition/ID opening/Book Launch event on 1 April which was a major highlight. It was terrific to bring the three events together to celebrate all things 'fashion' in Dunedin.
- Toitū hosted the CTANZ (Costume and Textile association of New Zealand) symposium 1-3 May a large multiple day/space event. The team trialled using the temporary gallery as a venue space (aptly named the T&T Annex) for the secondary stream of talks which worked well and the research centre was used for food and beverage. In addition, the attendees had group entry rates to Lan Yuan and a separate talk at DPAG featuring the NOM\*d exhibition.



The commercial manager and manager at Olveston attended MEETINGS 2025 the industry Business Events trade fair in Auckland in mid-June. Four properties were promoted – Toitū, Lan Yuan, DPAG and Olveston to prospective functions and events clients across Australasia, meeting with 25 buyers over two days. There was good interest in bringing conferences and events South to Dunedin and we hope to benefit from this over the next few years.
