1 PUBLIC FORUM

1.1 Public Forum - Johannah Horrell

Ms Johannah Horrell thanked the Board for funding to support her participation in an Outward Bound course. She said it had been a life-changing experience that enhanced her teamwork and leadership skills.

Ms Courtney Smith spoke to her application for funding to support her participation in the 2025 Sport Aerobics World Championship. She detailed the fundraising efforts she had undertaken since qualifying to represent New Zealand in August this year.

Teresa Christie spoke on behalf of the Taieri Network regarding the Network's funding application for A Very Taieri Christmas 2025, noting that last year's event was the largest ever and this year's would continue to grow. 6 PROJECT FUND

Consideration was given to funding applications from:

- a) the Taieri Network Charitable Trust for \$2,000 towards A Very Taieri Christmas 2025; and
- b) Ms Courtney Smith for \$1,000 to support her participation in the 2025 Sport Aerobics World Championship in Prague.

Both applications were thought to have merit. Given that this was the last meeting before a new Board would be elected, the Board was conscious of spending in proportion to the period of the financial year elapsed (around 25%).

There was discussion about targeted rates. Andrew Simms undertook to write to the ORC about a perception that an underspend in Outram's targeted rate might not be spent in the community.

- 1 **Taieri Network** Kathryn Anderson said that she had enjoyed working with a grassroots organisation like the Taieri Network and hoped its work would continue.
- 2 **Coronation Hall Trust** Dean McAlwee advised that he will stay on as a Trustee of Coronation Hall and he hoped the next Board would appoint another Trustee.
- Mosgiel Taieri Community Resilience Group (formerly Mosgiel and Taieri Emergency Group) Andrew Simms informed Members that the Mosgiel Taieri Community Resilience Group was developing a new community resilience plan and had applied for civil defence funding from the government. He considered it essential for the next Board chair to participate in the Group.
- Social Media/Media Platform and Community Engagement Regan Horrell advised that he was producing a video about work on the Silver Stream and would promote the "Meet the Candidates" event to be hosted by the Taieri Network on the Board's facebook page.
- 5 **Taieri Trails Group** Andrew Simms noted that the Taieri Trails Group would like a representative from the next Board to join it. Dean McAlwee reported that community members had undertaken extensive work on the Outram Loop Track, which he hoped would open next summer.
- 6 **ORC Lower Taieri Liaison Group** Andrew Simms commented on the wonderful news that work to restore the capacity of the Silver Stream was underway, and said it would be vital for the next Board chair to be a member of the ORC Lower Taieri Liaison Group.

7 **Community Board Executive Committee** – Regan Horrell informed Members that members of the Community Board Executive Committee would remain in post until February 2026 to ensure a smooth transition. He hoped the "Better Together" report would empower the next Mosgiel Taieri Community Board.
