EXECUTIVE SUMMARY

- This is a report for an application by JV Bars Limited for new on and off-licence for the premises situated at 2 Prince Albert Road, Dunedin, and known as the "St Kilda Tavern". The criteria found at section 105 of the Sale and Supply of Alcohol Act 2012 (the Act) apply to this application.
- The applicant is seeking on-licence hours of Sunday to Thursday, 10.00 am to 12.00 midnight, and Friday and Saturday 10.00 am to 2.00 am the following day. They are seeking off-licence hours of Monday to Sunday, 10.00 am to 10.00 pm.
- 3 Public notice of the applications did not attract any public objections.
- The Police, Medical Officer of Health Delegate, and Chief Licensing Inspector have opposed the grant of the licences.
- The underlying licences for this premises have been renewed to allow continued trading until these matters have been heard.

APPLICANT AND APPLICATION

Applicant



- The applicant company has a single director, Vishav Singh, and equal shareholders, Vishav Singh and Jaspal Singh. The company was registered in May 2025.
- The premises has been licensed since the 1870s. It now comprises a gaming lounge, public bar and garden bar. The first floor has been used as a dining room in the past and may be used for this purpose in the future. Off-licence sales occur over the bar.
- 8 The Applicant is seeking a restricted designation for the gaming room and every bar to be supervised.

PUBLIC NOTICE

- 9 Public notice of the application did not attract any public objections.
- The applications were circulated to reporting agencies and they have all opposed the grant of the licences.

Opposition

- 11 The Police have opposed the applications for the following reasons:
 - a) The object of the Act: the premises is located in a residential zone that is an area of high deprivation and at high risk of alcohol-related harm. The premises is on a major intersection of arterial routes which makes it attractive to people travelling along these routes.
 - b) Suitability of the Applicant: one of the shareholders failed to disclose convictions and previous involvement with the Police. Mr V Singh will reside locally but inquiries revealed he is still employed by Woolworths at a Christchurch store. Their experience operating premises also appears to be lacking.
 - c) Amenity and good order: Police are frequently called to alcohol-related incidents in an 800m radius of the premises. While there is no causal link between the premises and the incidents, caselaw indicates there does not need to be that link. The premises location is sufficient to suggest alcohol from the premises may be one of the causes of the harm.
 - d) Days and hours: when Police consider the harm in and nature of the location, they suggest the location of the premises means the hours are excessive.
- The Medical Officer of Health Delegate has opposed the application for similar reasons as the Police but also has concerns about whether the Applicant has appropriate systems, staff, and training to comply with the legislation. During interviews they Applicant could not answer all of the questions put to them adequately and the applications lacked some detail.
- 13 The Chief Licensing Inspector's concerns include:
 - a) Lack of experience of Mr V Singh. The experience he does have appears to be in an off-licence premises only.
 - b) Mr V Singh's employment by a Woolworths store in Christchurch. He has not resigned from that employment but is now resident in Dunedin.



- c) Mr J Singh did not disclose all relevant convictions and Police interactions. These appear to be alcohol related therefore his suitability must be questioned.
- d) Discrepancies between the shareholder's descriptions of how the premises will be operated.

CONCLUSION

- 14 This premises has been the subject of several objections in the past two years. The underlying licence for the premises has been renewed to allow time for the applications by JV Bars Limited to be determined.
- 15 This hearing provides an opportunity for the parties to present their positions to the Committee.























St. Kilda Tavern - Mitigation Report

The tavern has been operating as licensed premises from the same building since 1875 and has thus come to be seen as a community neighbourhood tavern. The patronage is predominantly of a middle aged and upper clientele, mostly employed in the immediate and South Dunedin area and thus has created its own "target" market, if there were to be a "target" market at all. As such the nature of the clientele does not lend itself to negative behaviour such as loitering or vandalism. In the last twenty years of current management, there has been little if at all attention required from the licencing authorities or the police.

With regards to any near housing, any sound from the premises is generally contained within the premises due to wall thickness and as the premises supplies its own car park, neighbourhood car parking is not impinged upon. Opening hours are generally sociable in that, while currently licenced to operate to 2.00.a.m. on a Saturday night, service generally winds down from midnight. And in general, the aim is to close around 1.00.a.m of the Saturday night. Earlier on all other nights. As we wind down service from an hour before closing times, patrons are able to disperse over an extended period, thus not putting undue pressure on available transport operators, nor putting a large group of patrons on the street at one time. We also encourage and will arrange, as per our Host Responsibility, safe transport options.

There is amplified music on a Saturday night which ceases at mid-night and noise containment is again as the above plus that any outside doors to courtyards, etc. are kept closed after 11.00.p.m.

There are two churches on corners across from the premises, two separated by at least one corner building. The premises, having been established in 1875, pre-date the churches, one of which decided to establish itself across the road only in the last four years. The has never been any discourse from these church bodies.

The premises and management actively supports and upholds Host Responsibility as per our Licence Renewal Application. Also, the nature of the premises and clientele does not require active security measures other than staff vigilance, although on Saturday nights because of a larger patronage, a security person is present.

Advertising is minimal other than "naming" signage on the building and once weekly advertising in the newspaper as to Saturday night entertainment.

With regard to the tavern's Off Licence, a bottle shop or liquor store with separate premises or street front positioning with associated advertising is not involved. Rather sales are mostly limited to beer as a take out across the bar – spirits and wines are not stocked for Off Licence sales, such spirits and wines being stocked for on premise consumption. As such, compared to other off licence premises, the impact of this Off Licence in the local area is minimal.







The patronage is predominantly of a middle aged and upper clientele, mostly employed in the immediate and South Dunedin area and thus has created its own "target" market, if there were to be a "target" market at all. As such the nature of the clientele does not lend itself to negative behaviour such as loitering or vandalism. In the last twenty years of current management, there has been little if at all attention required from the licencing authorities or the police.

With regards to any near housing, any sound from the premises is generally contained within the premises due to wall thickness and as the premises supplies its own car park, neighbourhood car parking is not impinged upon. Opening hours are generally sociable in that, while currently licenced to operate to 2.00.a.m. on a Saturday night, service generally winds down from midnight. And in general, the aim is to close around 1.00.a.m of the Saturday night. Earlier on all other nights. As we wind down service from an hour before closing times, patrons are able to disperse over an extended period, thus not putting undue pressure on available transport operators, nor putting a large group of patrons on the street at one time. We also encourage and will arrange, as per our Host Responsibility, safe transport options.

There is amplified music on a Saturday night which ceases at mid-night and noise containment is again as the above plus that any outside doors to courtyards, etc. are kept closed after 11.00.p.m.

There are two churches on corners across from the premises, two separated by at least one corner building. The premises, having been established in 1875, pre-date the churches, one of which decided to establish itself across the road only in the last four years. The has never been any discourse from these church bodies.

The premises and management actively supports and upholds Host Responsibility as per our Licence Renewal Application. Also, the nature of the premises and clientele does not require active security measures other than staff vigilance, although on Saturday nights because of a larger patronage, a security person is present.

Advertising is minimal other than "naming" signage on the building and once weekly advertising in the newspaper as to Saturday night entertainment.

Also, the nature of the premises and clientele does not require active security measures other than staff vigilance, although on Saturday nights because of a larger patronage, a security person is present.

Advertising is minimal other than "naming" signage on the building and once weekly advertising in the newspaper as to Saturday night entertainment.

With regard to the tavern's Off Licence, a bottle shop or liquor store with separate premises or street front positioning with associated advertising is not involved. Rather sales are mostly limited to beer as a take out across the bar – spirits and wines are not stocked for Off Licence sales, such spirits and wines being stocked for on premise consumption. As such, compared to other off licence premises, the impact of this Off Licence in the local area is minimal.

Inspector's comment

This report is prepared for the District Licensing Committee's consideration.

Two interviews were conducted with the licensees: on 14 August 2025 with Mr Vishrav Singh individually, then again on 29 August 2025 with both Mr Vishrav Singh and Jaspal Singh together as Mr J Singh travelled down from Christchurch to meet with the agencies.

Multiple concerns were noted during these interviews including:

was purchased and financed.

- Lack of experience of Mr Vishrav Singh. Mr V. Singh has only recently gained a manager's certificate, with seemingly only OFF-Licence experience.
- Mr Vishrav Singh's other employment, being via Woolworths Waimakariri Junction in Christchurch, is a position Mr Singh has not resigned from in the hope of receiving a redundancy pay out; however, Mr Singh now resides in Dunedin and does not work for Woolworths (in a practical sense) anymore.
- Discrepancies were raised when talking to both shareholders about how the business
- I have concerns about the applicant's suitability under section 105 (b) of The Act. These concerns therefore relate back to the Object of the Act, which is therefore potentially compromised with the applicant's suitability in question.

I am aware the Police and Delegated Medical Officer of Health have both raised concerns, and I support their positions under section 105 (k) of the Act.

I believe the committee would benefit from hearing from the applicant directly regarding the concerns the agencies have raised. For these reasons, I oppose the application.

Submission of Opposition to the Renewal of On and Off-Licence – St Kilda Tavern (J V Bars Limited)

APPLICATION UNDER THE SALE AND SUPPLY OF ALCOHOL ACT 2012

ON-Licence application: J V Bars Limited ON-15-2025 and Off-Licence application: J V Bars Limited OFF-4-2025

Background:

On 7 August 2025, Health New Zealand received an application from J V Bars Limited for the renewal of the On-Licence and Off-Licence for the premises trading as St Kilda Tavern.

On 14 August 2025, the reporting agencies met with Vishav Singh, a director of the applicant company, at the premises. During this meeting, Mr. Singh was unable to provide satisfactory responses to several questions relating to the day-to-day management of the premises, host responsibility practices, and compliance with health-related obligations under the Sale and Supply of Alcohol Act 2012 (the Act).

Due to the lack of clarity and detail provided, particularly around harm minimisation strategies, the agencies agreed that further engagement was necessary. It was determined that input from the other shareholder, Jaspal Singh, was required to fully understand the operational structure and responsibilities within the business.

On 28 August 2025, Health submitted an interim opposition to the District Licensing Committee, citing insufficient information in the application and delays in obtaining a full picture of the applicant's capacity to meet the requirements of the Act.

On 29 August 2025, a follow-up meeting was held at the police station with both Vishav Singh (Director and 50% shareholder) and Jaspal Singh (50% shareholder). Information gathered during this meeting, along with agency enquiries, forms the basis of this formal submission of opposition.

Opposition Statement:

Whilst completing the enquiry into the application several issues regarding the applicant gave cause for concern. Accordingly, this application is **opposed**.



The grounds for opposition are pursuant to the following relevant sections of the Sale and Supply of Alcohol Act 2012:

- Section 105(1)(a) The object of the Act
- Section 105(1)(b) The suitability of the applicant
- Section 105(1)(j) Whether the applicant has appropriate systems, staff, and training to comply with the law
- Section 105(1)(k) Any matters dealt with in any report from the Police, an inspector, or the Medical Officer of Health made under section 103.

The rationale for these grounds is outlined in more detail below.

Section 105(1)(a): Object of the Act

The licensing regime and this Act ultimately seeks to minimize alcohol-related harm and ensure that safe and responsible sale and supply of alcohol occurs.

Section 105(1)(b): Suitability of the Applicant

Additionally, police noted several interactions involving which the Medical Officer of Health believes are pertinent to the Committee's assessment of his suitability.

Furthermore, in discussing the meaning of "suitability", heath refers to Holland J in *Re Sheard* [1996] 1 NZLR 751, [1996] NZAR 61 (HC) at 755 stated:

"Suitability is a word commonly used in the English language and is well understood...

Where a statute uses an unambiguous and well understood word or expression and chooses not to enlarge on the ordinary definition... it is usually unwise for a Court to add to the ordinary meaning of the word as a general guide for all cases, as distinct from applying the word to the particular facts before it."

"Differing aspects of suitability will be given different weight by decisionmakers under the Act. Among them are experience in the hospitality industry, management ability, and personal integrity."

In *Two Brothers Wholesale Ltd* (2021) NZARLA 32, the Authority stated:

"[103] ... it is not correct that suitability must only be considered in the context of the operation of licensed premises... an assessment of suitability is much wider and includes considerations of the character and reputation of the applicant and its honesty..."

These precedents reinforce that suitability is not limited to operational competence, but also includes character, reputation, and integrity – all of which are relevant in this matter.

During the same meeting, there was also a discussion with Mr. Vishav Singh, the Director that holds overall responsibility for all operations. He stated that he is currently employed at Woolworths Waimakariri Junction in Christchurch, as he is not willing to relinquish that role due to potential financial gain from a pending redundancy.

The limited experience of both Mr. Vishav Singh and Mr. Jaspal Singh in the sale and supply of alcohol is a cause for serious concern. Mr. Vishav Singh has only recently obtained a Duty Manager's Certificate, while Mr. Jaspal Singh has neither held such certification nor demonstrated recent experience in the alcohol industry. The absence of adequate expertise and consistent oversight undermines any confidence in the applicants' ability to manage the premises responsibly, increasing the risk of harm related to alcohol in the community.

Section 105(1)(j): Systems, Staff, and Training

The premises is situated in a high-deprivation area with multiple off-licence premises nearby. This environment demands proactive management and robust alcohol harm minimisation strategies. It is the Medical Officer of Health's opinion that these were not sufficiently outlined in the application or during interviews with the applicants.

The lack of operational experience, combined with the absence of a clear and consistent management plan, raises concerns about the applicants' ability to implement and maintain appropriate systems, including staff oversight, and training protocols.

Conclusion

Health is concerned that St Kilda Tavern is situated within a highly deprived community which is often disproportionately affected by alcohol-related harm. These harms include higher rates of health issues, crime, and family violence. The area already has a significant number of off-licences that contribute to an oversupply of readily available, easily accessible, and cheap alcohol. This oversaturation of licensed premises undermines the effective regulation of alcohol and makes it challenging to achieve the Act's objective of minimizing alcohol harm.

As such, the medical officer of health delegate opposes the renewal of both the On-Licence and Off-Licence for J V Bars Limited at the stated premises.

Health respectfully requests that the District Licensing Committee decline this application in alignment with the objectives, principles and criteria of the Sale and Supply of Alcohol Act 2012.

On 07/08/2025 Police received an application from J V Bars Limited for the renewal of the On and Off-Licence for the premises trading as the St Kilda Tavern.

On 14/08/2025, the agencies met with the Director of the applicant company, Vishav Singh, at the premises. Subsequent to this meeting it was decided by the agencies that Vishav was unable to answer the queries of the agencies to a satisfactory level, and more time was needed to speak to the other invested party, Jaspal Singh.

On 28/08/2025 Police submitted an interim opposition to the DLC based on information lacking from the application and a delay in meeting with the applicant.

On 29/08/2025 the agencies met with both parties that have interest in the applicant company, Vishav Singh (Director and 50% shareholder) and Jaspal Singh (50% shareholder). Police enquiries and information from this meeting forms the basis for this opposition.

BACKGROUND

This is a suburban premises located in South Dunedin on the corner of Bay View Road and Prince Albert Road. The market for this premises is predominantly the residential community that resides nearby. Being positioned at a major South Dunedin intersection it is also attractive to customers travelling along these routes, particularly with a current off-licence capability.

This premises has not been immune to alcohol harm and was placed on a formal warning by Police for allowing intoxication at the premises in 2015. Despite this incident occurring under the previous licensee, the most recent licence application that was declined by the DLC showed evidence of intoxication, poor management, staff members consuming illegal substances, and patrons serving themselves alcohol. Police will submit that little had changed in the operation of the premises since the previous application wias declined.

Police enquiries have revealed this premises to be located within an area of high deprivation and at high risk of alcohol harm. Further enquiries also revealed the applicant, his staff, and some of his other premises throughout the country who are subject to previous suitability issues. Also, there remains issues around a proposal to include TAB within the premises that should be put before the Dunedin District Licensing Committee for further clarification.

For the lack of a better term, this premises has been 'passed around' a number of unsuitable applicants since 2023, with the former licensee and current landlord, Ian Tolerton, holding the base licence on which the current Temporary Authority is leveraged.

Police oppose the renewal of this licence under Section 131:

- (a) The matters set out in paragraphs (a) to (g), and (k) of section 105(1)
- (b) Whether (in it's opinion) the amenity and good order of the locality would be likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence

Specifically, s.105(1)


- (a) The Object of the Act
- (b) The suitability of the applicant
- (d) The days on which the hours during which the applicant proposes to sell

Object of the Act

- (1) The object of this Act is that-
 - (a) The sale, supply and consumption of alcohol should be undertaken safely and responsibly; and
 - (b) The harm caused by the excessive or inappropriate consumption of alcohol should be minimized.
- (2) for the purposes of subsection (1), the harm caused by the excessive or inappropriate consumption of alcohol includes-
- (a) any crime, damage, death, disease, disorderly behavior, illness or injury, directly or indirectly caused or directly or indirectly contributed to, by the excessive or inappropriate consumption of alcohol; and
- (b) any harm to society generally or the community, directly or indirectly caused or directly or indirectly contributed to, by any crime, damage, death, disease, disorderly behavior, illness or injury of a kind described in paragraph (a)



Suitability of the Applicant



In discussing the meaning of "suitability", Holland J said in Re Sheard [1996] 1 NZLR 751, [1996] NZAR 61 (HC) at 755:

"Suitability is a word commonly used in the English language and is well understood. In an earlier decision the Authority has adopted the definition in The Concise Oxford dictionary as 'well fitted for the purpose, appropriate'. I do not find it helpful to refer to other decisions on different facts as to the meaning of that word. Where a statute uses an unambiguous and well understood word or expression and chooses not to enlarge on the ordinary definition of the word or expression by a special interpretation in the statute it is usually unwise for a Court to add to the ordinary meaning of the word as a general guide for all cases, as distinct from applying the word to the particular facts before it."

The Authority stated, in Re Jays LLA 994/94, 15 July 1994, that: "Differing aspects of suitability will be given different weight by decisionmakers under the Act. Among them are experience in the hospitality industry, management ability, and personal integrity."

In Two Brothers Wholesale Ltd (2021) NZARLA 32:

"[103] it is not correct that suitability must only be considered in the context of the operation of licensed premises as regards the safe and responsible sale and supply and consumption of alcohol. As is clear from Nishchay's an assessment of suitability is much wider and includes considerations of the character and reputation of the applicant and its honesty as well as considerations of the operation of premises. Whether or not the grant of the licence will result in the reduction or an increase in liquor abuse is a relevant issue as are considerations about how a licensee will deal with liquor abuse issues that may arise from the establishment of the business, but suitability is not restricted to these matters."

In discussing the local oversight of the business, the pair agreed that Vishav will be the director and responsible for overall operations of the business. Police enquiries revealed Vishav is still employed by Woolworths Waimakariri Junction (Christchurch) and it is unclear as to why this is.

Furthermore, the experience of operating in the sale and supply of alcohol is extremely lacking, with on Vishav only recently obtaining a Duty Managers certificate to work at Woolworths. Jaspal has never held a Duty Managers certificate and has little to no recent experience working in the sale and supply of alcohol.

Amenity and good order


Police records of alcohol related incidents in the area indicate that the 800m radius surrounding the premises is frequently attended by Police. Frequent incidents of violence, family harm, traffic offending, and disorder are attended by Police within this area. Alcohol consumed at these incidents can be attributed to nearby off and on licence premises, of which St Kilda Tavern is prevalent and commonly frequented by the surrounding vulnerable community. The NZ Police Geospatial mapping application (NAHV) has provided the map below showing the location of the premises within an area of medium to high deprivation (orange to red) and incidents where alcohol is a contributing factor.

In Christchurch Medical Officer of Health v J & G Vaudrey Ltd [2015] NZHC 2749, [2016] 2 NZLR 382, Gendall J commented:

"there will be cases where the matter(s) to which the decision maker is required to have regard are so fundamental or critical that they assume an elevated mantle."

Police will submit there is no requirement for a 'causative link' between the premises and harm occurring in the area as Clark J commented in the Lion Liquor Retail Limited High Court decision NZHC 1123 [2018]

[68] In the face of such evidence the Act does not countenance the continuation of high levels of alcohol-related harm. The Act requires minimisation of the alcohol-related harm. The task of the DLC was to respond to the risk and it did so. It is not necessary to establish, as the Authority required, that the proposed operation "would be likely to lead to" alcohol-related harm. To require demonstration of a link to this degree of specificity is not much different from requiring proof. Requiring proof of "a causative link is not only unrealistic but is contrary to the correct legal position".
