PLACE BASED COMMUNITY GRANTS 2020-2021

Department: Community and Planning

EXECUTIVE SUMMARY

- The Grants Subcommittee is requested to allocate the Place Based Community Grants 2020-21 on behalf of the DCC, as per the delegations set out within the Council's Committee Structure and Delegations Manual.
- The Subcommittee has a total of \$311,000 to distribute to nine Place Based Community Groups seeking nearly \$476,000 in funding. A total of \$300,000 is available through the Community Development and Events annual budget. The remaining \$11,000 is a return of unspent funds from the Caversham Community Group.
- 3 Attachment A details the applications and amounts applied for.

RECOMMENDATIONS

That the Subcommittee:

- a) **Notes** the report.
- b) **Decides** the 2020-21 Place Based Grants to be allocated to applicants.

BACKGROUND

- 4 Place Based Community Grants were approved by the DCC at the 10-Year Plan 2018-2021 deliberations. Grants are in place for three years.
- In the first year that grants were allocated (2018-2019) two groups applied for multiyear funding; the Saddle Hill Foundation Trust and North East Valley Community Development Project (the Valley Project). Both groups were approved the full three years' funding 'in principle' noting that, for grants to be confirmed each year, they had to provide annual reporting satisfactory to the Subcommittee.
- In 2019-20 three groups applied for multi-year funding. However, only one-year funding was allocated by the Grants Subcommittee. Applicants were advised at the time they did not have to re-submit an application in 2020-21 if there were no changes to their request. The Corstorphine Community Hub and Greater Green Island Community Network have opted to resubmit their 2019-20 applications. Other groups have submitted new applications.



DISCUSSION

- 7 There are nine applications, including one from the re-formed Brockville Improvement and Amenities Society. The total cost for all projects is almost \$1.3 million.
- 8 Staff assessments on individual applications have been provided separately to the Subcommittee. The Subcommittee is requested to allocate the funds as per the DCC's Grants Management Policy and Place Based Community Grants criteria.

OPTIONS

9 There are no options as the Subcommittee is delegated to allocate the Place Based Community Grants on behalf of the DCC.

NEXT STEPS

Staff will administer the grants as allocated by the Subcommittee. 10
