### 6 PROPOSED AMENDMENT TO THE CAMPING CONTROL BYLAW 2015 - RESULTS OF CONSULTATION

A report from Parks and Recreation outlined the submissions received during consultation on the proposed amendment to the Camping Control Bylaw 2015. The proposed amendment would add the Thomas Burns Street carpark to the Bylaw under Schedule C and permit unrestricted overnight camping at the site between 1 November and 30 April each season.

The Acting General Manager City Services (Robert West), the Manager Planning and Partnerships (John Brenkley) and the Assistant Planner Parks and Recreation (Stephen Hogg) spoke to the report and responded to members' questions.

The people who had indicated they wished to be heard in support of their submissions presented to the Regulatory Subcommittee.

#### **Beth Garey**

Beth Garey spoke to her submission which included the positive experiences she had from being a DCC/DoC Community Ranger the previous season and the benefits to the city from the Thomas Burns site.
