CONFIRMING PARKING RESTRICTIONS OFF-STREET CARPARKS-APRIL 2021 (TPC 25)

Department: Transport

EXECUTIVE SUMMARY

1 This report seeks a recommendation from the Regulatory Subcommittee for inclusion of DCC off-street carpark spaces in the bylaw layer as a correction of the database. In June 2020, Council resolved to include DCC paid off-street carparking spaces in the database. Three off-street restricted and unpaid carpark locations were not included. This report recommends that they are included.

RECOMMENDATIONS

That the Subcommittee:

Recommends that Council approves the inclusion of three off-street carparks at 16 Church Street, Mosgiel, 10 Cameron Street, Dunedin and 37, 37A, 39, 41, 43 and 43A Rankeilor Street, Dunedin in the parking restrictions shown in the April 2021 update of the Dunedin City Council's traffic and parking restrictions database, <u>https://tinyurl.com/ParkingApril2021</u>

BACKGROUND


- 2 Traffic and parking controls contribute to the objectives of the Dunedin Integrated Transport Strategy 2013, particularly by supporting the achievement of a safe, efficient and accessible transport network.
- 3 Council maintains a GIS map database of traffic and parking restrictions (the database) which reflects all on-street parking restrictions that are implemented with markings and/or signs.
- 4 Parking controls are made under the Traffic and Parking Bylaw. The Regulatory Subcommittee has the delegation to consider changes to parking controls and to make recommendations to Council which can approve traffic restrictions and parking controls.

DISCUSSION

5 All relevant alterations to the database are shown at <u>https://tinyurl.com/ParkingApril2021</u> and detailed as Attachment A (TPC 25-Corrections-Off-street carparks). The GIS layer includes a



bookmark feature which links the numbered cases presented in the table of Attachment A, to their specific location on the GIS layer as seen in the example below.



- 6 Corrections to the database are detailed in TPC-25-Corrections-Off-street carparks. They do not change current parking restrictions but include variations to the bylaw layer which have been made to accurately reflect the parking restrictions that are on the ground. These carparks are a current restriction. However, as they weren't identified in the report to Council in June 2020, this report confirms the current situation. There is no requirement to consult.
- 7 Three off-street restricted and unpaid carparks locations have been identified to be included to the database. These are:



a) 16 Church Street, Mosgiel

b) 10 Cameron Street, Dunedin



c) 37, 37A, 39, 41, 43 and 43A Rankeilor Street, Dunedin





OPTIONS

Option One – Recommended Option

8 That the Subcommittee recommend that Council include the proposed changes to the traffic and parking controls database.

Advantages

• The changes can be incorporated into the bylaw layer and the signposted parking restrictions can be enforced.

Disadvantages

• There are no disadvantages.

Option Two – Status Quo

9 Retain the existing parking restrictions without amendment.

Advantages

• There are no advantages.

Disadvantages

• The signposted parking restrictions will not be able to be enforced.

NEXT STEPS

10 If the Regulatory Subcommittee recommends the changes to traffic and parking controls, a report of the proposed changes will be brought before Council for approval.
